What our group was wondering was, is the Alliance going to give an idea of what numbers to use in these countries for the RSS? That's a good question.

Well, it is and you would wonder that, but you are the humanitarian, the Alliance knows what you're going to be doing. So do I need specific funds for these? What are all the questions that you can come up with? Just know that the alliance is in charge? Yeah. How can your mind override your input from the Alliance? How's that going to happen? If you're coming from your mind, that's what they're normally going to do. If you don't turn off your mind and get your heart up to speed, you're going to have some problems. Now when I say turn off your mind, your mind is your ego. It was here to keep you safe and secure and thinks that they're supposed to be doing everything the heart mind or excuse me, the mind does it and it has overwritten your heart because it's kind of like the male overriding the female, because that needs to be protected. That's what the mind does. And they think that thinks that it's there to protect you. And so they're the ones that are making all your decisions. when the redemption starts, that is the time when your funds for humanitarian aid will be given out. And I'm gonna say two things here. Number one, if you're not the humanitarian to get the funds, then you can be the humanitarian, so do help do the work for those that did get the funds. But by the same token, there's when you do get your funds there, they'll count from the appointment. And not afterwards. That's why we're feverishly trying to get everybody so that they can get their exam, get the studying the literature and so forth, so that they can be prepared. And I've always said, focus on the preparation for your appointment. Because you might not have the proper preparations. And here comes the redemption. And what are you going to do. If you don't know how to do it is going to be difficult. So if you're coming in late, get working on it. Get into the training, and the videos and everything, add the documentation, read the documentation, they're there for a purpose. If you don't start reading the documentation, just listen to the video, you're not going to get everything. You got to read it as well as hear it and then it goes into a lot deeper and you're able to function at a better rate as you get into that. So okay, let's go to the next question.

We're using the same distribution channels that they use, everything's going to be very virtually the same, except we own it rather than the farmers. And we have the price that is necessary for humankind to get what we have. But we're not hurting anything. If you're thinking that. Thank you. You're, you're not reading, right? You're not listening, right. So we're going through the distribution channels that already exist. You know, there's other little things like maybe 10% of the farmers because 7% of the production that they have, can be sold locally, in farmer's markets and things like that. We're not that worried about them produce itself. You know, if you have a bad year, then there's gonna be a little bit short, but the national economic stabilization system, we've got north and south, east and west. So we we've got the ability to transfer and transport and do things that that we need to do. So we're having some problems here in America, then we can go to South Africa or South America to get For our food, and we will be able to distribute that appropriately. Oh, the oh the plan is overreaching all everything. Get a vision of that because that's really kind of exciting. Next question.

I don't know that it's that way in other countries. But it's something that we have to address with each country as we as it needs to do. So the NRELS is not is not really set in stone yet because of the variances in different countries. So other than the other than that, I think, you know, the way that I'm planning on doing is having a director type person to be involved in the real estate. And, and, you know, I don't want to have to spend a lot of time on that. So I'm gonna have somebody take care of it all depends on how the brokers do and the agents. So there's a lot that needs to take place. The NRELS, we need to have condominium conversions, stuff like that. Well, brokers aren't going to do that. They'll sell what you get, but they're not going to do that. So somebody else has to do it. Well hire the people to get it done. That's why I look at it. I hope that answers your question.

And if you are at the end and are a beneficiary, you can have six trusts beneficiary trusts. Oh, I'm not sure what happened with that. Let's go to the next question.

You do what you'd like to do with your money, it's appropriate for you to leave it with 20,000 with credit unions, credit unions are there. They're lovely people. I use credit unions, because it's less expensive than trying to use a bank that's always asking for fees. So it's up to you. And you are the one that owns the money, if you want to work with vendors with credit unions, and you can be wise in the use of your money for for things other than the quantum financial system. The credit unions will probably end up in financial service centers. I asked that about my one of the ladies that my credit union. And she says, Well, we're I'm not sure exactly what you're thinking about. But we're always getting trained. And I'm thinking, Okay, thank

you. I appreciate that. I'm grateful for the training that you're getting. But maybe they'll be there. We certainly want them to be there, because we'll give them a very high paying jobs for being part of the financial service centers. Next question.

Just curious, do you think that some benefactors will start their own financial service centers as one of their humanitarian projects?

No, I don't think that that's a not just a casual sort of thing. Keep in mind that the service centers, financial service centers, industry is being trained. As we speak by the Alliance for banks that have been plans. There was a vice president of Wells Fargo, here where I live that stated that he's been in training for the last six months. Now, we don't have that expertise to train these people. Let's let the people who have the expertise, do those things. There are larger Zim holders, and those who have larger amounts of money that may be asked to be part of the program and be the financers of the financial service answers. I don't know how that's gonna work. I've already told them that I'm available for it if they would like our help. So I think I think that that's something that you need to be trained in. And I don't think that that would probably be the best place to start worrying for projects and things like that, because that's not a project. That's a live experience. So this is my off the cuff response to that. We will find out a lot more when we get into it. Next question.

You'll get the NDA signed, when you have something to sign about an NDA, as when you go to your appointment. I don't know anything about the NDA except for they're gonna it's going to cover your the amount of money you get your rates and a number of other things that I don't know anything about yet. So the NDA will be there for my understanding about pretty much. That's the best time period for you to start learning how to be quiet. And don't don't blab off to everybody if the amount of the money that you got when I say blab off I mean, there are those who can get money and they want everybody to know how important they are because they've got money. All that's all third dimension thinking and I'm not really sure are humanitarians are going to be doing that kind of thinking that they are I'm wondering if they're going to get money. So these are the kinds of things that you have to concern yourself with. If you want to be the humanitarian Then act like one. Just simply start acting like one. What do humanitarians think about? What are they planning? Do they plan all this? And that the other? Do they really need projects? You got yourself of those people who have projects? I'm not talking against them, please. I'm not. I'm just saying that the first things that you're going to do is have projects. What are you going to do after that? How do you feed the homeless when there's no homeless? How do you find houses for them though, whether I'll live in in homes that want to

live in homes? That if they're all that way, then what are you going to do next? You're the one in charge, set up programs and let them function on their own. You just oversee that's the that's the thing that you're going to do. And that gives you the opportunity to think about other things that are going to be more effective in changing and creating changing the earth and creating the golden age of mankind. That's not a project. That's your life's work. So projects are just a thought process to begin with. Where that goes is where you're gonna go.

Okay, ready for the when the funds at the higher rates have been approved at the redemption center. I guess the QFS account has been opened or has been open for the benefactor. Well, the Alliance put the amount into our benefactors LWS motherlode account or will we do the transfer from our QFS account into the LWS benefactors account?

R

Ron Giles 34:22

These funds are going to be put into, at that time you go in for your appointment. You do not have a beneficiary account or a benefactor account. What they're going to do with you is put your money into your mother lode account. Now, keep in mind that the rate times in the Zim gives you a figure I call it the first the first principle that first principle is only an indication of what you want to Have for your annual payment from the structured payout. Okay, so you go in there and you get that and I'd like 10% of that primary principle as the amount of money that I'm going to receive on an annual basis. What happens next, the Alliance agent will multiply the number of years that you want that, by that figure that you said, which is 10%. From our history, we've gone to it's 10% of 50 quintillion, because you asked 50,000 for a 100 T Note, well, 50 quintillions, here's the for a 100 T note, that's your primary. And you want 10% of that every year, they take that for the number of years that you want, you might only want 50. And imagine why but you everybody gets to do what they wanted to do. So you get that amount of money, and that's what you're working with. So the amount of the first payment you'll receive from the structured payout account, which is administered by the Alliance kept keep this in mind, they're putting that that structured payout account, will receive all of the money that you're not going to get for the next 100 years. And they will dish it out to you according to the amount of money that has been established for you to have on a on a structured payout payment system. For most people, you know, we're looking at five to five quintillion dollars from our examples that we'd use, or need to start using the 100 quintillion instead of the 100 trillion. But that's, that's where you're going to be your account from there will be whatever you want to do. Okay, I sign in, I'm now I'm a gym, benefactor or managing director. Then you establish once you have that contract, then you establish everything that you need to do to function at that level. That's assuming that you will create your master account, your RSS master account, which will fund all of the activities that you put through the RSS program. That's when you get involved. But you're not you're not a gym, benefactor until you sign that contract. And there's no reason to be setting up a master account and attaching it to the RSS platform. It's a step by step process. So don't, don't, don't be jumping around. So those are good questions. But hopefully, that there's a sequence of things that are going to happen. And let those sequences take place. When you sign your contract, oh, I'm I need to get established my account and use that attach that to the platform so that they can pay for all this stuff that I'm doing. So that's the way it's gonna work. Next question.

you have to be a beneficiary to be on an employment contract. So yes. I hope you understand why. Well, let's look at the account through your benefits your Yeah, it's part of the accounting within your beneficiary account, you get an employment contract and it activates another section of the of the computer so that you'll have access to the funds will come to you from your employment payment contract and as part of the accounting in the beneficiary account or in your back office, private or personal office, whatever you so that's where it's gonna take but yes, you have to have a be a beneficiary to have an employment contract. And as you get to the point where I'll get offered a play, then they'll make you better beneficiary. So, which comes first I'm not answer that. Beneficiary accounts has to be established before the employment contract can be activated. Next question.

After redemption. benefactors will be establishing a headquarters and or their first CAC after I find a commercial real estate agent broker, how do I pay for the property and subsequent contractors to bring the buildings online?

Ron Giles 40:16

Use your money. Yeah, how do I pay for the property and subsequent contractors? To bring the buildings online? You pay them? I'm not sure. Other than that, what the question is, maybe you want to put them on a contract, then you pay him through the RSS program. That's the way I'm going to do it. I'm not going to be paying money to people on a personal basis, where I have to write them a check or something of this nature, they're just setting them up on a beneficiary account, and then put the contract in that account and the way that goes, they just get paid. You don't have to worry about it. They get paid you don't worry about it. And you don't have worries about two or 3 million people you have working for you. You've got to you've got to do it yourself. Nobody's going to come in you'll get the help you need to make those decisions. But nobody else is going to tell you what to do.

It's going to be that easy. So make your list if you want, but I don't think you'll when you get there. They won't even come to you to even ask those questions. That's my opinion. It is so compelling. The light in that room, there'll be all kinds of things. Love is light. Not going to be dark in that room. Or they'll be shining bright. But no shadows. Today, right, that most of my thoughts with with this we're moving into with what's happening to us. We're moving into something that we have never experienced before. And if you think for one moment that somebody's going to try and trick you to the point where you need to ask questions. You may not be getting your funds that you may not even be getting the appointment. If your faith is that lacking and your feel about what's taking place for you. Is that lacking to where you need to concern yourself with some fraudulent activities? I don't know where that thoughts coming from. And I think it's a dark thought. I think it's a flawed thought. I think you need to learn how to accept what is happening. You say, Well, when I say that, they've said that they're going to be, you don't believe it yet do. You don't believe it? And that's okay. But I'm telling you humanitarians do believe it because it comes from their heart. And not from Ron Giles, his lips. So let's let's mature spiritually. Let's learn to have faith and function from that faith. Doubt not fear, not be believing, and all things shall work out for the best good of those who love God. I don't know how to tell you stronger than that. Oh, but that's the last question. Let's let it go from here. Thank you for the questions. Thank you, Tracee, for your wonderful work that you do, and I so appreciate you and and God sends. So thank you, God. Love everybody who's involved with us. So we'll go ahead and close with that.
