That's why they get away with it, because it was going to be really it is really helpful for us. Okay, the NRELS is for getting people into homes. The structure is not really what you want to use for the things that you want to do. You just go by the house or by the buildings, and start renovating them doing what you'd like to do. And so yes, you can do that. The building purchase, go through that? Or does it go through the under ESS, it all depends on what you want to do with your activities in building the buildings or buying the buildings and how you're going to participate with us with the economic stabilization system. To me, they're, they're quite different. But we'll see because we're going to find things to fine tune things down to where we really understand what we're trying to accomplish. And right now, some of the things haven't been tied down enough to really give it its buy on purpose, I believe, you know, if I get more information, I'll make changes. That's not the point. of currencies from the depressed or devalued currencies, and that's usually as a result of war, something of this nature. But it's, it's the revaluation. And I don't know all of this stuff, they call it the first basket of currencies. And what are they, it's like, those are really important for people who are carrying around a symbol of water. And that's all that they can get. But we've got a whole ocean out there when we talk about the redemption of Zim. And you might be getting two or three buckets full of that kind of water. Or you might be having a pump there and just pumping it all out and all of it, but enough for us to use middle replenish and all that sort of thing. So the visualization I have of the difference between the exchanging of devalued currencies or the revaluation as compared with the redemption. I'm just going to say this, and I don't want it to sound arrogant. The people who are out there that are not part of us, will be asking for five cents per zoom, or something ridiculous like that, in comparison to what we're doing, they're not even asking \$1 for dollar. But these are the kinds of people who are being buying them and you have no idea how many 100 T notes. I have a friend of mine who's donated to love won society. He has 40,000 a box with 40,100 keynotes in it. That's just one box and the boxes are being bought and sold and all kinds of different things. The Alliance is the only one who will give money for redemption. If you are not a humanitarian. You will not be getting money for urine, Dead Redemption. If you do, it's because you have a kind heart. So if they're going in there with 100 keynotes, and a limited number of those because these idiots are telling everybody, there's only certain a number will so give them away because you're only going to get 10. And you're only going to get somewhere between 11 and \$33 million for them. Those are the people who are looking to do humanitarian projects, like wheelchair ramps for people next door, so that they have those kinds of, yes, that will happen. But that's not what we're about. Love won society is a changing the economic system for the whole world. And in some respects for the moving up us back into the Galactic and becoming part of the Galactic commerce and doing things interchanging with him. And when you're confused this because you don't have you haven't done all of the work that you need to be doing? Yes, this is a transition. And I understand that. And that's why we have patients. But this is the kind of question that comes up. And all of a sudden, you want to be a beneficiary with six personal trust. And you're confusing that with a bond account, trust forever benefactor. think these things through reasonable, it's reasonable. The whole thing is not that hard. But yet, it is difficult if you do not do your research and come up to the right understanding. So I say to this person, keep learning, keep researching. But the six personal

trusts are for beneficiaries. Only, period, exclamation point. As a museum benefactor, you can have as many trusts and different accounts as you want. I'm just saying that there's a bond account that you're going to need to provide for love won society, and the revenue sharing solutions platform, so that for some reason you don't keep up to your assign your master account, that we have a bond account that we draw from, so that your people don't get cheated out of their money. That will be part of the benefit benefactor contract that she'll be signing up that makes sense. Next question.

Who's going to judge you and tell you oh, that didn't. That doesn't sound any good. You can leave. They're not going to do that they're working with us where what they have to work with. They can't get it done any other way. So you want things all nice and calm. Don't be putting words in my mouth because that's not true. I mean, if I start saying things about trust, and people start writing me letters, and some of them have become pretty nasty because I don't really understand the six Trust that I'm telling people to set up as far as beneficiaries program, it's just a simple trust. When the idea, maybe we should throw it out, I don't know. The Alliance put it in, I have no intentions of throwing it out. I've argued and argued, and re Are you sure you want us to have six sets out? Sounds like a lot of just getting more money for us? They said, Yeah, six trusts. That's what it is. So if you were to ask that question to the alliance, what would you want to have them tell you? Well, you can have to wait until you get to a chance to talk to at least the airline alliance agent, who's your counselor. And that will be helpful for you. All of the things that you're doing now may or may not survive into the GESARA compliant government. We don't know all that stuff yet. Anybody that thinks they do? Then they don't believe in it. It's not it's in their mind, but not in their heart. So I don't know how to answer that. I really don't. I'd love to have the right answers for all of these things. But I just wanted to simple trust the you can get in, it'll give you another \$6,000 a week. So making you a total of \$28,000 a month or more depending on which how many days in the month or let's just allow a transition that we don't know everything about. Put that down on the backburner. Put it on simmer instead of high on the back. So that's that's the only thing that I can say. There's things that we don't know. And questions, I haven't asked the alliance and I don't get an answer until I asked the right question. Or a question that deals with it that way. And sometimes I don't get an answer, because it's not time for us to know about it. Yeah. Okay, next question, please.

I'm looking for the best common law lawyer I can find is if I can get some extra money here and start getting into the preparations of contracts for the gym benefactors, the different contracts that we need for each of the different programs. Let's see how that costs, all kinds of contracts. Some are boilerplate and some are quite unique. So we'll see how that works out. Let's go with the next question.
