every person in the world is entitled to a beneficiary account. In addition to that, every person couldn't have have an employment contract in something that they enjoy doing. Now, \$28,000 a month is what your director is going to get from his ESS program. How much you're gonna pay him? That's the question. Know how much you're gonna pay a director to stick around? Are you gonna pay him 50 100,000 A month, whatever. You gotta be smart with what you're doing. I've never said that you sign a contract for the for a director for seven years, I've never said that. That's part of the ESS program. And the contracts are associated with that. It is not in place as a fact. It is a negotiable item that you have with every business that you're going to do business with. It's only a target. And I have a real hard time with people who I don't give those kinds of information out. And they just assume that that's what's going to happen. I want you to

start using the right words, the right way of doing things. And don't don't ask me questions with that in there. Every person on this earth is entitled to become a beneficiary, that for the children till they're 18. Your heart has nothing to do with your beneficiary program. Absolutely nothing to do with. Your heart has a place in being a director. Here's the point about directors. I'm gonna start them out of \$100,000 a year or no more than that. Maybe 50 cents per minute download. I don't know what that is. And I'm just using these as an example. And it's going to be a lot more money than they can make as a beneficiary. As a benefactor. Do I have the right to do that? Yeah. Do I have the wisdom to do that? I'm hoping we do. When my directors go to a business and they sign up the owner in the beginning stages of things. That owner will not be a part of the beneficiary program. So there's a referral for, for the director. All of his, the people that the director has or excuse me, the owner has in his business employees, he can get the referral for he can give the referral for each one of those employees to become a bit in be part of the betta fish Sherry program, as well as receive and an employment contract so that they will stay in the business. The money is there, we just have to use it wisely. Okay, next question.

It's not just the ones that dance or sculptor, there's all kinds of different artists by trade musicians we're going to have some really fun things as we get into this because those

with talents are going to bring those talents to the forefront and we'll be able to enjoy going to their concerts and be enjoyed going to their dance recitals or their dance performances and and they go to their galleries and see the paintings and so on and so forth. And we can afford to buy them and pay real good prices. It's not because we're gym benefactors. I'm not saying it that way, because we have the beneficiary program and we have a contract. We've got plenty of money and money is not important anymore. Gotta have money in the beginning, because it's important because if without it, you don't have much of a life. But with a lot of it, and they and plenty to go around. Your money will not be important, so important as it is right now. There'll be changes. I wish you good luck, my heart goes with you.
