That is correct. And we do have to take into consideration the different laws. And we're looking at the transition in this regard. Just Saara compliance, we will all eventually come into the same arena. And as long as the country is just are compliant, and when we can go in and, and do some things contracts is going to be our biggest problem. And of course, the real estate listing service will be could be a problem because the countries have their own way of transferring title. But we'll work through all that. But yes, you are correct. law have to be under GESARA, but much of that is going to be taken place before we even get our money. So we don't have to overly concern ourselves about it. But it's something we're gonna have to take into consideration as we start doing contracts. Next question,

Those are good questions. And here's here's my, my feeling the Alliance knows who you are the people who will be getting the money or those who have been called of God to receive the money from the redemption of Zim so that they will have money to do things for the rest of the humanitarians who are not called to do that. So that means that they can be your, your directors and different levels of management and all that sort of stuff. But it is only those who are called of God to get the funds first period, exclamation point. And so how that's going to happen as far as the alliance is concerned, they, they have not shared that with me. And that's proprietary. You know, I not say this is going to happen this way. But the rest of the world will not know anything about what we are doing and how we are being dealt with, as far as the alliance is concerned. Are they going to get the same information and start redeeming and so on? I do not know, are they the banks going to be open up for the exchanges to take place, at the same time that we are, I don't know. But there's a distinct possibility that will go it will get our appointments, go in and redeem and get. And we're under an NDA. So we won't be talking to people and there won't be a lot of outside indications that things are taking place like this. Because it's gonna take a little bit of time before we really get into it. But those are the kinds of things that we're looking for. And the Alliance's since is in charge, and they will do an excellent job with us, especially with us. Not that we're better than other people. That's not that we have a calling and that's our calling is puts us over here. So we're different than other people, not better, just different. So we have our job and they will have theirs when the appropriate time comes. However, let's not underestimate who we are and the factors that are going to be presented to us and the way that we're going to perform. So be proud and be happy and be thankful that you didn't get this money. Now there's been people and I'll just say that briefly. There's people who want to share their resume with other people. And when we've got this idea now that we're going to give people their resumes and so forth. I suggest highly suggest that you're not be giving people Zim and unless you can feel in your heart that they are humanitarians, because only humanitarians will use those them. And if you just start passing them out so people can have money, which a lot of our people have been doing. They are not aware of what's going on, you give them a zim. That's like giving grandma four wheel drive truck that goes up into the mountains, when all she's going to do is go to the church every Sunday. They have no idea what it can do or what it will do. So you'll give something away to somebody that they have no idea about. They won't use it properly, probably. But by the same token, if you feel in your heart that those people are humanitarians? Well, the thing to do is introduce them to love won society. And that's what we're doing right now. We're not looking for directors, I'm not asking you to go find directors, I'm asking you to find those people in different countries, that can be Zim benefactors, and that they can be the ones that will get the money for their particular country. But they don't have to stay where they are, they can move around just like we can. But we're looking for the other 19 or whatever. 1000s. So we get our Zim benefactors up to 30,000 or so. So we're looking for benefactors, Zim benefactors. If you feel in your heart that those people are Zim benefactors and share after they've been interested in love won society got interested, and they don't have Zim, then that's when you start sharing. That's all I'm saying. Give them a chance to step forward, pick up the ball and run with it. You can be given these zoom away, and they'll just be cashed in the sock drawer somewhere. And they will never have an opportunity to because they're not zoom. They're not humanitarian. So let's be wise with what we do. I'm not saying be selfish with your zim, I'm saying be useful with your zim, and wise with your zim as you share with other people. I hope that makes sense. Next question,

I'm not going to go through that I've, I've spent said that many times the fact that you know that the there's six trust means you've been reading stuff, I've been hearing stuff. But at the same time, I have said that and always have said the six trusts are for anything you want to establish. For child trust until they're 18, or things that are I'm going to trust. And I mean, again, use the money for my children, instead of one of the you know, this was for her and this was for him and so on. You are in charge of the trust. And I don't care what you do with the trust, just be sure that you do it appropriate. And that the trust signals indicate what you want to have done. So if you want the trust to give you as a trustee, they have control of the money, all of the money, then put that in the trust. And, and then you can control the money and do the way you want to do it. The money is yours, the trust is there to as a vehicle to get you that money. That's all that the trust is for. And we've made a big deal about it. And it's gone way beyond what the idea of the trust is for. We're going to have a big trust, and we got to do this and I get get it all the time from people when they got to have a trusted, that's legal and we got to do this. A trust doesn't even have to be registered anywhere unless you want to have a bank account for it. And you're establishing accounts in the quantum financial system. Sure, don't be telling me about you got to have a trust, and the EIN numbers and all that stuff that's in America so that the IRS can track you and all that sort of stuff for to have a bank account, you're going to have your bank account in the quantum financial system. Now there'll be other ways of working with banks at our financial service centers. We'll have all of that opportunity available for us and we'll set things up as they come along. We'll make changes as they come along in the transition. But remember, we don't have the money now and the quantum financial system is not up and running. So all of that is going to have to wait until it takes place. Then we can start moving. Do you want to lay some groundwork? Yes But you can't lay tracks until we have something to lay the tracks on. And that's when we actually get into it. So don't put the cart before the horse. Yeah, it doesn't work. And you'll just be frustrated. So let's let things germinate. Is it correct to say that we will be paying our CAC staff position through the RSS? If yes, then their yearly salary would have to be convert converted to a per minute download? Is that correct? If no, is it up to us to source payroll services like currently use today? And then it goes on? Do you want to address it or don't me keep reading?

Yeah. I'll just address it. What you're doing right now is you're setting up your humanitarian

work. To support your activities that you want to accomplish, you'll find directors, you're going to use, in my opinion, as just my opinion, you can use this the structures of the RSS as you feel you'd like to do it because you're the one in charge of your money. I'm going to have everybody on the RSS program, regardless of what I have for them to do. If they're directors, they'll have a director. And in some locations, those directors are going to be excuse me paid a lot of money. I don't know, you know, we've said 25 senses a minimum. I'm not sure that that's really true. But and \$2 is a maximum. And I'm not sure that's really true. I have some individuals that I'd like to have to pay a million dollars a month to to come and be part of our program. Why? Because they are capable of doing what I want them to do, and what needs to be done. And they are the kinds of people who will pick up the ball and run with it and do the legal system, whatever it is that I have want them to do. So I have no restrictions, no minimums, no restrictions, the beneficiary program will be 10 cents a minute, their trust and so forth are 10 cents a minute. But when you start talking about employment contracts, I am in charge of my people. And I will be using RSS program because I don't have to worry about them being paid. I don't have to create another organization to do all that. So that's my idea. Now, I'm not sure that that's covered in the rest of the questions you've got there. But that's I don't you want to read through them.

I'll just finish. If yes, will there be a built in converter tool to assist in entering the salaries correctly in a download per minute and trade be very helpful and beneficial tool, then? Is it also true that any small business that uses the ECS through the CAC will also pay their employees through the RSS system? If yes, then previously you mentioned that the employers would call RSS directors to enter in the permanent raises. Two things come to mind if a CAC is servicing a large area, remote smaller towns are servicing a medium to large city, that a position may be needed to serve as just the payroll entries into the system due to volume. Would you agree? Secondly, it may cause a delay and or burden on the employers to have to contact the CAC to always implement arrays or new employees etc. Is there a reasoning behind why they wouldn't be given access to maintain their employees own records?

No clearly besides our people are involved in the RSS program, you don't give that information out you don't give authority to for other people to use it. I won't be you do that your you will suffer your own consequences. This is a convener then CAC is a community. It's not a city. It's not a county. It's not a state. It's this Community Assistance Centers. It's on a local basis. And it's that way for a purpose. So if you say to me that it's going to be a problem for the CAC or for the business owner to contact the director and do this and the other for the directors, the person he's going to have to interface with in order for him to do what he's wanting to do with his business. Because my directors will not delegate They'll delegate to assistant directors. And then we have staff in the in the room or in the CAC center, or some of those people are going to have to be the ones that are actually doing all of that, that book work. And they can be given an opportunity or responsibilities. But it has to be under the control of the director or assistant directors. And they're the ones that might be doing most of the entry through the code. So the directors have to the staff has to be in a position where they can support the director. And they all delegate as they feel like they need to do. So I don't see that, that it's a problem. It's a, it's a community, it's local. And if your mind is going for the state and the city, and you're trying to

figure out how to do things on local basis, this go to that section or that area that you have called Glendale, or Kearns or whatever, and you have your directors there, and they set up their own system. So it, if we'd make it bigger than it is, then it's gonna cause some problems for you. But if it's as small as a local basis, you're fine, you'll be able to handle it. When you get to check somebody, and you have responsibilities to use and for different things that you're doing. You take care of yourself, or you take care of other people, you've got to take care of yourself first. That is your stewardship responsibility. You are the Sovereign of Your Life. When I give you something, it doesn't come with all kinds of directions. And you can't do this and you can't do that. You're the sovereign, and I expect you to act like a sovereign. God expects you to act like a sovereign when he gives you a stewardship. He is said any money you need for yourself is yours, to do what you need to do. I do not want to hear oh, if I use that money, it's greedy. Oh, I'm gonna put I'm gonna put my Donga dinar in an account over there. And that's gonna be my money. And who told you that kind of garbage? It didn't come from me. Don't bring your guru garbage into our program. You are not greedy. If you got money from God, it is your responsibility. It is your calling. If you want the house on the hill by the house on the hill, if you want to buy a sports card and buy a sports car, who is in charge of your money? Who's going to tell you you're wrong? Why do you feel that it is wrong to take care of yourself? First? We've got to grow up and know what the Sovereign means and what we are supposed to be doing as a sovereign. It's a small little thing, well, how can I go? Don't ask anybody for anything. If you can do anything with your money, don't ever ask somebody else. If I can do this with my money, did I say God's money? Or did I say my money? It may be coming from God. But he's giving it to you and as a giver. There's no strings attached. God's not going to take away your money because you want the house on the hill. He'd started doing drugs and it's a different story. But you are the sovereign. And I want to take that opportunity to explain that very clear and precise. I don't want to hear anybody else that I'm going to hear it because not everybody is hearing this. But I'll say it again. When that time comes up. You're the sovereign. It's your stewardship responsibility. You do it as you need to do and be sure that you are taking care of you and yours first, please, please understand. There's no conditions of giving you this money. If there was a project and their funding projects, like the Guru's are trying to say, and all the other people, then you got to use the money for the for that particular project. We are not under that same condemnation, We're not children, where we have to be told, Well, if we're funding ourselves, not the projects that we come up with the other organizations, you're going to be funding the projects, and you got to use it for that. And this is why I keep telling you are the most important part of the program, you are the humanitarian, you're the one that's going to get the money because the money won't change you. And that's why you have a calling of God from God to do this. So you're going to get your money, you're going to do what you need to do. You'll have your own things that you want. And who cares. If you buy the car, or the house on the hill, or lock home up in the mountains. Just make habit make sense. Don't let those kinds of things get in the way of you humanitarian work. There's a

balance there, and you'll find that balance. Because that's what humanitarians will be doing. It's what we do. That's why we're called we will be doing things appropriately because we're being following our spiritual guidance system. That will keep us safe and secure within the bounds that God has given us. You'll have a counselor, how many times how many people out there do you think are going to get a counselor for themselves? Who else has said anything about the counselor coming from the non physical, to the physical, there'll be blood, flesh and blood just like us. What other organization is telling you that you're going to have this kind of counselor for you to do your humanitarian work? I tell you, they didn't give you a counselor to do a project. They gave you a counselor because you're the one that's going to ask questions, and you're going to be the best humanitarian you can be because that counselors already helped you to do that. Don't worry about things. Enjoy your experience as a servant of God. And it's not a slavery servant type of thing. Its stewardship. Its sovereignty. There is a difference and you need to learn that difference. Okay, next question.

If it's real, does that make a difference? You bought it from somebody or somebody's shyster. Do you think that the alliance is going to honor that? sheisty? No, no, they weren't. They know who you are. Don't worry about those kinds of things. Because that's not relevant, because we are dealing with the Alliance and they are dealing with us. Don't make giving you you're being yourself percentages, okay? 10% of 1.25 quintillion dollars per quarter, or five quintillion dollars. That's 500 Or five quadrillion for your family to spend every quarter or every year. Now you're not you're not being realistic with what's coming. I suggest that you sit down and you say to yourself if it's 1.25 quintillion, okay, and that's a quintillion how many quadrillion is you know how to change that. Do you know how to do that? When there's a point 1.25 bucks 125 quad variant? I guess I have figured it out yet. But those are the kinds of things you need to become familiar with. So start getting your pen and your paper out. It's all zeros. And what does it take to make a quintillion, it's 18 zeros, we put one in front of it 18 behind it as one quintillion. If we, if we competing with employment contracts, and people wouldn't want to work, so we lowered one and raise the other. And then along comes the Nosara, and the prosperity packages, and all of that. Some idiot says he's going to get they're going to give \$25 million dollars to every man, woman and child in America. Because of the Tsar, and I say you flame any idiot? Are you trying to destroy the world? Are you trying to help people? Why do you give, they give people money in them, the government taxes them to pay for all of this stuff, it's changing the way we get the money, then we're going to be building the roads and the bridges and the towns and the airports and whatever it is.
