Is that dependent upon new phones? I don't know. We'll see. It could be kind of exciting. But at this point, we don't I don't know yet. So we'll go to the next question.

R Ron Giles 01:12

They don't get linked to the board. I'm not sure what this question is.

I know, it's to probably to the benefactor, you know, or the Yeah, it would be the Benefactor when signing up. Many beneficiaries in the three levels of bonus, how does each beneficiary get linked to the motherboard, that just means probably the benefactor. And it's just all going to be automated, right?

R

Ron Giles 01:37

Yeah, keep in mind that beneficiary will be part of the RSS program platform, they will have their own personal office, where all of their information is kept. It's an accounting, setup, county, so that if your accounting thing in person and want to have all the information that it'll be there available to you to just go through. And you can be sure that everybody that signed up underneath your user ID is there and you'll be getting credit for it. And when you get two of them, you'll get another penny for a download, all of that information will be in that back office. Now, other than that, they will have nothing to do with a benefactor, per se, as in, I'm knowledgeable about my benefactor and all that No, they won't know anything, it's just the platform that they will be involved with. And the platform will take all the money that's necessary from the benefactors master account, and find all of the things that are going on, let's not put beneficiaries in a in a big position, because there's going to be millions and perhaps billions of these beneficiaries. You know, we got seven and a half billion on the earth, I guess, helmets submitted, some people say more, some people say less doesn't matter. Every one of them can be on this, it will be that big. It's being current programmed by the Alliance for the foreseeable future. So it will be big we we talked about the quantum financial system being really wonderful. Well, the alliance is programming our RSS program. And it will be huge. And it's in their purview. And they're, they're the ones that know how to do that sort of thing. So we're going to be in good shape, we don't have to worry about it. Let's just focus on the things that we do have control over. And that's our CAC is the real estate and our economic stabilization system and the International commodity Clearinghouse. Not everybody wants to get in those last two, but because there'll be contracts and so forth, you have to sign to get involved. And it has to be controlled. And when I say control, we're going to be controlling it to the point that we change the way the economic system the world happens. So in order for us to do what was appropriate, then we have to be in control. Let's go to the next question.

The answer is yes. If you have Chinese railroad bonds when 43 coupons attached, just take them with you those those to historical bonds, what are you going to ask for them? Well, I'm asking a certain amount for all of the Zim bonds that I have. But it will be the same amount for any of the bonds that I have that historical bonds, you've got the Chinese railroad bonds, the gold bonds, you got the German bonds, you got the Russian bonds, or all kinds of different

bonds out there. Historical bonds. Historical means that Russian Revolution took away the the Tsar and all of those people, they're the ones that issued those bonds. They're no longer around to pay those. So they're just sitting there. And there are bonds, yes, but who's going to pay those who has the responsibility to pay them? Because the people who do have that responsibility or con, the alliance has said that they will redeem these historical bonds for humanitarians? Keep that in mind, you have to be a vented humanitarian in order for you to get funds from those bonds. And then you ask for the rate that you're doing for all of your bonds. That's why I'm doing it. And yes, I do have some of those. They've been donated to us. So I think and yes, they're to be used for humanitarian projects, just like any of the others. So what a great blessing that is relevant. If we have, yes. Okay, let's go to the next question.

Outside of counseling with my counselor, and what's in my heart, what are your thoughts of how we might develop our first group of directors, it would seem most of them would be of those we already know,

Ron Giles 06:52

I'd say that that's probably true, I think it's wise to get people that we know if indeed, they are qualified, and humanitarian hearts and that sort of thing. But birds of a feather flock together so that you're going to have those people around you that you know, Now, keep in mind that we are going to have a directors Academy, that we're going to establish to train the directors, this is major, because directors need to have that kind of training. So they'll know how to deal with the bonds deal with the activities within the the RSS program, because they're going to be going in and changing things according to the contracts. So there's a lot for them to know. And there's a lot for them to gain an understanding of what they can do in the community to really make the computer the community thrive. It also has to do with the local government agencies. And they're going to be involved with those people. So there's, there's a lot of stuff that the directors need to know, we're going to get that up. And we're trying to work out the curriculum right now, to do that. And we have some really good people that are involved in that. There's still a lot of decisions that need to be made on whether it's going to be roaming around or if we're going to have a brick and mortar place for it. And then, and then there's going to be people to come in and give the different classes and so forth that that are necessary. So we're thinking this all true, but we're getting some help. And that'll be really good to understand that there will be a directors program for directors. And we're looking at the probability of having Zim benefactors go to that, so that they will have an idea of what we're teaching their directors, and then they can start managing the directors appropriately. And they have a common knowledge base that they can work with. So those are the kinds of things that we're doing right now. And it'll be kind of exciting to see as we go through it. Next question.

Ron Giles 09:40

Well, it's a really good idea to good question. And each country will have their own similar type of problems. If that's a problem. The solution is, you're gonna have somebody on your team right there, your team, meaning your counselor, and that person is the one that you can talk about. those things too. Now also keep in mind, this is very important. The Global Currency Reset has to take place before the quantum financial system is in place. What does that mean? Each country will have their own major currencies that are equal to and other countries. So let's take Mexico for instance, they have pesos down there is a pesos, or whatever it is, that's right. They're very, you know, they're, they're like, one pesos worth 10 pesos is worth a penny, something like that, it's really ridiculous. And so there's going to have to be a difference of how the countries will do their own currencies. And they may come up with a different way of dividing it all out. But there's some really, really smart people behind this. And there's some really, really smart people like from the other side of the veil that are helping us with this. We don't know a whole lot about you many, you know, we've got over 14,500 people now and it's growing really fast. Thanks to the prayers that have been offered. Oh, thank you. Thank you. And thanks for God to responding in such a wonderful, joyous way for us. You're registering at QFS2020.com that registered you for the training. We know that you want to be a zoom banner hacker you wouldn't have done that. To well extent you know, that is the extent that you will get really involved in the training process. Now have you trained and and we've taught you to focus on the preparation for your appointment and do that first so that you'll be ready when the time comes, it may take a little bit longer for the other stuff to come with some of the different programs. But when you have the money, then you have what you need to do the work that you're going to do. So focus on the preparations first. And then the other stuff can come along. When you register qf s 2020, you're registering for the training, we assume from that, that you are interested in becoming a gym benefactor, all you need to do is complete your training and go through all that. Then when you have your opportunity to go in, and you have your you've already trained, because in your mind, you know what you weren't trying to do. When the appointment comes along, you'll go in there and you'll get your money. And the alliance will vet you there as a humanitarian, give you your money, and send us and give us a give you a letter to send to us. That refers you, as in benefactor with all of qualifications that are necessary for you to function at that level, you'll have the money, that's all it's me, is two things, you are valid humanitarian aid, and you have the money. And so love won society just needs to know that you Well, both of those

things. So they're gonna give us a letter saying that you have the money to do it. That's all it takes. And we'll we'll, we'll get that taken care of. So you don't have to register for anything. You pick up the ball and run with it, and just carry it right on through to the appointment, get your money, and they'll give you the referral letter for us. And we'll sign you up as a zoom benefactor. With a contractor that I think gets I get excited when I think about these things. Next question.

The reason I'm saying that is because the, the redemption of or the exchange of currencies is is chump change, you pick out, you bend over to pick up a penny, well, that's what it is compared to the 1000s and hundreds of 1000s. Or whenever millions or trillions of dollars. It's just there's no comparison. So in my mind is just a nice convenience that the alliance will take, we'll go ahead and redeem those for exchange those for you. I don't know what it's going to be. And you just discussed that with whomever you want your counselors report to be at your appointment. And let that just be your operation. Don't put a whole lot of stuff in it. And some people said, well, you don't have enough dog. Well, why would you be going out and buying Donald when you could buy? Okay, if I wanted a million Dong, there's probably used to be about \$100 to 1.8 million or whatever it is. So you get some money, that's a real good investment. But that's \$100 that you paid for bonds when you can pay \$100. And you can get so many other large Zim bonds. That makes it so it's it's not even in the same vicinity as far as how much money's you're gonna get. That's what that's my feelings about redemption or excuse me, the revaluation of currencies? Is there a lot of people that are involved with it, and there are a lot of people who have been manipulating them for the last 11-12 or excuse me, 20 years. 22 years. The banks are supposed to be you know, a contract is with a bank. Alliance doesn't contract. So people have said, well, a contract rate. Well, what is who who made the contract? And why did they have authority to contract for you? And why did you assume that the contract that they made was for you as well. There's there's no sense of what's been going on as far as the revaluation of currency. And I don't believe that they will continue, they're going to continue to not make those exchanges until after the quantum financial system is up and running. Well, you are a beneficiary, and therefore, you can become a trustee? Because you're going to set up your own contracts, or trust,

So for instance, if they are putting away funds for a vacation as one of their trusts, then they are the ones receiving the benefit. So they are the beneficiary. So Who then is the trustee,

Those copies will be on your personal office, and you can go back there and just fill in the blanks. And then there will be a simple thing. So the more meticulous you get, and the more you have attorneys get involved, then the more difficult it will be for you to understand that because they do things so that you won't understand it. And this is going to be simple. I like to create a trust and I want to be the trustee. I want my family or whatever to be the beneficiary who's the grantor who's the one that sets up the trust. That's you. What are you going to set it up for what beneficiary? Well, it's my family, whatever. US combined, yes. And then you get to be the trust to be the one in charge of the funds.

No, it's still you don't get another trust or you don't get another beneficiary account. And that's what you're asking. We're only gonna happen for 100 years. We might have all of these different employment contract accounts, and doesn't matter to us. It'll be there forever. So over 100 years That's a long time you don't create another trust or that another beneficiary account wouldn't do, they're gonna have one, that's all. Otherwise, you'll have some problems with the quantum financial system and the whole, the whole security system. And please, please people

don't try to game this whole program, for your own benefit. If you do, you're going to lose. If you get kicked out, because you're trying to be dishonest and trying to figure things for your own self to get more, there's a good chance that you will be discontinued in the beneficiary program. Do you want to do that, because all your contracts and everything are associated with that? How are you going to get paid? This is serious stuff. Don't ever try and game the program because God knows what you're doing. If God knows what you're doing, the lions knows what you're doing.
