No, it's a benefactor you there's no reason for you to have to be going through the NRELS unless there's a home you want. But no, you set it up the way you want. If you buy it, you don't have to put it on 15 year payout or anything like that. Just just pay it off. Don't confuse the structure with a requirement to use them for your own specific things. These are for other people, not for you. I mean, they're for you to use, but they're not the benefits of it. Are for humanitarian projects to do human and parent terian projects. So next question,

You will have a counselor somebody that you can talk to from the alliance. And we'll call them the Elijah's lions agent or angel whatever you want to call them. They will be available for you to have counseling advice and you can talk to him and get all kinds of questions answered. So that's your that's the beginning of it all. So it won't happen with love won society, it's probably a good idea. There'll be opportunities to join together, especially if he app you're out there working program. So you may run into somebody else also doing it. So there's your opportunities other than that, I don't know how to work that. I'm not inclined to do it as far as love won society is concerned. When, when the RV takes place, love won society will be just as busy as any other benefactor. So you see in our own programs. So there may not be a whole lot of extra stuff that we're going to be doing. But we'll not just drop the ball. If there's something we can do, we'll do it. Next question.

I heard on a recent video that a person needs to have an open qf S account before they can activate an RSS account. I guess I have been under the impression that when we help them open an RSS beneficiary account, it will automatically open their QFS account as well, possibly QFS will have a website where an individual can open their account, or am I misunderstanding something?

R Ron Giles 06:09

I don't think you're mishandling standard things, the QFS. It's out there, is there a reason for the Alliance not to put a link on our back offices or offices for a beneficiary account. I don't think that there's a problem with that at all. I'm asking for it for the Alliance to have that available to us so that we can help people get their account in the QFS. We'll see how it all works out. It's going to be perfect just the way that it does work out. So but I like your idea. I'd like it, I'd like to be able to have it automatically open up an account. But then that requires more information. And I'm not sure that love won society wants to be the keeper of information that's of a personal nature. We'll wait and see what happens. There's a lot of time between now

and then, you know, not a lot of time, but there's a lot of time for the Alliance to be educating us on exactly what they would like us to do. So I'll defer that and defer to your counselor for other questions about the next question.

When you say bullet points presentation, are you referring to a PowerPoint or written bullet point, sorry, I'm old school and just joined your group in February trying to learn as fast as possible.

**R** Ron Giles 07:40

You're doing just fine. The bullet points concept is written out so that you have instead of in depth reading to of your projects and so forth, you just put down some words that will prompt your memory and then make a brief orientation for that. It's just like notes on giving a talk in med school or any other location. Oh, that's what the bullet points stand for. Next question.

I just heard that benefactor notification started, I haven't been contacted. So I'm wondering if I made the cut. If not accepted, will I be notified?

**R** Ron Giles 08:22

Okay, when you listen to people that are not from the Alliance, if you listen to me, I'll give you the straight shot. I would never say that the notification has started. If it has, then I'm under an NDA. So if you listen to the Guru's I'm sorry, I really am. But this is the kind of stuff that I have to put up with all the time. People listen to this, that and the other and, and expect me to have some kind of an opinion about it. I don't have an opinion about it, because it's not from the Alliance. Period. Alliance doesn't say things like this. So you're, you're listening to the wrong radio station, whatever you want, if it's not from the Alliance, if you're getting your stuff and you know that it's not from the Alliance, and don't be calling me about it, because I'll tell you that it's just false. I don't care who it is. They're not giving out information, good information. And it doesn't matter to me if it comes from trolley Ward, some parks, any of the Guru's. They do not come from the alliance. And if they don't come from the Alliance, then their information is skewed. It's it's not accurate. It's their own interpretation. And they have been notorious all these years for giving out bad information. You want good information, you come to love won society. I get my information from the alliance and if it doesn't really encourage you, then maybe you need to go listen to the others. It's up to you that sometimes I get a little bit perturbed when you listen to other people, and then come and ask me if it's true. Yeah, let's just leave it at that. It's a very bad irritation for me for people to go and listen to other people in income and asked me to try and straighten them out. If it's not from the Alliance, don't listen to it, period. Yes, well, you talk about the, you're talking about something that is so far removed from anybody's understanding that you're going to be if you're not a conspiracy theorist, you're a wacko just understand that when the money counts, and you have authority to talk about it. Until that time, it's only speculation. And the more you speculate on things, the more you go out and present yourself and ideas to people who are not plue, then you're going to have some frustration, and it's not going to be of any value, in my opinion, to go before the gun starts. You're at the starting blocks. When gun goes off, then you go, the gun going off means that they've let you have your money in and now your real Zim benefactor in a way you can go, you're not you're not going to gain anything by giving people information that they can't understand. This is part of your training. So when you say we can you please let me know how to access my RSS platform credentials. Once it's up and running, you're going to have a contract, you're going to be signing that contract. And I'm not responsible for your education. I'm responsible to take care of love won society, and you as a benefactor who's applying for the job. And if you get the job with a referral from the, from the Alliance, then we're in good shape. But it's not my

job. And I'm not going to put that on my list of things to do. There's over 11,000 people now and I'm not going to be contacting people on an individual basis, unless there is some reason to do so. And just because it's starting is not the reason you'll be found. You have your opportunities to know all about that. So just allow things to take their normal course and you're not going to be left out if you're humanitarian. They're not going to leave you out. You could be in Timbuktu riding a camel around, they're going to find you. That's all there is to it. Next question.

The ESS is mentioned of each country of the world in support of the program. Is there a current list of participating countries or nations?

No. I mean, the list is 209 different countries. We don't we don't share this information until the money comes. So we're not any further along as far as that's concerned and anybody out. I don't know which countries we would have that are participating. There's just there's no way to know that. Next question.

Following the first question of the March 9 q&a, I would like to ask the question differently as the question did not put the beneficiaries honestly on the line but rather questioning the sovereignty of the benefactors say that Ron and I are benefactors John signed, in Ron's downline as an RSS beneficiary. John lives in my region and as a farmer, I set him up under the CAC program. Ron's responsibility is to pay John his RSS benefits and my responsibilities to pay John, according to my CAC program benefits, why should Ron pay for my CAC program with his funds? Why can't we both deposit it in John's account according to our liabilities?

R

Ron Giles 16:53

That's an excellent question. And it's one that's been floating around for quite a while. And I perhaps gave it didn't really set this to rest, because it wasn't set to rest in my mind. But when I inquired about how the program is being programmed in the in the new quantum Internet, and that's where where we'll be there's there's a different thing. The idea is that it goes by the benefactors ID number. So how do you get into how would you get into Ron Giles's beneficiary account? Well, Jim benefactor has the ability to go into that account, and, and make a an employment contract. And so with the directors and so forth, but it's under the direction of the new have a different job Zim benefactor, that the employment contract would come out, and it's coming out of those funds would come out of the, of the master account associated with the Benefactor with those particular things. So it goes by the, the Zim benefactors ID number, and anything under that ID number is paid by their master account. And it's all on the same platform. So and I failed to realize they're all on the same platform. So it's not a hard thing for the, for that to be taken care of appropriately. I was reminded of that. So that's the official word in this particular point. I hope I explained it as in benefactor, any of the things that they do will be paid from their master account, regardless of who originally signed up the benefactor or beneficiary. In other words, who signed that person up or under what chain of beneficiaries a signed up and it doesn't matter. If they're going to get a contract, it will come through a new benefactor. And those funds will be paid out of the benefactors master ID or master account. Next question. Okay.

a thought. I'll have rock'n'roll in one segment audio books and another segment and anything else after that. The thing is, I could buy a network of stations, hopefully at 1955 prices, I'm sure either way would be okay, if enough money is there, a syndication of stations would be marvelous being in Australia and might be a long time before my angel appears.

Ron Giles 20:28

Your angel will appear as soon as it appears to everybody else at your appointment. So don't be putting yourself the last place in line just because you're in Perth, Australia. It's not even going to be accurate. That's not an accurate statement, even in Timbuktu with the camel jockey, it's going to happen for them just like it's going to happen for anybody anywhere else. It's the Alliance's responsibility to get hold of you. Now, I've heard that we're going to go back in this 1955 prices? I have no word for that. Why would we want to go back to 1955 prices? When we're giving people \$28,000 per month? Potentially, if they do the six dress, we're giving people 26 \$28,000 per month? Why would we need to go back to 1955 prices. We're going to take things from where they are and make them better. Going back and going through the hassle of changing prices back to 1955. Prices is is a human tremendous, huge, hugely tremendous, whatever it is. Project, why would they ever want to do that? What is the accomplishment? In the end? Is there any real benefit to society? And I'm saying no, not with the amount of money that we're working with. So you're gonna have plenty of money to pay for things at today's prices, the economy will work itself out. And we'll have some adjustments to make. But we're going into a brand new way of living in a brand new way of commerce one with another, the quantum financial system. And with all of the money that's being poured in imagine 10 11,000 people, each of them getting 1.25 quintillion per quarter. Imagine that many people putting that much money into a system, why would you want to go back to 1955 prices? To me, that's just ludicrous. Whoever saying that. I'd like to talk to him. I'd like to find out where they're getting their, their distorted information, and why are they passing it on, as if this is the way it's going to be? Now I could be wrong. And I'll admit I'm wrong if the Alliance tells me. But so far, they haven't said anything about that. I have not inquired about it, because I don't see any reason for it. I don't see any reason for this to take place. We would not set it up to go back to 55 prices. We've set it up to move forward from where we are with people getting all the money that they need to have a life and that's where the ESS is for economic stabilization. Everybody gets to participate in the economy. And everybody is financially viable. That that's the way a good economy a good solid economy founded with built on the foundations of love and serving one another will work. I'm very clear in my mind on those kinds of things. And so, for me to see something different is going to have to be shown to me. pretty arrogant statement, isn't it? But that's where I'm going with this as well. I've gone Next question.

Comes concerning seven year work contracts, I think it would be practical to have a grace period at the beginning of the contract. I wouldn't call it a probation. There are many variables involved. I'll give some examples. But there are many more. An employee has been working there 10 years and jumps on the new contract. But after a few weeks realizes he'd rather go back to school and upgrade his knowledge and pursue something else. As also the entrepreneur may change or upgrade his production line and may abolish position after people get new money, some may need some time to make life changing decisions. I find this as a more relaxed contract than being locked in right at the beginning, less pressure for making a decision. What are your thoughts?

R

Ron Giles 26:55

Well, I have I think that that has some wisdom to it. I've concerned myself with that. That's why the seven years it's not a long time. And but there's got to be some stability when we go into a company that is manufacturing cars, or tractors or trucks or whatever. And we're trying to establish some form of consistency with the with the people who are doing the work and building those things. And we're trying to enhance it so that people will want to do that. But if there's nothing that they if there's something about the work that they don't like, then they shouldn't go into the contract. In the first place, if there's something that they would rather do, then it's probably a good idea for them to take a look at things. But it has to be on an individual basis. Now, if it's a contract, then it's a contract, when you sign a contract, that's as good as your word. And you shouldn't have to some people goes into a contract. And as soon as they've signed it, then they're looking for ways to get out of it. Now if you're that kind of person, I wouldn't want to be dealing with you. If you come to an agreement, and then you write it down and you sign a contract, that's an assign, that's a signed contract. That's an agreement we have that's that is an agreement between two people. And it needs to be honored by both parties. And so there are stipulations and conditions in there already. But just a simple sentence, I thought, well, I don't want to do this anyway, you got seven years on the contract brother, or sister on your contract, you'll get the you'll get you can do things in your spare times. And this is available for you to do obviously, in your spare time or whatever. But when you sign that contract, I want it to be honored. And there's teeth, there will be teeth in the contract so that you'll keep it and then allow it to mature. And then when it matures, that

money is coming in for you for the rest of your life. Where's the problem with that? Though, you have to wait things out. But if you signed a contract then if you want to wiggle out of your contract, I don't know. I'm not I'm not going to say advise somebody to get out of the contract. Unless there's some interest in getting out of it or changing it on the other side of the the other party's party or parties that are involved in the contract. I feel I feel compelled to say it that way. Although I would want to say you know if this isn't for you then then don't do it. But I would like to say that to the In the beginning, not as they've signed the contract and give them a six month period is saying, Well, I mean, how do you tie down for six months? You can't hide that down. So that's not a real employee of yours. And then why? Why do you give them six months to mature in the contract? You know, there's two sides to that. Maybe they don't want you, I don't know. But if they sign the contract, then you're you have, they have to have you work for them. So it's a two way street. You have to weigh these kinds of things out. And the whim or the change, or the inconsistency of a person's thinking about their work, I don't think is, is a real good reason to be getting out of the contract. Next question.

Actually, I have two questions or whatever on this. So is this something that LWS has a hard line on? Or is this up to the individual benefactor in case the the parties involved, meaning the employer and the employee want to renegotiate something?

R

Ron Giles 31:11

Well, we're talking about two different things. We're inferring one thing and talking about it in a different way. If we're talking about the business owner, employment contract account. The LCA is what we're calling that business owner contract account. That can be set up any way you want. There's no seven years on that at all, if you want to do 15. I say to people, you know, if you want it for a longer period of time, and Let's enhance your benefits. But the that contract is available for the beneficiary, or excuse me, for the benefactor to change when you get into the larger ones that have to do with the larger corporations that that will be managed by love won industries. And there'll be a different type of contract for those people. Although they're similar, but it's, you've got a problem with, we're signing, they're signing a contract with us. And then you're working for somebody else. With a business owner contract account, you're working for the business owner. And if he wants to fire you, then he fires you. We just want to keep that business owner in business and serving the community. Though, when you get into some of these larger ones that are going to be administered, administered larger corporations that are going to be administered at a higher level, in loved ones loved one industries, then that's by contract that you will be involved with that. So the sim benefactors don't have as much personal leeway as they would, I mean, it's probably going to be more like you're your choice is either participate or not. In some of those larger contracts, it's not an easy thing. It's not easy to get involved with. And it has to be very highly thought through with attorneys and, and everybody and working out all of the details. And so not many Zim benefactors that I know of. I mean, I don't want to be the one in charge of doing those kinds of things. Because I don't have the experience. I've known the CEO or any of that sort of high Business Technology type of person. So those are really sharp people. And you got to have your wits about you know what you're doing and having an attorney or attorney firm or whatever that gets involved, that can be sure that you're that that everything is going to work for the best good of all parties, rather than one sided, where the Cabal likes to do things, everything is for them. So we want to be

sure that the people are that we're doing business with, they're happy. And so the contract is going to be a little different that way. And I don't say a lot about this. But it is changing in terms of how that contract is made, who makes it and under what circumstances. If it's in love won society, and we're buying all of their product and putting it into a distribution system at prices that we're going to control. That's a different contract. And it has a lot of different ramifications. And it has to be very carefully controlled so that it accomplishes what we're trying to do. If everybody's out there doing their own thing, it won't work. It's not organized. You got everybody going in a different way. and that will not work and you know, love won society love won industries won't be working that way. It'll be very carefully control. So, again, you're going to have a counselor that you can talk to about getting involved in some of the the ESS program, the internet, aquatic clinic clearing houses and even and their real estate listing service, it's going to be a different sort of way of doing things. Well, you're assuming that that's true and how to is that we don't know. I'm not sure what you mean, independent of love won society if you're using our love won society programs, there's a certain structure there. And if you're going to be Zim benefactor, we assume that you will be using that structure. That's what the contract is for. So you're, you're creating a whole different idea than I want people to have the freedom to do what they want to do as far as being a benefactor, and doing any projects that they want to do. But you've got to conform to the things that we set up as a benefactor, you're not going to be working independently of from LWS. And we're going to assume that that's held us as a, as an independent benefactor. Now you're, you're dependent on love won society to stay in operation. And that's part of the reason that you're there with us. And that's why we, in a contract, you will do certain things, we will do certain things. So, if you're going to act as an independent from love won society, well, don't become a gym benefactor. We don't want to inhibit you. No way. If our programs can help you, and you can, and they can enhance your ability to be a humanitarian, then do so. But we're not the only game in town. I think we're real good game. The only one that I know of that the alliance is supporting, but others could come and they could support them. It does make a difference to me. It doesn't make any difference to us. We're doing where we're gonna do. Next question,

Well, I'm I'm not sure what you put a must in there. I don't know that I said that. But in a more recent video, you say you're saying that we must actively share about the six trust? I'm not sure that that's what I said. And that I'm not, it's certainly not what I meant. I'm saying that the beneficiary has the ability to have six trusts. At some point in time, they'll learn how to do that. But I'm saying that it is not something that you use to get people into the program. It's there and enhances the program. But you don't go talking about the six trust before you even sign somebody out. Let them uncover the things that they would like to do or can do. As as they explore through, let's say, six trust. That's interesting. I wonder how to do that. Well, there's going to be videos, and there's going to be trust documents that you can find on the website, so that you can go ahead and do that. Now we want them to know about them, but it's not a sales point. Now the sales pitch, it's not come here there. We've got seven we got \$1,000 A week for \$10. And and then you pay another \$10 and get another trust and so on so forth. So all of that can be really exciting. But I would not like to see people using that in the beginning. But something that adds to the value of their beneficiary account at a point in time when they can understand a little bit better. So we must actively share about the six trust. I'm not sure that I said it that way. But maybe I said it wrong. And that's the way you took it. But I'm just simply saying it's something that they can learn on their own. And if they have a question, they can come back and ask you about, if you're the one that sign them up. So it's not as if it's now or never for them, they can learn. And you're the beneficiary. They're going to do what they do. There's no control over them. And there's no control over benefactors for that matter. But it would be nice if at least the benefactors were on the same sheet of music. But beneficiaries, you're going to get referred people the way that they want to do it. And I have no control over that. And I don't think we shouldn't have any control. Let's just be a good example and not do things that would mess it up. It's always fun to find out where to look I do these trusts for anything that I want. And then let them have the excitement of setting it up. Next question.

If everyone over the age of 18 receives six trusts as a default, why not just set the RSS download to be 70 cents to eliminate the need for all the extra paperwork needed for trust? I imagine in many rural and tribal areas around the world, finding legal help and people to read sign and set up six trust is going to be a challenge.

Ron Giles 41:52

I think that there's some reasoning with the way that you're saying that, but that's not the way it's set up. It's like saying, God, why don't we just let the waters go up hill there so that we can get them to the top of the hill, I don't, you're changing things that are set. And it's not going to change from my perspective. So I'm certainly not going to say in the beginning, you're going to get 70 cents per minute for download. That's leave it to them to figure it all out and say "Aha", instead of you having to dictate all of these things to them. So, but the idea of doing it ahead of time, it's not it's not going to happen with love won society. It's not going to happen with beneficiary accounts, which are mostly controlled by us. Other than doing employment

contracts, then the embedded factors will be involved with that, but definitely senses the way we've got set up now. But what are we what do we What's the price when we go into Africa, or other parts of depressed areas where money is so hard to come by? Things are changing, we're trying to keep this on a worldwide basis to do things appropriately in that level that they're at. So. When you're looking at this, it doesn't come across that way. That's okay. But we have to look at it that way. Next question.

Do beneficiaries have to go to a financial service center first to create a queue effects account before they sign up to the RSS program? Otherwise, where will the 10 cent per minute download go? Banks will be gone and financial service centers up and running. By the time the RSS program comes online.

Ron Giles 43:54

There'll be a transition Yes. And baby. Like I said earlier in the in our q&a that there may be opportunities from the Alliance to put a place in our RSS platform that people can use to get into to establish their own account with within the quantum financial system, it's not going to be a big deal. It may be that you'll have the financial service industry, those people will have access to the computer to the quantum financial system so that you can get an account up and running from there as well. It's not gonna take a long time for everybody to get in there, because it's a very desirable thing. And by the way, the RSS platform does not have any money in it. All of the money is kept in master accounts and drawn down to the banks or the finit to the quantum financial system account, by request as the only time when there's any money involved and it's not in Quantum, he's not in the revenue sharing solutions platform. Sure you understand that? Next question.

With regards to the ESS will love won industries be paying the salaries of those that takes under their contract? Or does that come from our bond account, I assume a joint contract between us love won industries and the company would be needed to be drafted in each case of the ESS.

R

Ron Giles 45:27

That's correct. If each contract will be, it's not going to be a rubber stamp, many of the things will be the same in there. But there's, you're going from building cars, to building tractors to building road graders to building bulldozers, or airplanes or whatever I don't, there's so many differences in those kinds of industries, we'll just have to be sure that we do it specific for the that particular industry. Keep in mind that the bond accounts, they don't the bond accounts don't pay for anything. Bond accounts are there for a surety, of our participation in a contract. Even the bond account, we're calling it that. But if I'm going into a large corporation, and I use the name for it, but it could be any, what is their cost on an annual basis for, for making cars. And so we look at that, we're going to be buying all their cars, less the cost of labor. And that

includes the company's business, or profits, and so on. So there's that price that we pay for them. When they sign a contract with us, they have changed the way they're going to do everything. And when that happens, there's no going back. So we have to be assured that they are going to continue in business for a very long period of time. And let's say it's \$200 billion, I don't know have I haven't a clue. Let's say there's \$200 billion that Ford Motor Company puts through their company every year. Well, it may be that we need to have a bond for 10 times 200 billion. So that a trillion dollars. Obviously, we're looking at some figures a lot bigger than I'm then there's real but I don't know that that's true or not. But we have to have 10,000,000,010 years worth of those kinds of funds available for them 10 years worth, so that they can be assured that we're going to be in business, they're going to be in business for 10 years. And every year it is renewed so that there's another 10 years, the same money that stays in the account, it's just a way that we use it by committee net for the next 10 years. Now that could be put into an escrow account, set up by a company escrow company wherever those funds may be made available for for the corporation to make more cars, if there's a need for it, or to make different cars, they may be making anti gravity machines instead of cars. There's all kinds of things that can take place. So it's a different way of doing business. It's a different way of selling cars and selling things is going to be changing. So we'll we'll think this thing through and come up with the best way possible. The Alliance is going to help us with this we're not on our own next question.

They don't eat meat and all this source. And I say that, you know, my opinion is garbage. And why do I say that? Because you you function that The level that you're at, if you're not, if you're vegetarian, then that's one thing that perhaps you won't have to do in the future.
