You don't you don't join as a benefactor, you join as a beneficiary when the program is going, so the 10 pounds is non existent right now. So you need to get in and and start educating yourself because you'll really find out all of these questions are taken care of. Next question.

When a beneficiary uses the NRELS to buy a home, they use a trust from the RSS to buy the home. Now for the trust in the RSS you get a 10 cent download. If the purchase of the home requires more than a 10 cent download, will they be able to get more than the 10 cent download to buy the house.

Don't confuse trust, RSS trust that you established with the the beneficiary account. Don't confuse that with anything else. With RSS, when you buy a house, there will be a an addition to your download. But it will not be part of the RSS program, that a beneficiary program that you're you're creating trust for. You want to trust for a house create the Trust for the house. But it's not part of the beneficiary program, six trusts. So do what you'd like to do there. But don't confuse the the trust. We're talking about trust, but you need to understand which you're talking about. So if you want to trust for the name of the house and put it in there for security purposes, or whatever, then you establish that trust independent of the RSS program, submit that as the name that you want to use. And then we'll set up the RSS platform so that you can get the downloads of the pay for the house. That's all part of the closing. So a little confusing, but don't confuse the trust. You operate in the QFS, the old banking system, if you need to use it, you put a little bit of money for your, you know, if you're, if you're paying bills, from your credit from your debit card, on the internet, and you might have eight or 10 of those who knows. And you still want to use that instead of re establishing all of them in the quantum financial system, you use, but some money to cover your, your expenses, I wouldn't hold money there, and I wouldn't put any more than I need to. So because the banking system is going to be repurposed for the financial service centers, that will be a transition. And we just have to adjust so that we can take care of our business, our financial circumstances, so you can put money in a bank, and it will be safe and secure, because they're becoming safe and secure, that they're going out of business. So it's a transition from the old going out of business to the news, staying in business with a financial assist, financial services centers. Transition. Next question.

You really have nothing to do with a ID number. You have nothing to do as a benefactor. The ID number is what they choose when they register. And there are there are no limitations to the number of people that can register. It's not by you giving them ID numbers. It's not your business. That's the computer and and their their ID numbers are personal number, then they have a pin number to get into the account. That ID numbers traced all over, especially if they get a house or get a an employment contract, or whatever. It's all it's all there that counting will be in the back office, their back office or personal office. So no, you're not going to be

involved in ID numbers. I don't know where that came from. I have not said that. That's an assumption that people make an impasse on is if it's true, but there's no ID numbers that you have any as a benefactor, that you have any control over. It's not your it's not your job. Next question.

I have a problem with the value of Zim, is it possible that wrong can give us the value of the various Zim type values? I am stuck with my presentation page?

R Ron Giles 08:21

Okay, what is the value of azem and has a face value 100 trillion or one cent Talian or whatever it is on the face value of the Zim that Zim bond has absolutely no value commercially, unless somebody is trying to sell it. Because they're the bond is used, it has been used as currency in Zimbabwe, it is defunct. They don't use it there. There's hundreds of 1000s of 100 T notes that were printed. None of them have any value to anybody, anywhere, except for those of us who use them to redeem with the Alliance. And we get our funds to do our humanitarian work. So when you're talking about the value of Zim, you're going to go in there with what say you have can 100 T notes and they say okay, good. What are you going to ask for the rate? What's the rate? Let's how much you get presume that's put into your account and use for your humanitarian activities. I'm trying to think through this because it's a simple question and has a simple answer. And I'm not sure that God at all because it's that simple. There's no value to us default currency. The Alliance is using that because of the large face values on the bonds. And we get to pick our rate to determine how much money we will receive. And then we figure out the term that we want to use. And then that money will come to us for 1015 or 100 years, whatever you want. And so that's part of the structured payout system. And I suggest to go to the structure, payout document, take a look at it, study it, understand it. If you can tell me what the 10% is, then you probably got it right. Next question.

Okay, regarding the \$10, will that still be multiplied with the current rates like we presently have in South Africa? Or will we be on one to one basis?

R Ron Giles 10:54

Very clear to me until you said, will it be on a one to one basis, your money will be coming to you in South African rand, if that's your, the currency of your country, that's where we'll be coming. So they will counsel with you and tell you what's going on with the differences. But prior to us getting into our redemption appointment, there is going to be Global Currency Reset. Don't confuse that with a cabal Currency Reset, is the global reserve currency reset for all currencies in the in the world to be on the same value one with another, a pound is going to be the same as \$1, South African rain is random is going to be the same as a USD or USN, I mean, because the quantum financial system will not go through the calculations of differences in value between one currency and other. So the Global Currency Reset is resetting all

currencies to the same value. So when you get into the digital gold certificates, which the quantum financial system uses to transfer money, it doesn't matter whether it's Rand dollars, pounds, euros, whatever. It's all the same. So there's no differences. As far as value is concerned. There's just the name of what you want to use your currencies. And that will be honored in the quantum financial system. Next question.

Oh, I don't, I don't see it as a company. What is a company it's just an organization. A Call it what you want. CAC has an organization. You know, I'm saying, if you're working in community, and you're creating a community assistance centers, then call it the Glendale Community Assistance Center, or the whatever. A name that would correspond with community. That's, that's all there is. There's nothing else beyond that, that you need to do. But I'm not in charge of people in the way that they want to conduct their businesses. They can call it what they want, they can created a trust or a corporation, a corporation, they're going away, an organization of some sort, that will be appropriate for the financial sense centers are the financial system that's been in place coming into place, you're free to do that. If you if you feel we'd like all of the gym benefactors to have to participate in the in the training, Director training, if it comes into the into your area of you can travel to attend it. Because you want to know what your directors are being told. So it's consistent. And it's always a good idea to be consistent, one benefactor to another so that the directors don't have any conflicts. So they have like a manual to go from that similar to the director that's over there, and another CAC program. We're just trying to help. That's the, I anticipate that this director Academy is going to be really big. Obviously, it has to be the 1000s of people going into an organization at one time for the training, so because it's going to take those kinds of numbers to get around to everybody in the mail will find to turn it and be in a position and make things work. Yes, as is, will be the administrators of this program, but on an individual basis, that would not affect the way that we're working, we'll be fine when I say that a grocery store is usually local. And you can go in and say and do put them on offer them, let's say that way, employment

contacts the owner and so all the way down and set up a parallel type of when you go into the RSS platform, they will be and set up the employment contract. It doesn't need to be part of the LW industry level on industries in order to be a part of the RSS program. So we're going to fine tune that along the way and things will be we'll work it out so that that it's it will function the best way possible. Yeah, if I were you, I would be thinking about, is there a need to know? If there's not a need to know? Why do you need to share it with them? Do they need to know that you're a Zim benefactor, and have definitions and find out that you get all this money? That's the sort of thing that you're really not wanting them to know about. And yet, maybe you do. Do they need to know to function as a director? They don't need to know where the source of the money, they just need to know there's a managing director that's over them and doing things. You keep your anonymity, once your anonymity is out in public, it's going to be very difficult to put that back that genie back in the bottle. So you have to be very, very careful. And that's why we're going to have an NDA. So on the NDA, if you want to exclude people, from not being able to talk to him exclude put their names down as an exclusion that you can talk to them, we'll go ahead and do that. But have it clear in your mind why you want to do that? Is there a reason for it, if there's not a real good reason, other than just I'd like my family to know that I'm wealthy. That's not a real good reason. That's a that's a ego reason. And we're trying to get away from that in our decision making process. So I would suggest you revisit those thoughts. And the idea here is, if they don't have a need to know, then don't tell them. If they do have a need to know, then you can kind of share appropriately. But know that that's a leak. And I say a leak, that's a possible leak in your program. And somebody can just start leaking out the information, inadvertently, or not trying to cause problems, but can just simply cause problems because you let them have that information. Next question.

So if you distinguish the, the ones that were printed from the gold and the silver bonds, there, none of them ever have any value. So when I say value, they have a curt Marshall resale value. But the actual bonds themselves do not because nobody redeem those bonds, except for the Alliance, and the Alliance is going to do it so that you can have your money. So if you buy the gold or the silver bonds, as well as the printed bonds, as to do with any bonds that you buy them, you want to exchange at the redemption appointment. The alliances said they will redeem them. They will redeem them. There's no bad bonds as far as the alliance is concerned. And this is a word if you are a humanitarian, under my definition of humanitarian and that's on the website, the first drop down menu under the glossary of terms. So if you're if you tapped into there, you'll get everything you want. That's because they need you to do the work and you need to have money to do the work. So there's a whole different thing. Don't worry about fake ones. In China, or wherever the alliance is said that they will redeem them, period. Next question.

R Ron Giles 30:22

You have to just simply patiently wait until your contacts, there is no way to push it. There's no way to get your angel to come and talk to you and get money so you can do your job, it's going to happen when the RV takes place, and we receive our redemption funds. And just say, and not until then. So all your wishes and all your desires to get going. The Alliance knows what needs to be done. And you're not going to get a dime before that redemption appointment from the alliance. The Quantum financial system has to be up and running, there has to be GESARA compliant governments, or they can't be a part of the quantum financial system, or all kinds of things that need to take place. If it hasn't taken place. It's not safe for us. Every machine gun

nest out on the battlefield has to be compromised or defeated. Because you're gonna be going walking around and all of a sudden, there's this live machine gun Nash and you're gonna get killed.
