If all CAC worldwide have the same name, it has the advantage that the beneficiaries always know what to look for when they need help. This would make our work and our beneficiary search for help much easier. What do you think about this?

I think that that's has some really good idea. I think it's a really good idea. I had thought like, instead of CAC, Liverpool, CAC, Paris CAC, let's see in Paris, you might have, I don't know how big Paris is. You might have 20 or 30. Community Assistance Centers in Paris. And each one of them would have to have some kind of an identification. And I've said like here in Salt Lake, we have a Glendale, it's a small, little geographical area. I call it a community. And so it could be Glendale CAC. But I liked the I liked the use of the word CAC or Community Assistance Centers. But this is a good idea. And I can't see anything wrong with that. Let's just see how everybody feels about it and try it out for a little while and see where it goes.

You can go in there and just see how their CAC is run, and how they're doing things. You may not, they might not know you, and you're just missing and you just go in and look around and see how they're doing their CAC. I think that's a really good idea. And see how that goes. I'd like to put it out there and see how people feel about it.

And, you know, if you were to go through the appointment preparation, you wouldn't have a wondering if you've got any more information that you need, because you'd have this all right there. So what I'd like you to do is go back to the menu items, the RV, QFS info. And read up on those appointment preparations, and the appointment and get familiar with it. There's five or six documents in that menu that are absolutely essential for you, and I don't believe you've read those. So you need to go back and do that so that you'll have a greater understanding. And then when you go to your appointment, you'll know that you're ready for it. Now that nobody else is going to help you do that, because it's all there for you to pick up and then do yourself so good luck on that. Next question.

I've done the math below. Can I volunteer to fund the RSS program for 100 years, any individual with a single 100 T zim asking 500k per zim can cover the RSS program more than four times over with their first quarterly payment. So like to volunteer anonymously. Of course, there are many benefits for starters, it would greatly simplify the corrupting and would give benefactors one less thing to track freeing up energy for other projects. And of course, I'm happy to add money for adjustments and increases. I've already overestimated but I'd put double or triple in that many more. You yours as well, it just seems like a very simple solution to a great many questions and concerns.

You know, I see what you're saying it's a very simplistic exercise. If it was only beneficiaries that go through the RSS program, then I would say, Well, yeah, somebody can take care of all of it. But what about all of the contracts? What about all of the other things that people do? So it's not, it's not that simple. And it's a simplistic sort of way, yes. But it takes about 40% or something like this 50 60% of one, one payment for everybody in the world, seven and a half

billion people to bring into \$364,000. That's one full year of the beneficiary program with all six of the trusts in place. So you need to cobra, you said it's like four times or three times or whatever, at any rate, for one quarter, but no, it's your it's not feasible for us to do it that way. Because everybody has their own money. And what you're concerning there is the whole program is set up for each individual, benefactor, or managing director are starting to call them. And they're the ones who are in charge, it's their money. And they're the ones that have the ability to use the programs for their humanitarian projects. And so having one person involved with all of the beneficiaries is I don't think that there's a value to that. i It's easy to it's would be easy to do, but it doesn't solve any problems that exist now. So I don't see that as a as a solution to anything. Because there's no problems there to be a solution for next question.

At the redemption date, the Benefactor will receive the referral letter to enter into a contract with LWS only then he receives the master ID number and can use the RSS platform for his humanitarian work. Are there any ongoing costs for the benefactor to use the accounting system of the LWS RSS, etc.

No, we don't charge for any of our work, that you get to use it. Just like we get to use it. You're in charge of your money and, and each one of us has benefactor will be in charge of our own funds. And with the master accounts and the backup, bonding account bond account. So it's, it's it works out pretty good. But there are no cost of the benefactors involved in general. So that's your that's the answer to your question. Next question.

for you to function because you're the one that has to go to the redemption appointment and and redeem your Zim so that you can have your funds to do humanitarian work. So Well, I would recommend to you, and to anybody who is having a hard time getting eBay or somebody like that to send them. And of course, if you're looking for the, those 200, or 2008 models of Zim bonds, those those series that are costing you two to \$300, apiece, they're no different as far as the alliance is concerned, for the ones that you can get 10 for \$17, or 20, for \$17.10, for 14, or something like that. And then you can buy one, Bicentennial Centralian, which is as good as 60 and 6100. T notes, and you're spending \$3.50 for it, plus 99 cents for per, to have it sent to you. You know, it's how the Duluth, Georgia, those are the kinds of things that, you know, if you're having problems with them, there's really no problems to have, there's solutions to the problems, and they're very inexpensive. But if you don't have them, you have to raise your hand and let us know, I'll be happy to send you some. But please, be careful. I mean, I've got quite a few. But I'm looking for people, the Alliance are looking for people who will pick up the ball and run with it without having to be told what to do. And all I'm saying is I'm suggesting you go and do the reading. And then you do listen to the videos. And then listen to watch the videos and listen to the Q and A's. You'll get everything you need to know really seriously, you'll get everything you need to know. It's not as if we don't want you to ask questions, because we want those if there is a question. But if the question comes, and it's already in print, right there for you to read, and you don't read it, then how can I really help you? Because you're just trying to dodge the idea that I have to get in and dig it out myself. And I don't want you to feel left alone and having to do things on your own. That's, that's hard to do. Excuse me hard to do. But you've got to go through and read everything. You have to read everything that's on that QFS 2020 website. And then you can listen to the videos and that's all going to all the information is there. Just like this person before it had a question about the program. And how do we how are we going to do things that way? Well, what shall I have done? Are we it's all right there. And you don't need to be told you just need to read it, because it's very simple. It's not that hard. It's not that involved. It's new, yes, but you got to

get involved in it. You can't do it any other way. There's no other way to become a humanitarian with love won society becomes zim benefactor, managing director until you have all of that information as part of your life, because that's what you're going to be doing. This is your new job. Now, I'm saying this now, but it's going to be really important for you to be prepared with for your Dead Redemption appointment. A lot of the information can come later. But if you keep putting it off and putting it off, then you're going to be stretching out trying to figure out what's going on while everybody else is out there doing their jobs. So I'd like everybody to prepare for a new way of living a new way of life. And in order to do that, you need to go in and find out what love won society is all about. If you don't feel inclined to do that, then maybe you should seek some other organization that you feel more comfortable with. Because you won't be comfortable with us because without the Zim without the \$500,000. Rate, you're gonna have a problem getting the amount of money that's necessary for you to do humanitarian work. So if you haven't got, zim, let's get it to you. If you don't want to get some and are kind of waiting or don't want to spend any money on it, and that sort of thing, then maybe check and see how you feel about love won society. It's not for everybody. And it's not the only place for humanitarians to to put invest their funds. Look at what you're doing. Determine what you want to do. As far as love won society is concerned, you have your projects, most everybody has a project, be reminded that you are not being funded because of projects, you're being funded because you are the humanitarian that they're looking for. And when you get funded, it won't change you. Other people will change them entirely, it will become greedy and, and haughty and proud and have a hard time working with people, because they gotta be the boss all that. That's great. And that's not the basis upon which humanitarians work and that's the vetting process that the human, the Alliance agent is going to go through with you. So, I feel that most of our people are pretty much ready for the redemption appointment and getting ready are getting their funds. And some are there and some are starting just starting out. I can't think of anything, if you're ready for the appointment, and you've done all your the things that you wanted to do, then the only other thing is to be is to pretend like the money's already here and go identify somebody who you'd like to be zim or excuse me, a director and you see and and how would you deal with them? Have a an appointment with them? That is not real. But what are you what are the things you're going to ask for? What do you want them to be like? Do you care if they're gay or whatever? I know I've got some people that I'm going to the beach is perfect. And when I inquire about them, yes, there's no problems or at all. God doesn't have a concern about this, this gay stuff. And if you want to use God's the Bible and so forth to judge people, then you're going to have some real problems. Because that's not the way that we're going to do stuff in the new world. So judgment is judged, not period. If you

want to come from judgment about other people, what they do and what they think what they build At then that's a problem you're going to have to work through. Because you're not going to be effective with those kinds of judgmental attitudes. So it's time to fine tune everything about your lives. And getting prepared is not just getting the appointment and getting the money and everything you have to learn were deficient in the requirement to become a Zim benefactor. And I'm hoping that you're taking that into consideration. So there's always more to do, always more. And I've been doing more and more and more for the last six, seven years. So am I done yet? No, I'm not finished yet. We're ready, we're ready to to receive the funds and started on what we're trying to accomplish. So we're always moving forward, the road is ahead of us, the faster we go down that road, the faster we get to where we want to go. So prepare yourself for the journey. It's we don't know what's coming. We don't know how many mountains we have to climb. We don't know what the Alliance may have for us. As far as helping with some particular project, if you don't have the money for it, you're just doing money for your own projects, you're not going to have money for the helping in other locations, in other areas that may need some help. It's never bad to have too much money. And if you think about that, what is sufficient, I've been giving this for years now \$500,000 or 100 T, now it's gonna get you all that you need to do. If he have five or six or 10 or more T notes. You don't lower the value of the Zim bonds themselves, you just ask for the same rate, because that's the rate you get from your heart. It doesn't matter how many bonds you get, you still ask for the same rate because they the your heart knows what's coming. And you're you think your mind does your mind is going to get in the way because they have no idea what's coming around. And you might get a number now. And you say, well, \$500,000, that's a lot of money. Well, that's what your mind is saying. That if your heart is understanding what you're going to be doing, and this is the amount of zim that I have, then I'm going to have to ask for \$2 million per zim those are the kinds of thoughts that need to come to you. And don't dismiss these kinds of thoughts. If you don't understand what a \$500,000 or trillion is hard to understand, we have nothing in our lives that has that kind of amount. We don't. So don't worry about the amount, don't worry about the zeros. Yes, go in there with the idea that I'm going to get what I need for my activities for the rest of the 100 years. And then let that just happen. And if you get more money than you can spend, then you put it over in the bond account, let it accumulate at the end of the 500 year or the 100 years and say, well, they still need some, well, you've got all of this over there. So there's no reason for you to not get the highest amount that you're qualifying for. I'll say that for 100 times. Just get yourself all the money that you can, because you may need at all. Okay. I understand that we have to place funds into the bond account. I also understand that the bond account is used to assure an employer that we can fulfill our obligations. How do we prove to the employer that we have those funds? Are those funds placed in an escrow account? Do we log into the QFS or RSS to show the amount of money in the bond account for the company? In short, we know we have the money in the bank account. How do we prove that to an employer?

Ron Giles 24:34

Obviously, it's going to be a question and how what employer are you talking about? Are you talking about small business? You're talking about Ford Motor Company entirely different and that's why the love won industries is involved in some of the higher ones because that whole

issue you're going to bond for 10 years. If Ford Motor Company is taking 160 to \$200 billion a year for their services or to build things. And that's how much they require 180 or whatever \$200 billion per year, you're gonna have to put that much in the account for 10 years. Now, that's an escrow account, I don't know how to do it any better, we find the people that will do it. I don't know that, let's say it's one quadrillion dollars, it's going to stay in that account for a long time, because we're not going to foreclose on, we'll get our money every year. But they don't know that unless they're part of our program. But they won't have any understanding of what we've got. They just, there's no reason to let them know. So we just put in will put a quadrillion dollars into an escrow account for you. That is your 10 year bond, it will be reestablished every year. So that same quadrillion is just going to stay in that account. And it's going to be good for the next at least 10 years, if we fail to stop and stop are our payments to you. And then you got to live up to the contract. So there's all kinds of things involved with it. And, but it, that's the way we do business now. So if you're not putting that that kind of money up into a situation for, for a bonding company, you don't have the kind of money available, you're not going to be doing the things that are available for for you to do, can you understand why I'm telling you to get the higher rate is for your own good is for your own humanitarian success. So you can do whatever you need to do and want to do, as far as the humanitarian is concerned. So don't worry about money in a bond account, you can have that there, that bond account, you just leave it there, it accumulates, I have no idea how much you're going to be spending on an annual basis. So I don't know how much you're going to be putting in there. But if you put in 20%, in the beginning, you know, I'm gonna put a quadrillion dollars in my bond account. And I'll be working with the point two, five, sort of thing. Until we get starting to really move money. And then we'll start lowering the amount that we put into the bond account, each quarter, we have finished spending it all and we'll get a new shot of it and the other will go the left with leftover will go into the bond account. That's the way that I look at that. And that's the way it's got to be set up. But once society can't take responsibility and liability we can't do that. Because if everybody did point out on us, and who's gonna pay all those people that money. So it's on an individual basis. And each individual basis, each individual's own gym benefactor, program director or managing director needs to understand the liability issue and be responsible. I have to do that, just like blood one society will be doing that will double bond everybody. Does that mean we have a lot of money? Yes, we do. We will have a lot of money. And we'll double bond everything everybody's doing. That's just, that's just our requirement. And we're getting a bunch of bonds in that, that are donated to us from those who go dragon bonds and all kinds of stuff. So it'll happen. But you've got to have your responsibility. And we don't have to show them the amounts, we can just put in certain amounts that will take care of them. And escrow accounts is the best way that I can figure it out at this point in time. And we'll see how that works out in the future. If there's somebody who can say somebody from the quantum financial system that can say, These people have the money, this person has the money to respond to your to take care of your responsibilities as far as a contract with them is concerned. And that may happen for us. And that may create the credibility that we need without having to put a quadrillion dollars into an account for 10 years or forever, for that matter. Things should change. But that's the way it is right now. So we have to figure it out now and then change when they things change. That's the solution to problems that we'll find the solutions. It's an interesting question. And I'm saying, if you believe people will do that, then that's the kinds of people that you will be hiring. Because you won't know how to differentiate them from others that are really good. Not all people are that way inclined? Yes, there are those who will be or could be. I have very much very strong faith in the fact that things will be changing because the alliance will not allow those kinds of bad people still to be with us. Who would do those kinds of things, however, you manage properly. If you just put money into an account and let them spend as much money as they want, where's the wisdom and that you you have accounts with accounting firms, where you know exactly how much they're spending for this, that and the other because it's all put together and it all balances out. And there's people that that are there that you don't know about and and you can find out and check it out and see if they're the good kinds of people. But yes, the business owner does get all of the profits from his business like he did before. Is that not a good thing? I think it's a really good thing. Yeah, I do. Next question.

Um, as I was reviewing my appointment, prep instructions, I came across a structured payout section that still puzzles me. Please clarify for me how 100 year term can be funded when I'm receiving 10% of the primary principal every year, I was taught the 10% over 10 years, not the 10% over 10 years on 100 years would equal 100% of the primary principle. So Should my binder be updated to say that I want 1% of the primary principle to determine quarterly structured payout payment for the next 100 years? Or am I missing something about the way the alliance is funding benefactors?

You're not understanding what structured payout means. Have I ever said that? It's 10%. Well, I shouldn't have said that. In the beginning. I didn't tell people were upset and changing. But I have changed it from receiving 10% of the principal primary every year. You don't receive print 10% of a principal primary every year. The principal primary is the rate times the amount of Zim that you have. That is a total it is a figure. It is a principle. And I'm asking for 10% of that debate paid to me Every annually annually for a 100 years. Now, let's go back and see and say that again. 10% is not an percentage or annual percentage rate is just 10%. Because that's what I can ask for up to 10%. To ask for from that primary principle to be paid to me on an annual basis for 100 years where did how much money is put in my account? I'm going to ask you this question. How much money is put into my primary? Excuse me in my structured payout account at the appointment? If you can answer me that question, then that's the answer that you're looking for. At the appointment, you will get let's let's use our fingers. If I asked for 500,000 I'm going to get per 100 Tea no aren't going to get 50 quintillion dollars as a primary principle I want 10% of that which is five quintillion dollars every year for 100 years. So, at the end, the end of your appointment, they will have put into your structured payout program 500 quintillion dollars 100 times five quintillion is five quintillion dollars into your structured payout that is paid out to you by the the alliance and those who are responsible for that. They'll pay you the five quintillion every year. The end of the five or the 100 years, you won't have any more money left because it's all been paid out. And you'll have five quintillion per year for your projects, pay quarterly or annually. Semi however you want it. I'm saying quarterly because I think that's a better way to look at it. Okay, so go back to the structured payout section, look at it, read it. And then tell me how much money is going to be put in the structured payout or the 100 here payments to you. And you'll see exactly what I'm trying to say. Next question.

If she wants to be as in benefactor, then she needs to take the responsibility to get the money that she needs to be a humanitarian. And so what I'm trying to say to you is, you might want her to be one, that maybe she's the one who's going to be working with you. He doesn't need to be as him benefactor. What is, you know, what about all of those people that are really good humanitarians, but won't have the money, those are the ones that we will be working with, will be will be thankful that they dropped by, and oh, gee, I'd like to be a part of this. Those are the humanitarians that will be doing the work. But once you get the money are not the only humanitarians, the ones who get the money are the ones designed to have money, so that they can do the work. And those who didn't get them, the money are the ones who are designed to do the work. And so it's going to work out just perfectly. So it the idea is that if she doesn't pick up the ball and run with it qualified to become a Zim benefactor, then she's not going to be one. And let's not leave it at that. Let's just simply say, well, she's gonna be involved with you. And I wouldn't make her as in benefactor as him benefactors a major responsibility. He may not want to do that. And there's some in our group that don't want to be doing that. But they're there to learn how to be a managing director. We'll see. We'll see how that all works out. But I feel like if he wants to be let's, let's move her along to point where she can knows what's required for her to do to become one. And then let's just do it. But he's got a different program going on love won society, it's not love won society. So he's got something that he's worked out to take place. And that's to do the smaller humanitarian activities projects. And, and that and that's just fine. You won't need to do that with us. Because you become a zoom benefactor, you become a managing director, and you are the one who goes to get the money. You're not You're not asking for assignment, or connected consciousness or the Alliance to pay for ping. or, excuse me, the Alliance. They'll give you the money if you have the bonds. So that's the difference between the two. We don't have you don't have to have a qualified project for us to be humanitarian and have some projects in mind and you just give your ideas about what you'd like to do and then they they test your water test who you are and so forth, and then they allow you to do it. So it'd be good. Next question.

Okay, this is the last question is long. Regarding the ESS CAC. contract manufacturing. I will use a friend's garment factory as an example as this is a large industry here in Indonesia. The factory produces garments for five different international brand names. One example is Victoria's Secret. Most are under long term general contracts, but the styles and amount of production is seasonal and can change every three months. The factory has roughly 3000 workers and does not produce any of its own products but only customs specific specifications for the brand name season by season. Also important to note is international brand names usually have contracts with hundreds of different factories all around the world and each factory just produces also of no talking about Youth and Government standard minimum wage, no child or slave labor, and typically are making low margins between 12 to, or five to 12%. Due to the COVID economic times. This is just an example. But it's important to know that the majority of manufacturing in Southeast Asia is now contract manufacturing, and very few brand names in many different industries own their own factories anymore. Would it make sense for the CAC offices to handle the employment contracts in this situation to ensure continuity of production for the local factory, since the ESS program would not be able to pre purchase the items? What are your thoughts are on

interesting ideas, and this is something that would need to we need to have a continuing conversation about once we get into the love won industries, this is a specific thing and it has specific problems associated with it. That may be maybe bigger than than the economics table, or excuse me, the CAC program. It may be a little bit further along that the lines are that maybe there's more than 25 employees sort of thing. It doesn't matter to us if the factory is a name, brand factory, or just produces materials are calling for a name brand. Those are the kinds of things that would be that we wouldn't know about, but it's part of the industry. So you find people in the industry and you start working out some of those kinds of employment contracts. There's there's the employment contract for the manufacturers, and how to do that. And there's some specific things as above with that. We're talking here about some other things that are just specific for that particular industry. And that sector of the economy. And those are where the professionals get involved and get in get the understanding that they need to be able to put all those people into contracts. I think it'd be a wonderful thing if we could do that. But it takes the kinds of people who are involved in it, Mike, you You sound like a good person. You sound like you know what you're doing? Well, let's go ahead and, and counsel, counsel with your counselor, Alliance agent, and we'll see if that's were some of the things that you'd like to do would be and then let's get you involved with Lavon industries. That's my suggestion. I guess that's it for now. Okay, well, we'll be we'll be good, then. Thank you, Tracee for your input. And I don't have a, I don't have a problem with you. Taking the reins and drawing me back in. That's a that's a perfect situation. I'm inclined to do that. And you're inclined to do what you do. And it works out really good for everybody. So I have no problems with that. And, and thank you, by the way for all that you do. special lady. And with that, let's go ahead and we'll we're we're caught up as far as questions are concerned, we'll probably be putting out a jot form to ask more questions if you if it seems appropriate.
