Is this accurate?

Ford Motor Company has a structure in their upper management for bonuses and, and benefits and so on so forth, I have not seen the need for us to get involved in that because it's paid out of the profits of the company, we let them have their profits, and we we don't pay their upper management fees, or rates or wages, that's part of their company. So we're in the middle of management and, and that's good enough for us. They get to do the all of that other stuff for their own purposes. And that's the way it was intended. So we're not being involved in their profit source. We're just helping them and providing them on an annual basis where they're going to make money, because we're buying everything they can produce. So that's part of their project. So they get, and there's some incentives with that. We'd like them to do the research and the development and do new new widgets and gadgets and that sort of thing that make the cars much safer. And so we encourage that. And if they do a good job, then they get more money. So they sell more cars. And that's what this is all about. So we don't get involved with that. But we'll see how that all turns out. And the number of zeros with that for just one bond is way more than all the stuff that you've got going for you. So why do we pay two or \$300 for a zoom note when the lion says, You don't have to do that? You go ahead and get these silver and gold bonds. And we will redeem them for you. So am I encouraging people to do that? Yes, I am. There's no reason to be spending that kind of money. I don't have the kind of money to spend on that. So I'm trying to help people get their Zim without spending too much money. Yes, I am encouraging. Why because the alliance has said that they would redeem those people think that the notes are really, really, really important to the alliance. When you go into your redemption, they will take that and destroy it. There's no market for those things. Does that make sense to you to spend \$200 on that and then turn around and get one of these large bonds, a middle Dalian for \$3.49 in the dollar to send it to you. No, I'm not doing that. I don't think it's appropriate. What do you think about Bitcoin? You think that's gambling? Or any other cryptocurrencies? Is that gambling? How many of you are fighting to keep that in place? Well, if it's gambling, it shouldn't be happening. Right? According to what you're saying? I don't know. But people are going to want to do crypto currencies, XRP. And all of that other stuff. I don't see it surviving. But it's not my game. And I'm not the one in charge. I just know that the alliance does not like that kind of activity where you're making money on money on other people's money. So is that the definitive answer? If it's, if it's, you're making money on other people's money, or you're doing something that's not appropriate? And the lines doesn't like it? Does that mean that that's all gone? I don't know. Those are questions that you need to ask. And so I'm going to say, cryptocurrencies are not what the Alliance wants us to be doing. So I say let's let that go. But I'm not in charge of it. Excuse me. We'll see how it goes. Next question.

And the overview of this, is it proper to present your project as a model that will be set up to be duplicated county wide in your state, then by each state in the nation last globally, thus, using the programs of the LWS incorporated into your own and the zim benefactor programs at the appointment?

Those are the ways that you didn't need to think set it up, start start somewhere, make it work somewhere. And then take that from what's working, and then introduce it into other locations and start going through there. So it's just a way to do it.
