Yes, there's no problems with using them as your projects. I mean, you're the one in charge. So you get to do what you want. Yes, they are humanitarian projects. Good. Thank you. Next question.

In setting up accounts at the redemption, can I set up a separate trust account for the CAC director so they can easily access money for the projects they're working on? What are your thoughts?

R Ron Giles 01:01

I don't think that the redemption time, that period of time is the one to start setting up your accounts for your directors. When you have a director, then you set up the account for them. And I agree 100%, setting up an account for a director or even down into the system directors

depending on what their responsibility is. So that there's an easy flow of funds. Keep in mind that the director can be the one that's in charge and issue funds to assistant directors, as the needs come out. And you you'll work that out because they'll they'll be a way for it to just be perfect. But the Redemption is not the time to set up accounts for the CAC directors. No, I would wait until later. Thanks question.

In the products that LWS is purchasing, like the cars, will you do that to a network marketing companies products as well, and help the distributors get their commissions as they sell the products.

R Ron Giles 02:16

Network marketing is probably not the best way for us to be buying all that they can produce. It doesn't work out that way. Because there's so many different people that have to get paid out of it. It's an idea that we need to think through. But my initial feelings about that and network marketing programs are let them be successful. We're giving their people money, a lot of money. And they're going to be the their sales are going to go way up, because people will have the money to buy the things they want. That's my idea. But we'll have to look closely more closely at that. Oh, next question.

I already have Zim bonds. And I am a US citizen living in Thailand wanting to be clear. Will I be contacted here in Thailand for my appointment if and when it happens, I will not be returning back to the USA. So my appointment must be here in Thailand, if you could help me understand this, I would appreciate it.

R Ron Giles 03:30

Okay, let's let's be sure we fully understand you are a beacon of light to the alliance. You're shining so bright, that they cannot. You cannot be lost from them. They know where you are. They're going to locate you wherever you are, and have your appointment and your redemption appointment and so forth at that location. Now, the reason I'm saying this is I want you to realize how important you as an Indian, you're just one of many as we think it to be. But to them, You are the prized possession. And they're going to bend over backwards to get you your funds so that you can be functioning as a humanitarian, as we bring in the golden age of mankind. They will never let one of our people not get their funds, period. So be sure that you realize how precious you are. That's important. Next question, please.

let's be sure we understand our job. A benefactor does not need to get involved in the RSS program very much at all. You just need to have a few people to start it for you could be your family members, anybody after that gets referrals from the benefit beneficiaries. And, and expands that way. You have absolutely no need to be putting your card all over the world, why you, you understand what I'm saying? All you need to do is get the ball rolling. Because if you send your card, then you get all of the benefits of the program, all of the bonuses, and you don't want that you're giving the money to other people. Now, it won't work if what you just wanted to do was done. Okay, that's the number one. Number two, if you are advertising, if everybody advertises, then nobody gets a chance to be able to function properly. It has to be word of mouth. It has to be because you need a referral in order to sign up. Let that program go by itself. And so yeah, it's not practical. The benefactors just isn't the one in charge, while he's obviously in charge of punching his foot paying for it. But I want people to understand that the Benefactor has very little to do with the RSS program, as something that they need to fully engage in or something of this nature, because that's not true. If you wanted to go to different locations in the world, whatever, then then you're the one to do it. Or if you have people that you would like to sign up in those areas, give a referral. And or let your family a referral or something of that nature. However, your job is the CAC program and the other projects that you're doing. The the RSS beneficiary program will go by like wildfire, because people want the money. But luck going to be sitting around for a day or two. Oh, let's see, I better go ask grandma. She wants to get involved. No, they're gonna call him right now. Tell him that, hey, I just signed up for the RSS beneficiary program, what you don't know what that means. But I'm sitting here looking at my computer, and it's downloading 10 cents a minute to me, in my account. I paid \$10 for this. And you can do the same thing. And it's \$144 per day. It goes 24 hours a day, dollars an hour, 24 hours in the day is \$144 \$1,000 a week. And there's ways to make more money. So let's sign you up grandma and let the thing go for you. And then, okay, I'll let you talk to Marilyn. And that I get Jane, I want, I want I want you to do divided up and watch and see how fast that goes. Not only in your family, but in that neighborhood where your family lives. And not only the neighborhood, but that city that state. It goes fast because there's nothing to stop it. And I don't give me this stuff. Well this really hard I didn't know how to get people to do. Don't go there. Just say pay your \$10 and watch your money come into your account. That's all I got to just tell them that if they don't want to do it. I'll come back here tomorrow. And I'll show you how much money I've made since the time that you and I talked and the time. That means that that's how much money you could have made. So let's let's just ball them over. I don't I don't sit and listen to their garbage and pretend like That's something that's valued. Their their garbage is their own garbage and their own break in what they want to try and do for life. So it'll just let it go. Okay, let's go on to that next question. Or that question.

As a humanitarian benefactor, I'd like to sign up local merchants in the RSS program and encourage them to put signs out informing people of the RSS program to increase prosperity for them and their customers. Is this allowed?

R

Ron Giles 10:31

The beneficiary is the one that's in charge of those kinds of things. If they have a business. Again, you're focusing on the the beneficiary program, and I'm saying to you, that's not what you want to do. You focus on the humanitarian, or excuse me, the Community Assistance Centers. And your directors will be doing what you just asked them to do what you're saying, and suggesting that these people do. You sign up a local business that supports activities and things that they could do a service oriented businesses, and you sign up their employees. What a great opportunity, those employees now become beneficiaries, underneath their, their boss, all of this is just perfect. But I want you to understand that is the benefactor is not your job. If you do that, you're wasting time. As far as getting your stuff out, because if you start doing the Community Assistance Centers, it will continue to go like wildfire. Your job is to find the directors, your job is not to find beneficiaries. Directors are the main course of what you need to do. And they're in your training for them needs is the most important thing you can be doing. So I want you to get off of the idea of a benefactor being a having to promote the beneficiary program because you don't it'll go like wildfire. And you're not the only one in town. You got other people, I'm in a city of maybe, I don't know, maybe a million people. I think that's too much. Well, we have 29 that the alliance told me we had and that was a year and a half ago, of people who have Zim. So it's going to go fast. And don't pretend that it won't just just you let it start. Look at it every now and then, if there's a way to do that, and I don't know that there is for you. It may be that the Alliance wants to work it out so that you can have some, some eyes on some of the stuff that's going on. Let's see what happens. So please get off of the beneficiary program is not your job. Your job is finding directors. Unless you don't want to do that. That's up to you. Next question. Oh, well, let's go ahead and finish that.

Ron Giles 13:55

Don't even concern yourself about Freemasons and other secret societies. You get the idea that there's so many of those people and they're all going to get all of the money and be the ones first and all that sort of stuff. There's not that many Freemasons. percentage wise, they may be less than 1% of any population in any location. They may have a community in someplace, doesn't matter. Don't concern yourself about negative people getting involved. Negative people will not be part of our programs. If there's any other Freemasons left don't worry about that. You're going to you're going to stumble and fall over one half percent and leave the other 99 Point 5% People unaccounted for. No, just let it go. We're not here, policing things, that's not our job, the alliance will do that. And they'll do a wonderful job with it. And the quantum financial system will do it, and they will do a wonderful job with it. Our job, again, we wanted to do the CAC. That's what you focus on, get your get your our RSS program up and going, and then forget about it, just let it go off to where it's gonna go. And then you focus on directors and training of directors, and working out the things that you would want them to do. And

that's going to be your job. Finding directors training them, we're setting up a whole training for directors anyway. And we'll probably put the benefactors in through the training first, so they can see what other people are being trained to do. And then you can work in harmony with that. So. Okay, from there, let's go. Next question.

R Ron Giles 16:29

Okay, you're, you're new. And there you are. That's the reason why you asked this question. You've not been around long enough to know. And I have said that and stated that 173 times now. I'm being silly. The Alliance has said that they will redeem gold and silver lookalike bonds, from Zimbabwe, wherever. And, as well as they will, the ones that their 2008 that they're charging 250 \$250 or \$300. For and we're paying next to nothing, maybe a penny per hours. So the alliance is basically said, you know enough of this profit for all those people, let's just go ahead and get what we need done. So that we can have our Zim dollars and, and redemption dollars and do our humanitarian work. That's not 100 T notes, either. You can get a bison Talian for \$3.49 with \$1. To transfer it, or to ship it to you know, tell me what you'd rather have. The Bison Talian is 600 zeros. You don't have to count them all just accept my word for it to colored zeros for \$349. And you ask for \$500,000 on that, or whatever your heart has told you to ask could be in the millions. And you'll be in a position to do most anything possible that the alliance would ask you to do to help in some of the projects are working on. I don't know that's really true. But you're positioning yourself I know that I'm going to be asked to do thing. So I assume everybody's in the same boat. I am. It's a cruise. We're on a cruise. So we're going to have a lot of fun with this. So let's not let's not worry about some of that stuff. Purchasing Sam, you send you return an email to me with a request for the latest the latest Zim bonds that are available, and I'll send you a list of the best one selling fine and I been doing that for how long six months or so they've sold out if I put something out there there's there's a lot of people are gonna buy it. So I have to find one. And if you go to eBay and you go to that particular site, you there's a little box here that says how many do you want? Well, I put in there 100. And if there's if there's not 100 Then it will say please ask for a smaller amount or adjust for a smaller amount. So you know how much is there and available and I? I have to they if they don't have at least 30 I don't even talk to him about their stuff. There's too many other vocations to get it. So. Okay, next question.

Oh kay, I just watched the new video on employment preparations. Although I've had our binders at the ready for about a year now, it was great to have a refresher, I noticed that asking for proof of funds statement was not on the preparations I currently have that stipulated on our cover letter stating proof of funds, statement 10 needed for third party persons real estate salesperson to qualify us to view property where an owner may require proof of funds, please advise if this is not necessary to have as a requirement.

I think it's a good idea. And as much as good ideas that may have been, it caused 1000s of people to wonder what a proof of funds is, I purchased some larger properties. And without the proof of funds, they won't even let you in to see that property. So I have to have some statement from my bank, a financial institution, that I have enough money to be able to buy that house. And I'm not just walking through to see how people these \$10 million homes and so forth, how they design and build their house or whether in or decorate their house and that sort of thing. The carpets and then and then you know you go, they are concerned about those kinds of tire kickers just going around and seeing things. So they say to the listing agent, do not put people through let people through who do not have a proof of funds letter. And we're going to be the kinds of people who will be buying those kinds of homes. That's the only reason that I have said anything about it. I was anticipating doing that before I started sharing love won society with everybody. And that's one of the leftover things that many other people, perhaps they would they would need it if they wanted those homes, but they don't know what it is. So I just left it out to many inquiries to me, where there's a proof of funds. If you don't know what it is, don't worry about it. If you've already got it in your, your presentation, believe it don't worry about it.

I'm married to a wonderful man and I'm going to become a benefactor. I wonder if he should be a beneficiary and make the \$28,000 a month? I wonder if I should do that. You can see the answer to that question. And again, don't ask me for permission for you to do something that you want to do as a benefactor, I am not your boss, I am not the one in charge. You are. Now also, you're going to have a counselor that's given to you by the Heaven from the heavens. Those are the kinds of things that you work out with them, you have to still have a question. you're brand new. So I'm going to have patience with you. The whole program is involved in the quantum financial system. If you want to know where the money is coming from, study the quantum financial system. Find out how money is made or prepared. And then once we get the goal and they have the redemption. We will go in and sell our Zim to the alliance. The Alliance will then activate gold digital gold certificates in the quantum financial system and put them in our accounts. Digital gold certificates are just waiting there to be activated. I won't go into the difference between the quantum financial system and the Cabal, except for this. The Cabal loans it into the existence. And the quantum financial system uses a transaction to get that into existence. That's why the Cabal has called the debt slavery system. Because it is a debt that creates money for the Cabal. And then you have to pay the interest on it. They don't include the interest. So overall, where does the interest come from? But then you can focus on them. When you can focus on the ESS program and international commodity clearing house and see if you want to be involved in them. Or the CAC or the real estate whatever you want to look at. Prepare for your money first with your money. And that can come next week. If you're not ready for it, then where are you? So I'm saying focus on that first. And then when the money comes, then you can you're prepared to get your funds to do your humanitarian work. So you're going to be in good shape. Bless your heart. There's a lot for you to learn. And I understand that. Good luck in your educational process. And welcome, welcome, come aboard. Next question.

There's no transaction that will be covered by the government. Why do they cover that because they want to tax you on it. Governments who tax people are not going to be a part of Nisar or just Saara they'll be out in the weeds somewhere. I don't know. So when you're talking about this, what's going to what is happening now is not going to happen once the government has changed. And if they're not part of the new government, why would you want to be there? You're just gonna get harassed. And that's what I'm saying to people. If your government hasn't become GESARA compliant? But move someplace else, do your humanitarian activity someplace else, where you are free, and you are safe, to do anything that you want to do. The Quantum financial system has all of the accounts in the world in that system. R Ron Giles 34:23

Yes, they are. And the 30s or 20s and anything other than that the alliance will redeem. There's no restrictions for humanitarian, very humanitarian, there are no restrictions on what the alliance will redeem. I want you to understand that for the humanitarians were involved. They won't have to worry about anything from being redeemed or not getting redeemed by the law. Alliance, the alliance has said they will redeem them all. But it is only for humanitarians. Now, this is something that I just found out recently. Those who are involved in receiving funds from the redemption of any of the bonds have a calling from God before they came to this earth this isn't haphazard. You're fulfilling the calling that you have had. It's in your hearts in your essence. And when you finally get a hold of that and figure it out, you'll say, Gosh, it's true. Yeah, gosh, that's true. I have a calling from God, to be a humanitarian, to bring in the golden age of mankind, there's nobody else doesn't matter how many else's there are. I have been called. And I, my heart is responding. I'm there. And love won, society is not the only one. But it's probably the biggest so far. But those who are called will be getting the money. It's a calling from God. So as a humanitarian, you're responding to your calling as a humanitarian. And that's your calling from God to do this work. Now, I want you to personalize what I just said.
