The owner still younger, if it's a small business, and he's the boss, and if he wants to hire people, you can hire him at a level that he wants and that there's some that are interested employees that He wants to keep around, put them on the pool contract, otherwise have an 18 year old is coming out of high school wants to be a mechanic and in a mechanic shop. He just said the map on an on an E, you can call it a contact and call it whenever you want. But if we do it through the boss and the director who's in charge of that area, then it can be put onto the RSS platform. And that's how they get paid. That way, the boss doesn't have to worry about the money for them. They just worry about training them so that they do a good job. And he gets he gets to pay them what he wants. And if he wants to start out \$15 an hour, you know, you figure that out with the down penny per Penny download bid be. And then he says I'd like to encourage the director, I've got a really good kid here that's really like catching on fast. I'd like to pay him 20 bucks an hour. Can you adjust the download per minute for this individual. And then call me back and tell me when it's done. So the director goes in and makes the changes and then it's done. That's how they that's how they support each other. The directors supporting the bosses. If there's 20 employees, then it starts getting above that there's there's there can be some other in stuff coming in as far as human resources departments and they set those up. And that's something that we can work with. If it solves problems, their directors will will be there to solve the problems.

If I gave you a link, and said, Well, this is where I do all my business or something like that, it will be immediately overwhelmed that purchaser. And so you go there and you've searched out and you find things as best you can. If you find the same ones that I did, then that's a good thing for

you. But if indeed that serves your purpose, the guidelines is basically find a place where you have you can buy them is I would always avoid China, buying stuff from China, although it's less expensive, but a long time to get here. It doesn't really matter where you buy it, as long as you buy it with the intent of doing humanitarian work. You're not going to get counterfeit, you could you could get the gold and the silver and the different colored notes that are replicas of or facsimiles of the originals. You can do that. And some of them are very high valued bonds with tremendous face value face value on the bonds. You get one of those one for one, it puts you far far ahead if he asked for the 500,000 put you far far ahead of those who only have one or two team notes they paid 200 \$250 for Hmm, I've just seen it's available. eBay is the one that I have found some success with in find where you want to go. Because if we start channeling people into these situations, it could be overwhelming.

Homes are much better, the raising of children is much better, the parents were there to give them some stability. If you take mother's home, when you get home from school, then there's a less likelihood that that person is going to be doing stuff. When the mother's not there, they do things that they may never get a chance to do if mom's home. So I believe and or dad's whichever wants to be the one. And there are a combination of whatever. We just want people to have the chance to make decisions of financial decisions in their life, that are for their betterment for their best good in raising children and creating an environment that is stable, that never be destroyed because of lack of money. You're never going to lose your home with us. No reason to. So we've taken all of these things into consideration and come up with the program as it is now. And so the 97%, we're not going to be dictated by the 3% that aren't going to be working. Is this my percentage? No. I got that from inquiring about our programs, because I'm concerned about that, but don't present, do what they're gonna do anyway. And there's nothing you can do to stop it when you can, which is the employment contracts and so forth. And let them do what they want. Make your own decisions. What if
