Sometimes you get a feeling like, oh, this may not be enough, you know, for the price it's required right now. \$13 for 10 100, keynotes, is, is really quite a small amount of money compared to what we used to have to pay to even just get one. So if you have some, some questions in your mind, and check inside your heart and see how you feel about things, and then go from there, that's the only thing that really that I can say. I mean, you've already signed up, if you're asking questions, when we get to the point that we will have a contract ready for Zim benefactors to become Zim benefactors, then that's the point where your decision will have to be made. And then we'll send it out that the contracts are now ready for those who want to become Zim benefactors, please contact us and such and such. And we will start disseminating the contracts out and hopefully people that want to be Zim benefactors will sign the contracts digitally, and then send them back to us, we'll we'll figure out the best way to do that. But that's when the time that you need to have your wishes to be as in benefactor known. Right now, we're we're putting everybody through the training, making the training available for anybody to voluntarily train themselves to become a gym benefactor. And we hope that the training is really helping. But we also know that there are very little that we can do. Beyond giving you information, you're the one that has to digest everything that we have given and, and make yourself available to know and to become Zim benefactor, you're

Well, I'm not seeing the question and that I see I see the real estate thing being set up to, to work in New Zealand as well as any other country. You buy a house, you have the money, you buy a house, and then you resell it to the people under the circumstances involved in the real estate listing service. I think it's so simple to do. Now, how to do it is something that might be different from one country to another. Because there's laws for transferring of ownership of properties. Also, keep in mind that cabal has put everybody the bankruptcy every country into bankruptcy. And they think that they own everything on the earth. And so they set it up so that they can be the only owners and they just lease it out to you and charge you rent. And if you don't pay your taxes, that's your rent. If you don't pay the taxes, they'll foreclose on you. So there's laws in each country, real estate laws for the transfer of ownership of property, the buying and selling the property. We'll tap into any country and work out all the details for us to do our real estate listing company. It's a national meaning in that country. I don't know that we'll have an international real estate listing service, but we'll see. We'll see. We'll see how it works. But each country is going to have to set up that according to their law. Ron Giles 30:08

Okay, number one, you are the sovereign. It's your money. If you want to buy property with it, it doesn't have to be left over from one quarter to the next. You can buy that property anytime you want. You are the sovereign, this is your money. Please, please understand that you don't need present permission to buy something using your own money. Now the money that's left over from one quarter to the next is put into a bonding account. And what you're saying to me is I say, Can I use the money in the bonding account to buy real estate, you have more in that

bonding account in 10 years than you could even imagine? Because you're not going to be able to spend all that you get on a quarterly basis, or even on an annual basis. So can I buy property? Who's going to tell you you can't? You're the sovereign, it's your money. Who can tell you if you can buy something you can't? There's a thought process that that you're missing out on here. And and this is why it's frustrating for me when I get this kind of a question, because I'd like you to understand that when the Alliance gives you money and and through the redemption of your funds, or your bonds, that money is put into whose account your account. Who can spend the money out of that account? Only you it's your money. Nobody else owns it. Nobody else has any business getting into your business. And that's the way it's set up. So can you do it? Yeah, you can do whatever you want. Next question.

CAC directors have a very strong business in my organization for NRA LS business service can be director or part of the CAC organization, he or she can hold several positions?

R

Ron Giles 32:32

Yes, we're kind of opening up that. It was in the beginning, we thought that the directors would just be in their local services trying to help businesses, directors gonna have to wear a whole slug of different hats. It may be that the Zim benefactor, the Benefactor will want to set up directors that will interface with NRELS. And, and I think that that's wise, because on the local basis, is where your service to your community is going to be. The director may be involved in finding contractors to do the remodeling, and set up appliance stores to be able to buy the appliances and get them installed. That's a real big thing. Somebody's got to take the bull by the horns on that and and complete the job. You know, we talk about remodeling, well, it just doesn't happen all of a sudden, it has to be done by people who are in the in the business, so that it's done properly and correctly. And it's it's beautiful when it's finished. And then the home has all of the updated appliances and the updated all of the gadgets and so forth, might even have a security thing, or security system and all those things take people to do the job, somebody has to coordinate and somebody has to pay them. So I'm looking at a potential director. And I'm saying that well, your director, your job, your job is not going to be in going and doing contracts with the local businesses. But you're you can go out and find contractors who will do the work and contract them to do the work for the real estate listing service. So the CAC is becoming bigger than we had anticipated in the beginning and have a lot more opportunities to serve the community. How many directors do you think you need in a community? You could be having 10 or 15, or at least one and assistants 10 or 15 assistants doing a whole bunch of different stuff that's coordinated by the director. It's going to be interesting to see how each Zim benefactor will solve problems within their organization will do some guidelines. But we're certainly not going to give you a, you got to do this, and you got to do that. Because it's not our money, it's none of our business. Your business is to serve the community in the CAC programs. So set it up and be flexible, solve problems when they come up council with your counselor, represented from a representative from the alliance. And you'll be able to do a lot of things that we just don't now know now that are available to do. But the structure is there to do it. And that's the important thing. Next question.

There is no exclusivity, if you want to go another place. Again, what is telling you that you can't do that? Who would tell you that? You don't want to grow faster than you can. But your ideas to grows fast and take care of as many people as you possibly can. That's why if you have a 100 T note at 500,000, then you get to get 1.25 quintillion per quarter. How are you going to spend 1.25 quintillion per quarter, you've got to expand and expand and expand the money's there to do the expansion. But it's up to you. You'll find the qualified people to do the work for you. Because that is a promise that has been given to us. Not all humanitarians will be getting the money in the beginning. But all people who get money in the beginning will be vetted humanitarians. And you're going to be using other humanitarians who did not have the opportunity to get the money, is that make them any worse? No. The reality is, is that they were they are going to be the ones doing the work, we're just going to have the money to hire them and oversee the use of the money for the appropriate things. R Ron Giles 37:40

It's more like the benefactors looking for the people. If there's I don't know how to say there's a factor over there.

It's for privacy. I didn't finish because I'm trying to just take one piece of each question. It says to keep the Benefactor identities private, not known to the public being in the document will be difficult to keep the Benefactor private.

R Ron Giles 38:05

You do under you do things under a trust, or something of that nature, if you want to do it that way. So that you never use in your own name, and cannot be identified. There's ways around all of the problems that are created by being not maintaining your anonymity. So find the best ways to do that. I think trusts are a really good thing. Moving forward anyway. And so you set the CAC program under a trust, who's the trustee? Who's one in charge? It's the you can you can say, well, I'm in charge of a trust, and this is my job. And there's all kinds of ways to do

that. To accommodate your anonymity. And not have to, and you might put your, your signature on a document, but there's no way for them to track it back to you and who you personally are. You just have a job to do and you're doing a job.

T Tracee 39:10

And couldn't you just have your director handle it? So you're not involved in that?

R Ron Giles 39:15

Yeah, that could be the best way. One of the better ways to do it. Yes. Okay, and then you don't they don't want to paint a target on your director, but because they're always working for somebody else, I don't make the decisions. I have people that I have to account to for the decisions that I make. And some I can make and without getting permission and others that I have to go back and discuss what when I'm going to use the money for like a banker. I can only loan so much money, my paygrade and that's a huge loan or something like that. You have other people are very involved. There's a structure that's already there, and we just have to figure out what it is plug into that. And the anonymity is all going to be there if we do it properly. And again, as is always the case, you will have a counselor, a representative from the Alliance to be sure that you're getting the right information and making the right decisions, although you'll get counsel, and then the decisions that you make are yours, and you don't have to go out do what you feel is right. But you'll get the input. That's what the counselors for. Next question.

We don't need to do a credit check to qualify beneficiaries as real estate buyers anymore, is this correct?

R Ron Giles 40:43

Absolutely correct. You don't need to know what a person's credit is. Because in the bottom line who is paying for that house, you're gonna download more money into the beneficiary's account, and then you'll take it out as a payment on a monthly basis. You don't care what their credit is. Because you're paying, you're giving them the money to pay back the house. Pay back the loan that's on the house, when it's finished in the house will be there. And you paid for it. benefactor has paid for it by downloading the sheer amount of money to pay for it. It'll never be foreclosed on, because you'll never miss skip a payment period. Next question.

What if a beneficiary becomes a drug addict and uses all his RSS money into buying drugs? Would he lose his home?

R

Ron Giles 41:45

Who would be there to tell him that he's losing his home? Now, we're not the police. We're not the drug addict, take trying to find the drug addicts and take them away and do all kinds of stuff to limit their abilities. The old system creates this garbage in people's minds where they have no hope. That leads to the use of misuse of drugs, we're going to have med beds that will take care of those kinds of problems anyway. So you do not have to worry about that. They get the money to get the rehabilitation, they always have money coming in so they don't lose faith. They get the help that they need. And then they begin a new life because they still have money coming in. There is a solution to the problems, all of the problems. My perspective, with the setup that the alliance is doing for this golden age of mankind. We might not even have drugs available to do all of that garbage stuff with you think that the qf s and will support any kind of drug dealings, illegal drugging or abusing, I don't think so. However, we'll see how it all works out. But I'm looking for the the person to connect with who they are and find out who they are. And in that process, their lives will change. So all of the old garbage, and all of the meanness and everything associated with it is going to go away because that those kinds of people, and those ideas that people hold that if they hold those kinds of ideas, they're not ascending into the higher dimensions, they will not be taken, they will not be dragged, screaming and yelling, because I don't want to go into fifth dimension, they don't have drugs there. There's none of that sort of stuff going to take place. There be a movement towards people moving into the fifth dimension, this is what it's all about. This is the fun part about what we're doing. I don't see a problem with it too. If there's a problem with somebody, you counsel with them, you find out what the problem is what the core of the problem is, and you work with them. You're, you're asking about things, there are bad brokers, I suppose are crooked people, and so forth,

they'll be eliminated at our system. They'll go to where they feel that they can have a life that's suited for them instead of the higher light that we're creating. Again, I think that's a projection that is not be relevant. Next question.

What would you do? It doesn't matter to me, if one person gets a, if a broker is showing, and he gets a listing and the sales commissions, both of them? Why would we want to make a change in what that person receives? Is there a reason for that? Do we not have enough money to do that? Is there a reason that we won't want him to have the higher commissions that he is, is appropriate for him to have as a licensed broker? Now let's take a little different approach to things because we have the money to do. And if these people are doing a real good job for us, and we pay them and we pay them well, is there a problem with somebody making a million dollars a month through our programs? I don't think so. I think a million dollars of a person is somebody who has really gone out and spread the money around, uses a bonus programs, the NRELS uses all of these things that are given and we don't have a reason in my mind. We don't have a reason. And I think it's inappropriate to try and restrict those people and not give them the full amount. So you're, again you're it's your it's your business, it's your stewardship.

Nobody's can be looking over his shoulder. If you have an upset broker because you've shorted the amount his commission's, why did you do that? Why would you do that? Why not give him a bonus for the things that he's doing? We're working with money. And we're motivating people to go out and, and make money through our programs. Why would we ever want to short them? It's all there for us. But let's be sure we understand where this ship is going to. It's not going over there where the Cabal used to be. It's going away from that. Next question.

So each of them will get their commission that's due to them. A buying are less let's put this way. I'll ask you this question. How many pennies? Is there available in a \$250,000? Home? For the listing agents, their listing broker, an agent and the selling broker an agent? How many how much money is involved in it? The short answer would be five. Business four times five is 20 cents. That goes up to 200 over 250, which would be you know and below 500,000, then they get an additional five cents for each one that's involved. So that level, then you're talking about, instead of 20 cents, you're talking about 40 cents that's shared between the people and the commission structure. So it just depends on who gets the credit for it, the listing, if it's a brokerage, and the brokers has two agents, so they're working together and they get paid one of the selling one a listing, everything worked out just beautifully. No fighting though in trading, no problems. Just just part of just starting the work. Buying and selling are the buyers and the sellers and the Commission structures. Next question.

Can somebody purchase outside of the if they have the money there? They spend their money where they want? I'm not sure where that question comes from? I'm not sure where there is a question involved. Can people spend the money they want? Yes, they take up the money to buy and sell all they want, go out and buy and sell. Make your profits out there. But don't try and make profit with our NRELS, beyond what is available. We're not looking for real estate gurus to come in and start making money off of it. This is for the normal person, person on the street, you're, if you're a real estate investor, and that's your business, we have no business getting in his business. We just give him an opportunity to buy a house here. And that's and that's the way it's bought. And he can do one of those every five years. So if they pay the loan off. Otherwise, it goes for 15 years, and then they still get the download that they've already got or that they're getting to pay it off. It's it's a different way of looking at things and I appreciate the fact that it's new. We are gaining the abundance mentality. And we are sharing it with everybody that we work with. People who deal with a Zim benefactor will be making tremendous amount of money. And we have no reason to restrict them or to hold them back. Let them fly. It's only getting more people into the program and sharing more people with who are getting money. It's a success story for everybody. And and there's no reason for us to really restrict or not allow things to take their natural course. Because humans will do that they take the natural course and create things, and they'll, they'll be some very clever people. We just don't want them to take advantage of us. But they're able to do things the appropriate way and work on their bonuses and so forth. Give them every blessing that I can. I think that that's where we're headed. The abundance mentality, we have to have, as in benefactors, have to know that we are abundant. And there's never a shortage of money for us to do the things that we want to do. Is it fair for them to have a million dollars a month? Yeah, I think so. They've earned it. But what about to me, I don't care.
