Yes, we have an update. It's not an update, we don't know. But when the RV takes place, we'll get our money. And then it will just be as soon as we can possibly put the RSS platform together before we launch. I'm my understanding is it's already being put together in the quantum consciousness for us by the Alliance. And but it's going to take the finalizing of us making decisions on what pictures to use and what this that the other and we need to finalize things. So other than that, it's not going to take much time to roll out after the RV takes place, when there's no date on that. By the way, the Alliance doesn't give dates, unless they are military deception. So even if you're getting your information from the Alliance, if it's a date, it's only a military deception. Is this the correct procedure? Do I simply set up another QFS account to act as my bond account?

Yes, that's correct. And understand that the extra money that you might put into your master account to fund your activities in the RSS and the CAC is fine. And some people are going to put in, you know, five Quintilion or whatever, in that motherload or in that master account, but it's yours. And it's it's your responsibility to fund that account. So however you do, it is up to you. Yes, you're right on as far as your bond accounts and so forth. The next question.

You will have access to the quantum financial system yourself, it'll be a personal thing. And you can you can transfer money, it's an account to account transfer initiated by you. Just so simple. It's just like mobile banking is now that easy. Next question.

In the case of death of a benefactor or beneficiary, how does next of kin advise the upline of the death of that individual so that funds can be diverted to the next of kin?

R Ron Giles 05:40

The beneficiary, or the Benefactor knows their responsibility. If they are approaching time, when they may pass away, they need to make the the necessary arrangements so that somebody can have the pin numbers and the codes and so forth to get into their accounts. Love won society won't be involved in any of those kinds of things. The program is automatic, it will continue. So it's up to the beneficiary and the benefactor to take care of their next of kin and how they wanted to. It's like a wheel, everybody has to have a wheel. And if you, you know, with the med beds, we might not have that for a long time. But let's take into consideration the possibility of that taking place, but it's your responsibility. It's not love won society, and nobody above love won society or above is interested in those problems. We just download the money into the accounts, and you do with it, which you need to with your next pin so forth. Next question.

Yes. And, and there's nobody that's going to concern themselves with it. Because it's all private. Period. There's no governments involved nothing of that nobody's looking over the shoulder. Once the QFS is in place, you have complete anonymity and complete control. And nobody, not even the quantum financial system will get into your account. Unless you're doing something that's inappropriate, and you might have some problems and your account being frozen for a while. Or something of this nature. We'll see how that's gonna work out. Or does that payment go directly to the owners QFS account? Do I keep on paying him double his last year's income for each of the seven years.

The point you're you're doing now you're setting up an account for him a download. You figure out what his two year or his last five years, if you have five years if he said whatever it is, but you're going to double what he's making. Just figure it out. And, and that's, that's in the download, there's no one time shot and less. That's what you want to do. And there's no problem with that. You just transfer some money to an account that he's got and the way it goes. But as far as the download is concerned, this is where we're looking for a person to double our income every year continues on. And we're doubling that as far as the download is concerned, but he's still in business for himself. And what he gets from his business is still his, we're just paying him double what he's already making. So he continues in business to make money and it's, was that make it three times as much? We all have, it's my intention is to have reports that they can go to as the having a master ID account. Yes, we can take care of some of those things for them. And I think it's very important to know how much money you're spending, how much gone through. So we'll do that. It'll be a report that will be almost like a tabulation on your, in your personal office that you can just go and look at. And it'd be a running total rather than monthly or weekly or it's it's just the it balances immediately. So in the QFS, so it'll be available for us and we'll, we'll do those reports. Next question.

I am a benefactor. In this scenario, I have hired a director who in turns, hires an assistant director and gives him a bonus, who has the controller responsibility to upgrade the permanent payout of the assistant director.

That would be the director himself. The director who hires the director has the responsibility and has the PIN codes and everything to get into the revenue sharing solutions platform and make changes there. I don't know that it would be wise to have a assistant directors been given that those PIN codes to get into it for themselves. So it's a director's responsibility. Even one director can have 20 or 30, assistant directors depending on what their job or what their, their location and the things that they're trying to serve us in the in their community. But this director, because it is becoming a very, very pivotal position, not only in the CAC program, but in the communities that they serve, they'll have a lot of hats, they're wearing a lot of people that they can be involved with. It all depends on how you if you understand the program, then use it properly. You know, it's like shifting gears in a car, if you know how to do it, then you don't leave your push your collection

before you change gears. Those are the kinds of things that would be necessary for you to understand. And when you get into it, you will and you'll, you'll figure out the best way to accommodate your personality in the things that you do. Those are things that are your responsibility and do things the way you're the one that's in charge to your money. They like to give you the money to do your stuff. It's an interesting question. And I'll go back to what I've normally say, when people ask if I can do this, or something, I can do something. Very seldom is there any directions that are going to come from love won society, you are the one that's in charge. So it's, it's the way you want to do it, you want to do drug addictions. Now, there's an awful lot of assumptions out there, about homeless, being drug addicts, and mentally ill and all that sort of stuff. That may be true. But if you use that as a way to judge them, or give them a class of drug dealers, and all that sort of stuff, I'm not sure that that's where you want to come from. So I would avoid putting labels like that, and assumptions that everybody fits into that label. Each individual is needs to be dealt with appropriately on their own basis, that having drug problems, then does that stop them from having an account? I don't think so. Is it you're giving them money to to keep their drugs going? Possibly so that a person gets into drugs for a particular reason that is built into the society and into the economy, the way that the cabal has done it. When you get rid of all of the garbage, then you're giving hope to people. And one of the biggest problems that they have was hopelessness. They get into drugs as a way to get away from all of the problems. But if there's no problems there and they don't like the drugs, they don't like what they're doing. They have an income to be able to go get the help they need. Now, keep in mind med beds will take care of these kinds of things. Global Currency Reset. You really think it's happened? You're confusing the revaluation with the reset. The Global Currency Reset is resetting all currencies on par value with all other currencies. So a pound is worth \$1 Yuan is worth a pound and a liras worth whatever it is within relationship to other. So the cue Fs does not have the is not programmed with the capacity to make changes in the difference between currencies, values as it presently exists, you go to the Forex you see all these differences, well in the Global Currency Reset, that will all be done away with and everybody will be on the same value. Now, the Global Currency Reset has to happen before the RV takes place. So I'm really wondering if all of these people who are promoting these things are accurate? I don't believe they are. It's a when we get into the exchange of currencies, which is different from the redemption of them, then those that has its own venue and has its own way of dealing with things. And for us, let them do what they're going to do. I'm not concerned about it. However, I am concerned about Zim. In the country of Zimbabwe, they had tried to establish a new currency. And that's theirs them dollars. They're not bonds. A bond is a contract of value. And they say, you know, I have here a bond that says pay to the order on air bearer on demand \$100 trillion. Zimbabwe doesn't have \$100 trillion in their entire economy. So the fraudulent aspect of this was noted by all other currencies or all other countries and put Zimbabwe sanctioned Zimbabwe and put them under very strict control. And only humanitarians will be able to redeem Zim bonds, period. You're not a deathbed humanitarian, you won't get a dime from that source. Think about that. Only those who are going to be doing the humanitarian work for the Alliance will get the money to do so. All the others who cares about the currencies, when I say who cares? You may make quite a mountain of money or a rate of return on on your investment in the currencies. But we're not talking about 100 trillion Pinot, at \$500,000 far outweighs anything that you can get from any of the redemption of or the exchange of currencies. So you're playing in two different fields there we happen to be on the right side of that. Very little that is associated with life as it is now as far as taxes are concerned. There's no income tax, there's only sales tax. How the how the government see now they're talking about 14% tax, and others are talking about 17% tax. My understanding and my belief is that 14 is for the federal and 3% is going to the state to be shared with the the state the cities and the counties. And then that's going to run the government but the way that things are now and the size of the government is going to be drastically reduced. You're not going to be paying income tax. And the ownership of property is the basis upon which they charge you acts on your homes, when we change to the Sharia compliance, all of the garbage that says that the land belongs to the government is wrong and will not survive. You cannot tax a, okay, there's ownership that the cabal has done there you, they own it, and you just get to pay tax on it. And that means you can live there. The government does not have the right to do that they do not own property. Colonial a loyal excuse me, a loyal title is what is going to be coming around. We build the roads, we build the bridges, we build the the sewer system for a city that's expanding into a new area. And we we help set that up so that the people, the investors or builders, or homes and so forth, can come in and start building the homes that we're going to need because there's a lot of people that are homeless now that are going to be first time homebuyers in our NRELS program. That needs a lot of building a lot of homes. So things are going to be changing. Allow for those changes to take place in your mind. And then look into your mind and say, I wonder how I fit into all of that. What's going to happen? Study GESARA, NESARA if you want to call it study these things, become familiar with it, because that's the newness of life that we're moving into. And we won't be dragging all of this garbage with us into the New Earth. Nobody owns the New Earth. no government, no Cabal, none of that. I want to be appropriate here. This crap is okay. I think there are no taxes on Vietnamese Dong or Iraqi dinar or anything else. Okay. However, one 100 keynote at \$500,000 per sim gives you a 1.25 quintillion every quarter, for 100 years, if that's what you choose. So you're gonna have a lot more money than you really know what to do with. You'll find ways and ways will come up that you never thought about. That's what I'm anticipating and being prepared for in the future for things that we don't know that's coming. So that's why a heart will give us a rate. That's why our heart will help us to know if we need more Zim. The reason that the heart is so important, we have a pea brain in third dimension, everything goes through a pea brain. Absolutely not the only time that you're going to run out of money. Even better put this in perspective. If you as Zim benefactor, enrolled 7.7 billion people which like everybody in the world, and each one of them had the beneficiary count plus six trusts. That's Like somewhere around 300 and some odd 1000 per per year. And you give 7.7 billion, that 300, whatever 1000 per year, you divide that into just one, just one quarterly payment of 1.25 quintillion. That's just one quarter and you're paying a whole year worth to these seven and a half billion people or whenever there would be about 60%, or excuse me about 40% of that quarterly payment left after you paid for all of those people for one full year. So can you see how, in my opinion, and I don't mean to, it's silly to think that you're not going to have all the money you need to do everything. That's just one person 505,500 People worth to join and do the same thing. You're going to have a hard time as we know it now, how to get rid of that kind of money. I don't know. It all depends on the kind of humanitarian stuff you want to do. If you look around your neighborhood, or things you'll find a single moms, dog rescues the volunteers, the first responders, all of that sort of stuff. Yes, they're there. But once you've taken care of all of

them, what are you going to do? If you don't want to do anything else, and don't get the larger rates, because you won't need to put things in the proper perspective and do what you want to do as a humanitarian, you're not buying yourself a job that you're feeling uncomfortable with. I'm just trying to where's the question is how are we to activate our accounts but you activate the account by depositing money into them. That's how it works.
