Good morning humanitarians. This is Ron Giles. And I'm here with Tracee, we're going to do a general question and answer. #### Tracee 01:32

So first question well as in benefactor, be able to add to the principal amount later. 50 quintillion is such an astronomical amount that one can find it difficult to calculate whether it be sufficient to cover all RSS, CAC and NRELS, current and in the future. So the question is, can they add to the principal amount later?



#### Ron Giles 01:52

No, you have a transaction, you take your gym, you have an appointment, you get your gym, redeemed, if you have the others, they can throw that in there as well, other currencies, they can throw that in as well. This is a one time shot. The amount of money that is we're talking about here, in terms of the structured payout has to be done at this appointment. I don't know if this is a steadfast rule, but do not withhold right now plan for the whole 100 years to get all

the money that you need. So yes, it is in us astronomical amount of money. And it's hard for us to wrap our minds around that. But we don't need to wrap our minds around it, we just know that there's plenty of zeros there. And those zeros are opportunities to serve. So even though your mind doesn't wrap around it, don't be afraid of it. It's not a problem, the alliance is willing to give it to us. Just because it's a lot of money doesn't mean that we can't have it. A lot of money is needed for what we're trying to accomplish. So let's not short ourselves in the beginning, because you'll be short the next 100 years. And less they make some changes, those changes may come and they may not I do not know. But I'm not gonna sit around and wait for them to make changes so that we can get more money in the future. Next question, being given

#### Ron Giles 03:52

I'm going to say that the bookkeeping is you need to be in charge of your own book. As far as the RSS platform and those things, we will have reports that you can will generate from the information that we have. But we won't have anything have anything to do with your CAC and that sort of thing. Because we don't know where that money is going once it's once it's just set up on the RSS as a download. We don't keep track of that. There may be some ways to do that. But it is your responsibility to do your bookkeeping. For your management purposes. I'm saying it's your management, your purpose. So bookkeeping is a good way to manage things properly. Next question.

Well, it will, there will be a certain amount of it that, you know, is it an RSS or is it a CAC or is it an NRELS program? The computer will have no idea Yeah, it's just a download. You're the one that's in charge of the downloads. And so if they want to keep track of them fine. If they don't, I think that it's important that directors have their own CAC have their own accounts, bookkeeping accounts, and QFS, or whatever other way they want to do it. I plan on they're cool. If you want to give money to your director, you put it in his account in the QFS. The way to do

#### Ron Giles 05:49

It's a fair question. The qualifications for an RSS program. Very, very, the qualifications are very small few. The biggest thing is to get the money that you need to be an RSS to get qualified to be in the RSS program. In other words, you're creating a liability, are you going to be able to fulfill that responsibility? And that's why we're asking the for you to get a letter from the app the appointment indicating that you have sufficient funds to do the RSS program. They know that, and we're asking them to the Alliance to provide us with that, as part of the applications for people who want to become Zim benefactors in the RSS program, what are the qualifications, you know, if you're a humanitarian, then you'll get your funds from the appointment. That's the qualification that you need right there to become a humanitarian to become a RSS participant. So those are the only real qualifications that I'm thinking of at the present time course you got to have a brain on your shoulders and functioning as a human. So other than that, financial is the biggest qualification. And we're going to get that information referral through the RSS, or through your redemption appointment from your alliance agent. Next question,

#### Tracee 07:25

well, this or similar training continues to take place once the QFS is initiated. If needed, I am a Zim holder and I am planning big things as I was told my teenage son who is 16, should we buy him Zim in addition to mine? If so, does it matter what value we purchased for him.

#### Ron Giles 07:48

I would do everything and let your son be a part of your program. Don't buy things specifically for them. They, you don't know what their life is going to be like, don't give them Zim. Just let them be a part of your program. When they mature, they'll they'll seek their level of humanitarian activities that they feel comfortable with. And you'll have plenty of money take care of them, then fact that's a real good thing for your son to be as part of your program. Next question.

#### Tracee 08:18

I heard you say as a benefactor, it is not good to make money with the money we receive. I understand that since our job is to spread my money to other people. With that said, What do I do if I'm a realtor, and I start to buy and sell houses for the NRELS program alongside my CAC program? Is it considered a conflict of interest? Or should I have some other realtors do the work?

Ron Giles 08:43

Well, it all depends on how big you want to be. If you're, you're the, you're the managing director of the money, you're the one that's got the money, you hire people to do the work. If you're out there doing the work yourself. Then you're down in the ditches, trying to get things done, instead of being up above where you can see what's going on. So pick where at what level you want to be at, and then start doing your program from there. If you're in charge of 25 cities, and you've got 50 brokers that are working there for you, you can't you can't micromanage anything. And you can't be going out there and doing the things that you've always done before because you're the one that has to see to over see the overview of all of it and manage your people accordingly. Let them get out there and find the houses and they'll do the buying and and bringing the properties into the NRELS. And then through the the other programs that we've got, we provide the buyers for those. So it's it'll work much better if you let them do their job and you do your job. job, you're the manager, not the one that's doing the work. And if you don't like it that way, then then you can get in and do the work and let somebody else manage it, it's up to you. So, catch a different vision and be an expert in your field, but you don't have to be down in the, in the trenches doing all the work. Next question.

#### Tracee 10:29

Yeah, you know, let me just share something. So one of my friend, my friend that I've told you about Ron Karen, we are basically going to she, she lives in a certain city, and I live in a certain city, and there's like a small community in between, that actually I live in. But anyways, we're going to share responsibilities to set up CAC in the adjacent cities. And we're going to create a system or a template, if you will. So then once it's all up and running, and we have a good system, we're going to go and, you know, go on the other directions of those and keep popping up CAC, CAC. But the first ones are, we're going to work together on so that we can create an easy system that we can follow in the other areas. So we're not going to be the boots on the ground doing the NRELS, even though she's a broker, but we're going to actually just get people in those positions, because why would we want to pay ourselves for work? We are going to have plenty of money.

Yes, for sure. And I think that collaboration is a really good thing. As long as you collaborate after you have your funds.

Well, we're friends now. So we're dreaming together.



#### Ron Giles 11:39

but funds collaborate after you have the funds, not after your friends. So do you understand what I'm saying? Yeah. Some people are saying, well, let's, let's waltz and dance on and together and go through the redemption appointment. And then we'll have money, we can do what we want to do. And I'm saying no, don't do it that way. You take your exam, she takes her exam, go into the appointment, get your money, and then collaborate and have some fun, but you need to be in charge of your own stewardship, instead of jointly with somebody else who's going to be the boss who's going to be you've got to, and some people will try and control others. And the best way to do that to eliminate all that kind of problems, just have your own money. That's my point of view.

Yeah, we're not gonna go to the redemption together, and we have separate binders and everything. So Okay, next question on and on NRELS program, my understanding is that the buyer will be put on the RSS download, and once the mortgage amount is set up, the download will increase to cover the mortgage amount is that all inclusive of principal interest tax and insurance and HOA fees. Since if you are delinquent on HOA, the homes can be foreclosed on

You can set that up the way you need to, you know, I don't know, taxes, I don't know if I'm not gonna be charging interest on my loans. But that I put up there. So there won't be any interest, no tax insurance. I don't believe in insurance, why pay insurance policies, when we can just buy the, if something happens, we just, we've just paid for it. That's just in our cash flow. That's where it's well, and then the homeowners fees, those are things you have to deal with yourself, and you just work out the best way to do it. But there's nothing that I can say that would work for every location or every situation. So you got to manage this manage the spot, let's call it that way. Manage the spot when you get to it. #### Tracee 13:47

If the house is basically paid for by the program, what price limitations will buyers have on the houses? Can anybody buy a \$5 million house for free?

#### Ron Giles 13:57

That's a good question. And it can be a problem. We've tried to eliminate that to a down payment, you know, a \$5 million home is gonna take a lot more money for the down payment. But then on the other hand, the amount of money they're getting from the RSS program means that they should be able to get the 10% of a \$5 million home in a fairly short period of time. It's a it can be a problem, but we I'm looking at in my mind, if the if there's people that want to have a \$5 million home and they've never lived to have a home of their own, then that's that's not going to work. Because you're you're in over your head. You know, if you're used to driving a little scooter around and all of a sudden you get a super dragster. It's not the same way. It's not the same venue for you. You need to do something that's more along the lines of a first owner needs to learn had to have a home before they start moving into a million dollar homes. This is a philosophical sort of thing. I look at the the downpayment as a determining factor. And then the real problem is going to control a lot of, of the homes that people buy, especially for first timers, encourage them to get into something that is reasonable and something that they can handle. But it's a good question, as it's worth list is worth the thought process was to kind

of determine where there could be some problems, and then perhaps try and solve those problems before you get to them. But the thought processes are valid. So I don't know how to say it from there. But people want a \$5 million home, if they can get it, then they can get it. Very. Next question.

But we have technologies that are coming out, we really don't know. Some people say that we're not going to have money in the future. I don't believe that's true. But they have their opinions. #### Ron Giles 17:40

I don't I've not heard that. I don't believe that that's true. We can justify it. But it's on a need basis. And I'm not going to try and take over. Just because I'm a humanitarian, I'm gonna take over somebody's dead spot that's dying. It's all going to be on a priority basis. And I don't believe that humanitarians deserve a priority position, even though there's a lot resting on us. It allow it allow them appropriately and fair. Will there be a way at our redemption meeting to ask for guidance in in person hands on training to make sure things are clear?

#### Ron Giles 18:31

You talk to you to establish your own relationship with your alliance agent that's up to you

#### Tracee 18:37

A lady called Sky princess. She's in regular contact with the Alliance. And they have stated that very few private healing centers will have access to med beds, they're controlled by the US military. And it might be quite some time before any private healing centers will be allowed to use med beds. Do you have any insight or information about this?



#### Ron Giles 18:56

I agree with her. I don't think that it's wise to be setting up stuff to do us med beds at this present time, because it's going to be controlled by the military with priorities that are not in that list of priorities are not available to us now. So those that's all speculation, but I agree with her, the military will be in charge. We'll go from there. What happens will happen?



#### Tracee 19:23

Can you give an example of where we would not provide funding to a person or organization?



No, it's none of my business.



#### Tracee 19:35

I know we can pay the directors whatever salary we choose, is there a benchmark set to give us an idea of a starting salary?

#### Ron Giles 19:42

It's a good question. I think that there's a combination of benefits we'll call it benefit. Director is going to be in a position to sign a number of people register to register on the RSS program just as a part of their business Now, if you give them that bonus, or that person then and sign it up under their ID, under the directors ID, then they get, that's part of their bonus program. Now, as a, as a director, they're going to have that so you give them a nice salary, but you're giving them an opportunity to create, you know, could be up to a million dollars a month with the use of the, the program the way it is, I don't know. But I think it's, it's a benefit package that you're looking at, and give them the opportunity and incentive to go out and really do a good job with getting people in, you might want to every two contracts, business contracts, you'd give them another penny as a bonus, or five contracts to get, or they get a bonus, if they get five in a



week or something like this. Workout, something size, just a salary kind of concept. And that will give them an ownership position in what they're trying to accomplish. And you'll find that they'll be much more involved in their work, rather than just going to work and pushing pencils around on your desk, and so forth. That way, they get out and get the job done. And when they're doing that, then they're effectively helping the community. So that's what directors should be doing. And I would, I would find those incentive marks that you want, and structure, what you how you're going to pay them to realize that there's an incentive for the things that you're trying to accomplish. And then do your bonuses and all that sort of stuff as a result of their, of what they do. So let's just say there's plenty of ways to pay people and benefits packages, what you're looking for, and leave it open for them to be in a position to grow from CAC in a certain area to maybe there's some of their assistants becoming directors and they move up in a in a higher position. There's all that kind of upward movement that's associated with those who are doing a real good job. And if they're doing a really good job, let's pay them really good. That's my opinion. Next question.

You mentioned we will work alongside government officials, would we have any of these government entities under employment contracts as well? Would CAC eventually replace local governments? Could we set up the relationship with say, a city or town to come to us for some needs, as opposed to taxing the residents?

# Ron Giles 22:41

I think the transition is the word that will describe what takes place. Because if we have a country that is just are compliant means that the sub governmental, like a state or a county or a city would have their own structures that need to be trimmed down because you're not going to get taxed anymore. And so we take over some of those responsibilities. Will I offer a police officer a contract, an ECS, plumber contract there? Is there anything to stop from doing that? I don't think that there is they're humans, they're doing a job. All government people are humans doing service for what they get paid for, for the community. But all of that, not all of that much of that will change as we translate or transfer from a system that's based on taxing to get things done, to where the local people like us have the money to get the things done, that the government will never have. So how are they how are they going to govern? And how are we going to assist them to govern? Because is we the people now that are starting to pay for everything instead of the government's and the government agencies and their clones, clowns, whatever you want to call them. We're changing things the way that we do business, as far as government and as far as we the people, because we the people are taking our rightful positions as ones who are creating a stewardship responsibility for where we live. We've given that responsibility to the Cabal, and we're taking it back because they they screwed it all up. They messed it up. They had the chance. They're finished, they're out, fired, delete, whatever you want to call it. And that's the way I look at it. So yes, we'll, we'll be working with a transition. The government officials have responsibilities, and we want to be sure that those responsibilities are transferred in a way that will instead of paying the local police He put them on employment contracts. And they're they can be administered through their organizations and so forth, or whether they are they normally are. But we can pay them and put them on the contracts. And, and, and we're the ones that buffer the problems that are associated with her. We also will get involved in the budgets of police departments and fire departments to ensure

that they get what they need. And because there's no taxes, it's going to pay for a lot of that stuff. Is Hall going away. So we're the ones that are in charge. So I see the CAC program and directors almost becoming part of the government or the government becoming part of us, whichever way you want to look at it. Because we have the money.

#### Tracee 25:51

How does all of this play out with our sovereignty? I've been going through the process of correcting my status, we have been operating as the straw man, once QFS is activated, will this grant automatic sovereignty?

#### Ron Giles 26:04

That's a good question. And I don't know the answer to that. I just know that under the new laws of the under, we're getting rid of the Cabal, straw man were created by the Cabal to control us. So it was the baby birth certificates and the footprints and all the the soul and all that sort of garbage that they created, all of that is going away. So how do we work with a transition into something that's entirely different than that? It's going to be interesting to see how it works out. So what is the sovereign, you know, the only way a sovereign take your saying, Will this grant automatic sovereignty? No. And the reason I say that is, you are a sovereign. You're born sovereign. And now you're just claiming what is really yours anyway. They don't grant me sovereignty at all. We, the people are the ones in charge now. And if they don't like the way that we the people are running things, and they can go find another planet to infest their garbage with. So things are changing. And I understand where you're coming from, but I want you to understand that you are the sovereign, regardless of what those sob shoreline shoreline brains, okay, have done to us. So we're taking charge. And nobody's going to grant me I am sovereign. That's the way I look at it.

that's right. How do you address a husband and wife who should be CAC directors?

#### Ron Giles 27:52

That's an interesting word. If you want them to be CAC directors, then hire them to do that. Train them and let them do their work. They want to work together. You know, this, people say, don't have husband and wives and family working together because they, they will start creating stuff for themselves inter tasting with each other and creating something that's perhaps is not appropriate. There's all kinds of things that can happen with that. So be careful of it. There's reasons why those kinds of things don't hire family are in place, make her director CAC director have a husband over here and then another one for a different location over there. It's just be wise. You'll have a counselor to advise you on these things. So be sure that you're using your advisor as you go through and then ask him those kinds of questions or her those kinds of questions, and I think you'll be in fine shape. Next question.



#### Tracee 28:54

Well, precious metals such as gold and silver be exchanged at our redemption appointment. No. Okay, on Ron's q&a dated August 29. First question was from a humanitarian, this entity had money invested with a wealth management company. Ron's answer was fire them, get rid of them. The QFS isn't like these people since my retirement, I have my money with a wealth manager. Where do I park my money if I fire them? This is where I'm confused before this new LWS people invested money in the wealth management companies. So on a future q&a, could Ron give us a little bit more clarity on what should be done with these investments, which are fiat money? can't just throw it out?

#### Ron Giles 29:43

Well, it's, I understand that there are people who have enough wealth to have a wealth manager. I'm not saying that you have to fire them. I'm saying that I do not want a wealth manager as a position or counseling over me and be dropping money with them. And then they're making money. For me, we are our directive as we don't make money with our funds. So what good is manage wealth manager who makes money for people to be involved with us when we cannot make money using our phones. So we're, how do we interface with them, I don't know, if you've got your money invested with somebody and you become Zim benefactor, I'm not telling you that you have to change your whole life, from your what's your wealth has already been created, but you just don't make money with the new money. So there's a transition there. Your money is going to be put into quantum Financial System System anyway, in your account. Now, they're not going to have maybe you'll give them an accountant in the QFS, and they can manage the money for you. But in reality, that whole system of making money on other people's money is going away. What are they going to invest in with? There's no stock? How are they going to invest your money? Are they going to get out there and start putting money into real estate developments and all this sort of stuff? I don't know. I, I really don't. And I don't really want to know. But if that's your business, then that's your business. It may be that you're going to have to make a decision whether you want to be a wealthy person, or you want to be a Zim benefactor, or managing director in the RSS program, I don't know that there's has to be a line of demarcation, but you're going to be you're going to move towards one way or the other. And a lot of times those who have a lot of money, they all take a certain percentage of their money in use for humanitarian work. And if you've done that, because of your heart, and not done it because of the tax ramifications, then you're gonna have some you can have some changes. Don't change who you are, because that's, then you're trying to be a fraud to people, that's not going to work either. So be who you are humanitarians who will rise to the humanitarian top, and then they'll be doing some marvelous things. And of course, when you make a lot of money, then money is not so important to you. And that's what we're all about. So going to be a change. Next question, please.



#### Tracee 32:45

I heard Charlie Ward and David Mahoney talking about registering Zims? Is this something we need to do? No, please confirm if I'm on the right track you FS is only an accrual banking system. And the difference from the Federal Reserve is how it is tracked. And for humanitarian purposes, the oversight of transactions will be by the Alliance, the MD, I don't know what that means, will have a direct line of communication with the managing director of a direct line of communication with this member of the alliance for my understanding of these training videos,

is the community switching to the QFS helps with discovering who is capable of being true humanitarians? What happens to those that are not? And are they given a second chance to prove themselves? I'm referring to a way of forgiveness and patience for those people?

# Ron Giles 33:33

You know, the question that you're the way that you're forming that question means that if you're not a humanitarian, then you're something less than. And that's that's not really the way this is being set up. When you talk about a cruel banking system, it's not a cruel and a cruel banking system. And I'm not sure what that definition is. It's a ledger. It's a simply has, you have accounts that are balanced with each transaction. So the money goes from one account to another, it's all in a transaction. And it's accounted for. That's what the ledger is. So I'm not sure what you're talking about as far as a cruel banking system. The Federal Reserve has really very little to do with what we're going to be doing in the guantum financial system, because you don't make money in the quantum financial system, nor are there fees or charges. So I, all the stuff that you've heard about, as far as banks are concerned, go away, because they're in it to make money on your money. And they won't be around very long because they can't make money on other people's money anymore. That's why they're going bankrupt. That's why that whole system is going back bankrupt. And so the quantum financial system and the quantum consciousness that people are calling the computer has completely taken over the Swift transfer system and taken away the ability to make money on using other people's money. That happens has been happening for the last couple of years 86% of the profits from banking is done with overnight trading. And that's going away, because the quantum consciousness, when the banker sends the money, they send it to their account first and is supposed to be moving on after that. The quantum consciousness takes the money and, and intercepts it from the banking system and sends it to the original or to the person who's going to receive the money. Anyway, it bypasses the whole banking system, and they can't make money. It's been doing that for years. And that's why the banks are trying to do something with crypto and all kinds of other things have stayed relevant, but they're not going to they can't make the money. They're a fat pig. It's over there, there's no food for that fat pig anymore, he's gonna die. That's what the whole system of the central banking system is about is making money on other people's money and putting them into debt slavery, and then not providing enough money so that we can have a real good economy. They manage the economy, like doctors manage diseases, it's going away, won't happen anymore. So I'm not sure how to answer that question. But other than to say it's all gonna change. Next question.

#### Ron Giles 37:10

That is true. I'm going to say it that way. I have done enquired specifically about this. However,

your your the humanitarian, they're interested in you. If you don't have your Sim, talk to the people, show him your receipts, see what they want to do with you. There might be marginal

people that they won't let through. And then other people who are definitely humanitarians, they want them to have the money. See, it's not the Zim itself. The Zim has no value. So what are they going to do with the Zim when you exchange or when you redeem it with them, they'll just throw it away. They may even offer it back to you or not, if you ask for, they may just give it back to you. Because it's it's useless to anybody else, because they already know that it's been the Alliance knows it's already been redeemed. So keep in mind that it's the person and not the process. That's the important thing, the humanitarian is the goal. Giving them the money to do the things that they're going to do is the goal. That's what this whole process is about the redemption process. And the Zim and all that is just the vehicle to get the money into the hands of the right people in an appropriate sort of way. That makes sense. And that can happen so that we can get our money. The big, it's a big project, a big thing that we're they're trying to do so. But you're the most important part of this process. Understand that the humanitarian is on the just right underneath the angel list as far as hierarchy is concerned. That's my opinion. And I believe that I'm substantiated with the fact that the alliance is doing everything they can to help us and train us and make us the best humanitarians we can be so that we can get the job done for humanity. However, walking into the redemption appointment, my humanitarian company won't exist yet. Therefore, it will not be eligible to be used for the second trust to cover this gap post redemption. I'm looking for an established and trusted company to do that. signee as beneficiary until I can get my company legally established, would Ron be open to a short term option allowing me to designate LWS international as my second trust beneficiary? In the event, something happened to me before my company was set up?

# Ron Giles 40:18

Well, you're doing a bunch of what ifs that really don't are not valid. I think you've got some points there that might be of questions. But the questions that you're raising, in my mind are quickly taken care of, I don't know what you feel you need to do to set up a company. The legal stuff is all in a trust, the trust documents, all they need is just the name, the trust, or the trustee that then the beneficiary and the name of the trust, and then you've got the trust. And you can do everything that you could do by setting up a company. So I'm not sure why you'd want to have anything and an interim, when you can just do it all there. You can set up the accounts, you can set up everything you need to accomplish what you're trying to do. Now, remember that when you go through the appointment, your main job there is to get the funds. And then you'll have the opportunity to counsel with the agent there on the best way to set up the and function the way that you would like it to function to support your humanitarian activities as a structure of financial structure. Those are the important piece to look at. And those are all called perfunctory. It's there's a way to do them. And it's just the way that you want to have them done. So I would not overly concern myself with those things that you're concerned with in that regard. So next question.

I listened to the q&a of training, I've heard anyone asked this question that I can recall, what about signing up people who are working in the USA illegally?

#### Ron Giles 42:04

You know that? It's a real good question, I would say that it's illegal, don't do it. It's illegal, don't do it. Yet, they're here in the country illegally, then they need to have, in my opinion, and this is only my opinion, they need to wait to go back to their own country and have the funds necessary to establish, reestablish themselves in their own country. And there's a lot of reasons for that. It's their, it's their home, it's their family, it's their traditions, it's their culture. And I think that there's some richness involved in a culture that is, is a collective or a cohesive group that's together, that have found peace and harmony in that culture. And I think that destroying anything of that nature is not going to be beneficial. People come out of that system, if it's not working for them financially, as well as for safety. If they can't walk down the street without getting raped or, or have the their money stolen from them and their bike, you know, knocked off the bike and the bike stolen from, that's not a good place to live. And I can understand why you would want to leave. But things could change, because all of those bad people are being are going to be rounded up and they will not be infesting their garbage into our new society, because they're not going to be around those with a pure heart can go back to their homes with the blessing of all kinds of money that they need. And so he finds people that can get a green card, if they be here, legally, then he can hire them. And he would much rather have those people. And he knows that they're going to send a lot, if not all of their money back home. And what I'm trying to say is that families are being separated because of financial situations that I don't think are appropriate, right. #### Ron Giles 49:45

The Benefactor has no legal responsibility for beneficiaries. What they do with their money is up to them. They do out and buy drugs and they bought drugs. That's up to the quantum

financial system to worry about benefactors do not worry about that. You're not responsible for other people's actions with the money that you use. Unless you can, you have some way of controlling it. And, frankly, the RSS program has no controls. Then, in fact, her managing director has no control over who gets to be part of the RSS program. It's designed that way. Everybody gets to be part of it.
