The RSS once you sign up is fairly easy to demand itself. Yes, you can go anywhere you want.

This is something that I threw in there for my own personal needs. A proof of funds letter is something that I can take to a real estate agent, and show that person that I have the financial wherewithal to buy that property. And without that proof of funds, he may have a principle that the owner of the home that says I don't want people coming in here just kicking the tires, I want people who are potential buyers walk into my house. If you have a \$10 million house,

you're not going to open that up to anybody that wants to come through. So you do a proof of funds letter requirement that you as an individual who wants to look in my house has the capacity to buy it if indeed you wanted to. But if you have no capacity to buy it, the owner does not want people going into his house and and figuring out what they want to come back and break in and steal. It's just a matter of security. It's a matter of propriety. Really. If you can't buy a house, don't go looking at it unless it's open. But the proof of funds is your ability to go in and say, Hello, I'm looking for this. I'd like to see if this your house here. Well, it's only showing to people who have the money. Well, here's my proof of funds at your ticket into that particular. And is that the only place that proof funds now. proof of income, whatever you want to call it. It's a standard thing. And I'm wondering in my mind why people don't understand what's going on with that. I hope that helps to clarify. And we'll have to take a few more shows. So

So let's not pretend like we know everything just because we drive by a homeless camp and, and, and think we'll just throw some money out there. That's not going to work. As to be a plan approach, or else you're going to destroy continue to destroy the dignity of people just by giving them money. Why not give them a job? to help them do things to earn money? If that's what they want to do. Be wise.

Okay. Yes. The most important aspect about anonymity is the buck doesn't stop with you. Now, what that means is, there's always somebody else that makes a decision. So if somebody looks to you as a director, and you're the one who's making these decisions, if they ask you, well, I'd like a commitment for a \$5.3 million building over here, recreation building. Oh, that's way beyond what I have the capacity so I'll have to get back to you. Even if you're the one that says yes, or no . You have to pretend if that's the right word to use, that you are not the one that makes a decision. If you do that, if you mess up and do that, then that's the sort of thing that gets out that you have money and that's not what you want to do. So we do things differently for the safety and anonymity. See, when you work with your directors, what you can do is up to 500,000, make decisions up to 500,000. If you do something like that at that level, then it'll be in the reports and I'll know what's going on. And I'll see that , or somebody will see that the has authority over you, or if that's the right word to say. But we don't just give grants, we don't just give money, I don't find something unless they have a plan. So much down so much, at this point so much at that point. And then the final, we give them a little money up front, this is the way you, you do contracts with people, and they administer contracts, and you have it all down in writing . And you have inspections, as things are, are being done, the city, the county, whatever, they do inspections, and then when there's certain level of work that's been done, then they they give away another tranche. That's what they call it a crunch. And each time, and then they, so it's all taken care of. And there, you don't have to trust people that way the work is done, then you get more money. That's the best way to do it keeps everybody honest. And then you know for sure that the people you're working with are acting in the best interest of the whole project. You're going to learn how to do all that. Or you're going to find people who can and then you will watch the reports that you you delegate and require accountability for the decisions that they make. That's the that 's a management style that even the heavens do it that way. So they've delegated to us our lives. And we have to be accountable for it. So.

And I'm just working for them as the the lead on the team, or whatever for the community . Because she's worried about. Excellent. Right? So yes, the other thing that I have thought about is that I have a nonprofit that I started even before I knew about all this. And so I started an LLC, that's completely anonymous, in Wyoming, because they have privacy laws there. And what I was going to do is put all of my funds in the LLC private account, and then say that that company is funding my nonprofit and the nonprofit is what's giving to the community. So I've kind of thought about both of those options.

Yeah, and as long as you're a level or two away from the actual giving out of the money, then you can remain anonymous. There's ways to do that. But be sure you can trust the people that you talk to about something, setting something up like this. Never tell anybody how much money you've got. There's no reason to do that. They don't need to know.

Yeah, when I don't know so. Okay, next, what do you think of being a benefactor combined with an assistant director so that there can still be some community connection?

- RG 44:02

Being a benefactor combined with an assistant director, I'm not sure what that means. Whether you're working for yourself as an assistant director now if you use that for anonymity that that can work. So in fact, that perhaps could be a real good way of keeping your anonymity and you work for somebody the director over there and he doesn't ask you, what can we do this, you know, in front of somebody . You can have your meetings and so forth, and you can be the assistant director and be out there in the community . I think that's probably a good idea is more Think about it.

I have never hired anyone before. What do you think would be a good starting employment contracts for a director,

- RG 44:50

there are people who are really good at this. They're out there they're headhunters. They're people are out, trying to trying to find people for Companies that in whatever positions feel, don't employment agencies might be a good place to start. People who work in employment agencies are very good at that sort of thing. That they see somebody like you come along, and you're hiring people to give money away board, they're going to love you, because they can find a lot of people in a short period of time. Especially when you pay them something commensurate with where present, what they're presently doing . So it 's going to be easy to find somebody to do these kinds of work these these kinds of humanitarian work, well, I've hired some people, but it's not that hard to do. Human Resources, have

questions and ways of interviewing, so forth . But always hire somebody else to do the things that you don't like to do. And you can find the right people to do that. And of course, like attracts like, so you can get a lot of people that coming in there that have the same ideas and attitudes that you do. And hopefully, that's humanitarian, and then we get to go into our work and have a lot of fun doing what we're doing and create a lot of energy and a lot of fun. Look at it that way, and you're the one that's in charge of the funds. So it's a fun meters low, then you're not doing a good job, it's high. Tech about

I have purchased them . And I would like to utilize your free system to manage my projects, is there any paperwork I need to fill out with you to start the process, or just wait for the contracts to be written.

- RG 46:45

We just need to have the contracts written. And then once you once you made up your mind, then you sign on the dotted line with the contract, and you're now a gym benefactor. Up until that time, we had a discussion and we thought, well, there's no reason to limit the trainee videos, to just those who have committed. So we're allowing the training videos to be available for anybody. And as they go through and they kind of feel like Well, that sounds like a good idea. I'd love to be part of that, then they can make their their their wishes known to be a zoom benefactor. But the real time is when it's time to sign the contract. Up until then, who can fluctuate and do what you want to do? no commitment. Just because you've committed to be a zoom benefactor doesn't mean you have to there's no legal things there. There's no legal implications by just saying I would like to be one of those. But when this comes time to sign the contract, and that's when you're as in benefactor.

They're still for sale.

As the Zim holder, I have foundations in place to begin empowering communities immediately with over 100 people around the world who are being uplifted as facilitators to change with gifts back to humanity. What support would there be?

I'm not sure of the question . It sounds like you've got some big plans with hundreds of people around the world . Are you planning on becoming a gym benefactor? Because you're talking about as a Zim holder? It sounds to me like you have a foundation.

It sounds like they have a lot of people, but they could just utilize all the different systems of loved one society, you know, just plug in. Right? Yeah,

it's kind of like a plug and play. But you can plug in and play your own tunes, because you're the one that's in charge . So if you use the system and buy contract s, and so forth with us, our platforms, then that's a good thing. And we and I highly recommend that we created this for that purpose. So I'm going to use the revenue sharing for all of the things that I'm going to do as far as paying people and then we have the beneficiary side. There's there's a lot there. What support would there be? We have the platforms, you can use them free. That's good support. And other than that, I'm not sure where you want to go.

Assume I am selected as as in benefactor Is it a condition when setting up a trust to declare the total amount of capital within, within or controlled by the trust Now,

- RG 50:03
Okay, number one, you're not selected as, as in benefactor, there are certain qualifications who will put down saying you, you got the higher rates and so forth . So you know, you have capability of doing stuff, it might just be a proof of funds letter. I don't know yet how that's going to work. But there's an obligation that you commit to as in benefactor. And you have to have the capacity to do that. So somehow we've got to understand and know that you have the capacity to perform. If you take one t note, 100, t note and do the 500,000. There's no, there's no questions, you'll be able to do everything you want to do with revenue sharing, so you'll have the money to do it. those are those are, you know, yeah. I'm not sure how to end that. That's my answer.

With regard to ECS, you mentioned the term full ECS. What constitutes full? And what other levels of shares will there be? that confuses me?

- RG 51:23
Well, I understand the question and sometimes are using the term employment contract shares, that's a contract for employment. Now that application can be at a very high level as like is an automobile . manufacturer, a guy working on the on the assembly line, highly skilled, and we pay him a lot of money, or you can have the ECS, as the owner of the local restaurant, or the local mechanic shop, or something of this nature, the contracts are much different nature than you would then just a simple one. So when I talk about the fall, when I'm talking about the seven years, the free or free health, and so forth, and with a one cent raise every quarter, which is equal to \$400, every quarter raise every quarter, for a month, and those that's the full contract, am I going to do that for an 18 year old kid, that's going to be working in a starting as a mechanic and a mechanic shop . It's up to the owner first, number one. But it's not appropriate to have that kid signed to a seven year contract, where if you just simply want to get out of it, you're

going to lose everything that you've got going into it. So we're not going to put that kind of weight on a young person or somebody who's brand new for the, for the boss, he doesn't know how they're going to work out. So they start paying him with the RSS program, but they can take them off it and say, it's not working out, I need to let you go. Well, then he tells the director who's in charge in working with him, and they adjust the download, we're going to give that person 30 days worth of downloads, as the transition from where he is now to it's almost like unemployment. But at the end of the 30 days, then we'll terminate that the director will terminate that for the, for the owner of the shop, or whatever it is. So that's what we say the flatware they referred to as this fall, and that was probably a poor thing to say, right? And that where I'm looking at a number of different ways. The one that's coming up to my mind now is we'll call it something like a benefactor account that they established for anything they want to do. Whether it's paying their family members, whether it's setting up a trust for firefighters or or police precinct, whatever. The benefactor has the right to do what he wants to do for his money. So we'll call it a benefactor account, instead of a beneficiary account, or whatever. But it doesn't have to be a trust account. We don't worry. It sounds like we're requiring people to put things in their trust and and that's not what really what we wanted.
