The RFS program does not have any conditions except you have to have somebody refer you into the program. Once you're in the program. You can work the program any way you want to and use the money for whatever purposes, that means it's unconditional. When you get into employment contracts, then you want the people to do employment things. When you're saying things like a minimum of 20 hours a week, and so on, so forth. As a condition to receive continuous financial support. When you do an employment contract, then they will have somebody over them who unless it's the business owner, and if they're working for the business owner, then they perform their labors. Under his watchful eye. You're an employee of yours. If we're just doing it, if the employment contract is for the business owner, then it's his responsibility as a business owner to maintain his business, keep it open, and we basically pay him to keep it open. And whenever he gets after that is just cream on his crop or on the top of his game to the coffee, whatever you want to call it. Because we're paying him to stay in business. And his employees get to be on employee contracts instead of employment contracts, employee contracts, where the director of the CAC comes in and helps him to give employee contract for the people that work for him. That's the way it's set up. We have nothing to do with how they do we have nothing to do with supervising them. We just provide the money for the people who are employing them to keep them employed. And I think that there's a real important understanding there to be had. We want them to do their work and we want even the volunteers to do the work. But why do we have to have volunteers, let's just pay them full time job, full time job to help people and give them money and so on and so forth. So, work it out so that it's a effective, and if you see the program in action, you'll be able to see what we're trying to accomplish. Hopefully we'll see that before we get to the point we're actually doing it so that you can make your plans and adjustments in that that way. Next question, please.

They might have to come to me assessments might have to come to the director, the director might have to come to the person who's over them, if there is one, and then it goes back to the benefactor. The Benefactor approves all of the larger grants for particular things. Who's going to administer those grants who's going to administer these contacts? Well, I think that there's people that are capable of doing that. Sometimes you're in the government sometimes they're not but you it's your job to find the best way to do that. We cannot do every thing as loved one society, for every contingency that comes up. That's why humanitarians have to come up to speed. It's like the football player. So the fumble ball, and he jumps on that knee looks over the coach and says, What do I do now with it or pick it up and run to the touchdown? We're looking for people who will not look over at the coach to find out what they should do next. We're looking at people who understand the game that they're working where the things that they're doing, and make the decision and go for it and not be stifled with questions and trying to understand things. This is the level of understanding of the program that you're going to have to achieve in order to fulfill the full measure of your creation as a humanitarian. Because their work is pivotal. Does it matter to us how much we pay them. We want to be reasonable. We want them to be so happy then get up and go to work in the morning. That they just can't wait. And they may stay a little bit longer. We don't want that to cause problems for the family. They want them to be socially engaged in things but we want them to be enjoying the work that they're going to be doing. Working out contracts and things like this and saying how much we're going to pay you we're going to double your income Mr. Business Owner and we're gonna pay all of your employees and then everything that you make as a business is just beyond that. How would you like that? Which one of those bosses those business owners would prove to be an idiot and pass that by? We're making it so easy for these people to really do some really wonderful things in their communities. It'll be fun. It'll be fun to watch. There'll be fun to participate with it.
