

Hello humanitarians today is November, the third Wednesday, November the third 2021. I'm here with Tracy and we're going to do a question and answer period. She's got this big question mark on her forehead. So I suspect this is what we're going to be doing today. So we'll go from there. First question.

Okay. So this is a four part close question that they just want clarification that their understanding is correct. The first one is that you have six accounts, plus an employment contract share, download, plus an nr ELLs download account. When they purchase a home. Is this correct?

That is correct.

Okay, question two. Wouldn't it be worth a lot of money to Yeah, okay, go ahead.

When a home is paid off after 15 years or sooner that beneficiary continues to get the mortgage download?

Yeah, that's correct.

Okay, and then the mortgage is paid off and that person wishes to buy a new house for a higher price than initial mortgage. Do we just top up the download per minute on their original nr ELLs download account?

That's it. That's a good question. It sounds like we would be double dipping. And yet, do I have a problem with that? And I'm not sure I do have a problem with it. But maybe this is one of the details will come out when we finally get things put in stone that we're going to work with. But this is a real good idea to bring this up for thought and consideration. And like I was saying, I'm I'm inclined to give money out is what it seems like from the past is that somebody has been greedy or whatever the important thing is we have the money to do it. Why not do it? Why not put it out to those individuals who want to do this thing these things this way? So it to me it looks like it's gonna it could really be that way. And we'll see how when we get into it, we'll see what the light has to say so far.

Okay. Once a person completes a 15 year employment contract share agreement, Lee and leaves that job claim this job number one and takes a new job calling it job number two, does that person maintain the lifelong download for job number one, and open up a new employment contracts share account for job number two?

Yes, that would be correct. It's like when you retire from the military after 20 years. They don't care if you go and get another job. It's only GM we will so we don't have any problems with that. If they want to still work at the place that they're doing, if it's your own business they want to continue it on. Then the benefits continue. But yeah, I have no problems with having two incomes from one employment contract and has was completed and bringing on another one. There's no problem with that at all. Right.

Next question. In regard to churches and other organizations, will we be dealing with corporations and nonprofits as they are legally set up now? Or will they be different in the 5g quantum consciousness financial system as they are set up in 3d now?

That's a good question. And some of these kinds of things will there'll be decisions to be made maybe all of the information inside in to make the decision. It's like, surely cross

record the old bridge. Well, we don't know that until we take a look at it. And take a look at all that go out there and stand and jump up and down on it. Oh, that'll be okay. So you go across, that's when you make the decision. And until we get to that point, we're just speculating. So understand that there's a lot of questions that we can solve now or begin to solve tell. That may turn out to be different when we finally get to the end product. So we're moving towards that direction. And we'll get there all these details will finally get taken care of. And so these kinds of questions, we just have to kind of put them off for now. Next question.

Assuming you're signing up a church or other organization, and it's a corporate nonprofit who is in charge of signing up this entity, does the person in charge sign up as a beneficiary, and the church is one of their trusts or the church signs up and the person signs up under the church?

Okay, well how would you like to show the law? Who's responsible? If a person if had been a beneficiary wants to just make a job of going to churches and talking to their ministers and and getting their congregations to sign up? We have a three generation payment system first, second, third, and if you get 10 people you get another panning for the first generation second and third. So that means that a person can introduce the the minister, he can sign up and have the church members sign up under him. And you're not, you're not knocking off the person who introduced it to you by going so many deep that it does. There's no incentive to do that. So there's a certain amount of cooperation or else you're cutting off the hand that feeding you in effect, and we don't want that and that's why we have three generations. So seven up, but remind the people that that this is your job, you do this for them and that's why they're even having the opportunity and then let them set it up according to that to correct principles. So the to get here once and for every 10 people at a time. Next question,

I understand the RSS permanent download for each country will be calculated on the GDP of that country. My question, how will that affect beneficiaries in different countries? For example, I'm in South Africa and signed my wife as my first beneficiary. She signs up our three children who live in New Zealand and the in laws are in South Africa. We have family in Canada and Australia and friends in the US and in Finland. My wife gets the South Africa rate. Will my son give a South Africa rate or will he get the New Zealand rate while his in laws get the South Africa rate?

That's a good question. It's one of those situations. We'll make a decision and then that'll be how it's done in the future. So there's all kinds of things that would create an exception to the rule. And this is one of them. But we have to make something that's workable. For every buddy not just a one time problem, or a solution to one or two people have a problem when it affects the whole hundreds of 1000s of people so we'll do things appropriately. And this is one of the again, one of those questions that we can work on. When we get to that point to make decisions on that question.

Let me just elaborate on this one. So what you're saying is, is that you'll come up with a recommendation but ultimately it's an it's up to every benefactor to make their own decision. Is that right?

If it's a beneficiary program, then that's part of the beneficiary account. That's something that loved wants to say is responsible for the download in each of the

different countries. how that is implemented. And how that's administered. Is that is the question that we'll try and work through. But loved one society or their RSS platform will be for the beneficiaries. His set is going to be set in stone. There's so much other stuff that's available for the benefactors to do to make to do what they want to do with the program. So, but we have to have something like the RSS program that's similar, if not the same in every different country. Okay, next question.

Okay, I'm going to answer this one. It's a new person and they ask, I want to ask, When will this start? We don't know yet.

Okay, that was that was profound, crazy.

Just teasing. You can answer it.

Well, it's true. We don't know. And we'll know just as soon as this starts and then we can tell you

Okay, truss,

okay. Just Just one other point here. Okay. The Alliance does not give out dates. They're the ones that are going to do the RV. They do not give out dates. If they do give out dates. Please understand it is for military deception. There's a purpose behind it a military purpose behind that deception. So if the Alliance gives out a date, no, that's military deception Are you going to go around believing in military deceptions? Are we gonna wait until the real stuff comes along? Elijah does not give out date period. Next question.

This one's about trust. And it says the manual on CAC indicates directors can create trust I assume under their beneficiary status of just six. And it was written that directors can be a trustee of the same trust they set up. So a director can set beneficiaries under his ID can create a trust and be the trustee of it and so on.

Okay, don't use computers to CAC for the beneficiary, as beneficiary, the CAC director can be have his own beneficiary accounts. And set up his own six accounts for himself has nothing to do with his business as a director or his employment as a director. And you've assumed under the benefits your style that he's able to do only six when he's a director. No, that's not true. He's going to be going out and if he feels the need to set up some kind of a trust. There's a number of different ways to do that. And there's a number of different reasons for that. He can do that. That's his job. There's delegated by the beneficiary or excuse him by the Benefactor in their association together and how am I going to do my work for you sort of thing, they set it all up. So when you're talking about trust, always be sure that you're not talking about a beneficiary trust, as opposed to a director who has a contract, an employment contract with the benefactor to do certain things in that community. So keep those separate in your minds because that will be very, very confusing and restricted to a director if you can only put up six trusts in the 100 years that he's going to be a director. Oh, that's, that's, that's there's no thinking involved in that. So right the difference between that in your mind next question.

In regards to inner city kids, this document also states trust can be set up for kids under 18, a benefactor or director may only have up to six trusts which we just negated. So a limited number of kids can be helped under one director, who will be the trustee of

such children's Trosset should be a responsible parent, but who vets the parents some parents could have personal issues such as drugs, money mismanagement, etc. Yeah, the director himself will be the one in charge of that. You guys, excuse me, he has to do things according to the circumstances that are surrounding him. If there's a parent, there's a derelict and a drunk, then maybe that person shouldn't be the one in charge of a trust that the director set up for a person under 18. And that person under 18 can therefore get some funds to do things in his life or her life, where parents don't have the funds available, who would misuse them for their own purposes. First, if the parents want to sign up and become a beneficiary, and that's up to them, and that's the way this this all goes. It's just giving the director a leg up on helping and it may be that the director wants to figure out a way to have some funds available for children, instead of just specific for one, one shot. There's many ways to do these things. And obviously, it's when you're in the set of circumstances is when the Spirit tells you or helps you to understand what is the best way to move forward with that particular person. Without that guidance, this whole program won't work has to work on a on an individual basis, where the individual is receiving guidance and directions from the heaven for his own personal stuff, and the things that he's responsible for. And if we can all learn how to do that, and trust in that communication, so we'll never be out of bounds. We'll always be within the quantum consciousness that is designed to help us through us. And also, this this whole concept was written before we had an understanding that we will have a counselor from the other side of the veil angelic grounds will ever for us to talk to and to communicate with and to plan out with that'd be a great source of how to set things up properly. I think it will be a great source. It's a blessing that's that's been given to us by the Alliance. Because none of us humanitarians have had much experience in doing what we're going to be doing. And to function on the high level. We're going to have to have all the help that we can get. believe that that's what the lights are set in place for us to beautiful program. Next question, and you know what to elaborate this person has a really good point. Um, what if a director or an assistant director of a given CAC is aware of these inner city kids that need support? What if there was like a foundation that just helped provide resources for these kids that didn't have good parental support? While we are able to help these parents recover from whatever, you know, lack they're experiencing whether it's drugs or money mismanagement, or you know, whatever their problems are? In the meantime, we can also help the kids as a collective, what do you think about that? I think I think that's a great idea. Each individual community would have unique problems, perhaps similar problems, but sometimes you need for that particular area. Your job as a director, is to figure out the best way to accomplish what you're trying to do and that's to help children to grow up feeling that they're loved and cared for and if they're coming from a broken family. Let's help. Oftentimes families are broken up because they don't have funds. Dad can't take care of his kids so he gets them out goes down the road, you never hear from him again. There's all kinds of problems associated with the lack of funds. We're hoping that 90% of those things can be resolved because there is funds and plenty of funds to do the things that are necessary to resolve the problems. And when when given that resource. That is dependable, reliable. You can

start doing things that you could never do before. And we're looking towards that as the catalyst of making the changes that need to take place within a small community. And then the larger community, even on a state or a nation basis. So we're covering the whole gamut of what needs to be done. And then as we go into the boots on the ground in the communities, we make the changes there that will produce the major changes for a brand new economy. And the level of society programs are designed to do that. So as much as we're going to help the poor get the food that and clothe the naked and house, people who don't have homes and that sort of thing. We're changing the way that the economy runs so that we don't produce the poor. The poor are byproducts of the cabals way of doing business. We don't have to do it that way. Nobody tells us that we have to do it that way. We have the money we get to do what we want. When you got the goals, you make the rules. That's the golden rule is if you have the funds, then you use the funds as humanitarians. to uplift and build up communities. And that's how much fun we're going to have because we'll see what the changes are. And we'll be making those changes. And we'll be responding to those changes. And if we're doing something wrong, we'd go a little bit different. We tweaked it a little bit. We have the ability to do that because we have the funds. And we get to have fun with what we're doing because it's our funds and we get to do what we feel from our heart is the right thing to do. That's never happened before. How many politicians do not have a humanitarian heart. One out of 1000 2000 10,000 million, who knows? But we're gonna we're setting it up so that we have plenty of politicians with love in their hearts. However, the point is, is that we're going to get the job done. Because we have the funds to do it. Excellent question.

Cool. Okay. In 2002 I started a building project for the elderly that fell through the doughnut hole and destitute bets. I had everything builder architect the city was going to furnish the land and then no money, the oil companies were here we're already on their way out. I did not know that. I was told by the BBB run by Joyce Donald at the time to hold on to the plans I did. I still want to do that and 72 and do not need much anymore. So money is there to use for others. That is my story. I am in need of funds to revive my project from 2002. Is there a chance to make it happen yet?

Yes. Become a gym benefactor. Get your gym position yourself, both through the loved ones society stuff and, and organize yourself so that you can perform at a very high level. Some of us are older than 72 and we plan on being around for 100 Another 100 years. So we're going to position ourselves to be of service to mankind for a long time. You can do this. Don't know your name. You can do this. But you need to get involved with loved one society, learn everything about it. And then with that knowledge and understanding that you'll be able to do things appropriately for the people in further what you're trying to do. No more doughnut holes in your progress your project. Next question,

suppose I pay the whole world a salary of \$1 million each year. This is a million dollars. times 7 billion people makes a seven with 15 zeros. A seven with 16 zeros is not twice as much but 10 times as much as seven was 17 zeros is 100 times as much and as said with 18 zeros is 1000 times as much as to pay the whole world \$1 million per year. An average level in society benefactor will go for one with 18 zeros annually I think they

can then spend in abundance for every project they like and also for future things thinking about new technology SpaceForce ET groups of difficulties and more. Personally, I think that one with 18 to 20 zeros until 100 100,000 times more than giving the whole world also the kids a salary of \$1 million to be more than sufficient to meet all the needs of a big part of the galaxy. Now my difficulty you say that when you have Zim dollar notes with more or even much more than 20 zeros, you would even ask for the higher rates. While I think that most of the people using the loved one society projects will already have a very hard time spending a one with 16 zeros each year. Can you elaborate on this?

I sure can. There's a lot of assumptions that you're making here. And I appreciate the desire you have to help people financially. If you gave everybody a million dollars a year, you're going you're not going to have an economy because there's nobody is going to work. There's no reason to work. There's no incentive to work. That's why we give \$1,000 a week there's a certain amount of overwhelm, that accomplishes a an attitude of gratitude. We're grateful for this we didn't have to work for it's not a second job that Tada. It's bonded it's gonna last forever. All of these things are built into the system. A million dollars would destroy this whole thing. Okay, so let's just eliminate the idea of a million dollars for every seven and a half or \$7.7 billion for everybody in the world. And then how much extra money they're going to have for all of this and then the other. A person comes from their heart. Let's just say that humanitarians come from their heart, because I'm not sure that you understand where we're going with this whole. Senator, I understand where you're going with all the zeros and stuff. But you don't understand where we're going as humanitarians. The rate that I choose, or the rate that I'm going to ask for is the rate that's put in my heart. When I say put in my heart, I go inside and I I contemplate. I ponder on these things. And I get a feeling that my range should be \$3 million. Okay. If I were to come to you, and he would say, Oh, that's too much. You don't need seven or \$3 million. If you're going to get 100 quintillion dollar note. You don't need that much money. Well, who are you to tell other people what they should have or cannot have? Or is ridiculous. It's none of your damn business. I'm saying this very forcefully because I I mean it. You start going around telling people that's way too much money. Who told you it's way too much money? It's your own opinion from your own experiences that are lacking centered in your life. So don't be going to tell any people something that you don't have any interest in or know about. Because you're totally ignorant of what's down the road. Who do you think's looking down the road for you? Your heart is connected to the quantum consciousness. That's where you get your information from if you don't have it in your mind. Because your heart can look down the road and see what's coming. Then your heart goes out of time to do these kinds of things. Things are changing, you've got to come up to a speed and an understanding of what's taking place. This is why I say go into your heart get the rate that you feel is comfortable. For the gym that you have. Because the gym that you have your heart knows that goes what rate you need to get taken care of all of this stuff is found the road all of it. Just keep in mind that down the road. It could be little children that don't have a home and you don't have enough money because you didn't plan on it. Who's gonna take care of those children if it's your responsibility or your opportunity, and you didn't

ask enough money? Now I say it this way. Is it better to have a lot of money in your account in the quantum financial system? Or is it better to just leave that money in somebody else's or in the quantum financial system account? Where it takes a transaction to activate the golden certificate, the gold, digital gold certificates so that that money can be used? Why not? Is it worth where's the problem with putting into the hands of the humanitarians, even very, very, very, very large amounts of money. That means that the money is available to do the things that money was supposed to do. Instead of locked up in the quantum financial system, and can't be used because somebody didn't use their heart to ask for the right right.

This is really serious. Especially if that was my child that was down the road that didn't get the help that they needed. Somebody didn't come through with their heart to take care of those circumstances. If you could live with that, then ask for that 12 million for your 100 Tino don't talk to me about zeros because those are the kinds of people who don't care about the kids down the road.

We're humanitarians, we're preparing for the future. What you're talking about about the zeros and all this sort of stuff, I know all about that gone through it had dozen times. The important thing is that we will have enough zeros are just opportunities and if you get that in your mind that zeros are opportunities, then you will never question how much money another person would receive because they asked for \$3 million rate for 100 quintillion dollar note I say again, it's none of your damn business. It comes from their heart. It's a private transaction. And they are the ones who will receive the stewardship to do what they're supposed to do with the money that they receive. It's all set up in an appropriate sort of way. So that all of the bases are covered. That we can move into the golden age of mankind without tackling along a bunch of naysayers who don't know what the hell is going on. Those are the kind of people who will be going into the fifth dimension anyway, in my opinion, I could be wrong. They can change and they can change but they have to change to do that.

Not saying that this person asking the question is a naysayer because they just wanted elaboration or

they're not. Good, good. Good point. I'm, I'm arguing to get the point of people saying that you had you shouldn't have that much money. And if I have if I carry that thought process into my meditation sister situation where I'm meditating on what her radar should get, if I take into that meditation, the idea that I should have \$3 million you think you your hearts gonna override your mind? Now you guys still your mind is stupid in relationship to your heart. And so you just allow that to be true. And don't predispose yourself to a re might feel that that's what it never gets confirmation on your heart from your heart. That's how it's done. That's why I've preached this so strongly, is that the right word is so strong. Now I'm very passionate about this. I know it's coming and I know that we need the money out of the quantum financial system and into our personal humanitarian bank account or quantum financial system.

Okay, moving on,

I get a man Okay, okay,

using the celestial chambers I intend to live way past the 100 year structure payout going on the assumption that money may still be needed past 100 years is it okay to set

aside some funds? Like one quintillion in a separate kFS account in order to accommodate my personal needs past 100 years?

Well, it's an interesting question. And those are the sorts of things that you are guided yourself now. I have a bond account, I'm creating a bank account that takes all the money that I have leftover from one quarter when I get my new payment. I'm going to put that money in the bond accounts. Is that like a savings account? Is that something that you may think is the quantity or in your savings account? No. It's a bond account and it will accumulate way way way way way past quintillion. There's no call for that when there's no need for money or whatever at that level anyway. So you're you're already doing it's already built into the system. Next question.

Can you please expand on point number seven of appointment preparations regarding the 10 or more proof of funds statement of clear, clean and non terroristic? What type of document are you referring to?

It's called a proof of funds document. Meaning that the bank issued a statement letter that you can take to a real estate agent or somebody like that and say I this person has sufficient funds in the account to be buying this house. It's just proof of funds that you're not just talking. So you may be a tire kicker for looking into that house, but you have the capacity to make a decision to buy it. That's all it's for. Now, in that same frame of reference of what society is trusting you as the gym holder to become a gym benefactor, that you've asked for the higher rates and have sufficient amount of money in order to fulfill the responsibilities and obligations that you create as a gym benefactor. It may be that will ask for a proof of funds that can be submitted to loved one society. So that we don't have to ask you the question. Here's my proof of funds. Okay, so you are you have gone through the redemption format and you do have a lot of money so that you can perform as in benefactor without any problems and still do your own projects. That's what we're looking for. I'm not sure yet if that is something that's required, but it's certainly a good idea. So that there's no questions about from you to me that you have the ability to do something I didn't need to do and signing the contract for a benefactor. Next statement, next statement.

Oh, another one. Question.

I know that everything will be good in the end, but as a Zen benefactor, I will be happy to introduce my friends, family and others in my network. But in Europe, and especially in Denmark, where I live, people are so skeptical about receiving money without doing anything. Most people think it is a pyramid scheme and there is something suspicious about this setup. I have been working for a network marketing company earlier and when I think people think this will be a network marketing to do you have a plan to have a standard for telling people about the RSS and LW s I guess they want to have a like what your plan would be to pitch somebody on it.

Yeah, and we'll we'll come up with some of those things. That there's always going to be skeptical people you know it I deal with skeptical persons. Here. Let me pay your \$10 When we got to lose. You just got the email and your name on there and you get your ID. Now I'm going to come back next week and ask you how much money you've accumulated in your account. And go in there and see it. Is it a scam? Is there anybody

looking over your shoulder saying I need some of that money? No. If you don't believe in it, then try it out and see. You know, you're not walking on the library you can break through. You're not going to do any damage to yourself by going through this. It's a simple thing. And how you approach it. Don't Have in mind that Denmark people or people in Denmark are just skeptical and they think it's a pyramid scheme at all. So everybody thinks there is when there's something for free but just understand things are changing. You're getting back money that's been stolen from you for and your and your generation for generations of your family. This is a way for us to get back some of that money that belongs to us. And we do it in in in logical sort of way so that everybody gets some and that wants it, everybody and then everybody can have a employment contract. I think everybody in the world should have an employment contract, as well as their their beneficiary account six verses plus your own six trust plus your own beneficiary at 720 \$1,000. A week or is do I know that? Yeah. If there's a couple that's 20 \$26,000 From my aware that Yeah. Is it good? Is it going to change? No, I've gone through that with the time and time again, and I've always been taught guesses six trust sets seem to see the number six that six trusts. What part about six? Don't you understand? In a loving sort of way. So I've learned to quit asking about that kind of stuff.

Actually have an idea that I have an idea. People feel skeptical about this. They okay and sign up their friend and then when their friend is having all this success, then the people will say oh, well, I guess I was proved wrong, you know? And then Dominic actually in our group suggested a great thing. He said, if they're skeptical, don't want to spend the 10 bucks say Okay, I will I will pay your \$10 and then after you see this all coming to fruition, then you have to pay \$10 and pay it forward and help somebody else get enrolled.

Oh, I love that. The nice thing about that is you can do that for five people you get one \$50 one for \$50. You get that back that \$10 back and you could do for more years and the good news is that a good investment is \$10 to get you another \$50 Every time you spend \$10 You get \$50 back. I think that's a good way to do it.

Okay, county property taxes are required on all properties at this time. Will those still be required and controlled by the local authorities and have to be paid as scheduled it for example, in California we have to pay twice a year.

How Nosara is implemented will be interesting to see interesting meaning that you cannot tax the people. You have sales tax. The SAR just are compliant governments. There's 17% sales tax on new items. And there's a bunch of stuff that are non exempt. Three of the 3% 4% 14 goes to the federal government This is my understanding 14 will go to the federal government 3% is going to the state and county and cities to take care of their businesses. Now. If you get take out away car registration, how many people is the government employing to take your car registration and and the taxes for that? How many people are there? Well, you can just simply do away with all of those people having a job there and having to pay them so the the funds for that. are changing and funds for other things collecting taxes, no income tax, no income tax at all. So get rid of all of the people who are involved in the taxation of people. That's trimming that the government down and there's other areas that will be treated trimmed down as well.

So it will be against the law to just our compliance to be taxing people for property taxes. It's not it's not a sales tax, and property tax. Why do they get to charge you money to live on your own land? That is total cabal garbage. You think you own the land but in a cabal government you don't own the land, they own the land and they own the people and give you the opportunity to rent it from them. And they call you the owner will kind of find out what travesty has been happening to us. They cannot tax you because it's not their land. To have services or if you want to have service don't tax me for let's get together and say we need this amount of money for our services. Okay, well, let's do that and let's pay for that parents specifically. But you as Ben as a beneficiary of that. Get to determine whether you want to participate in other. There's all kinds of things that are going to be changing. So is that sales tax, property tax? Those are taxes that are not involved in the JSR compliant countries. Question

This one I'm kind of confused by Can you please tell us about benefactors master RSS account please?

Yes, I can tell you that each benefactor establishes an RSS account. You become a benefactor. You get a master ID and you put up a master RS S account in the quantum financial system. You put your money at there is that account and the computer draws it down when a beneficiary who's signed up in your chain of beneficiaries request money to be drawn down into their account. It comes out of the master account. The master account is all used by the RSS master or excuse me, the RSS computer platform. And the Benefactor has done that specifically for the purpose of funding all of those people. So that's the master account. I hope that's clear. Next question. Okay, this one wanted the Zim Bansal for that email. Okay. And I would like to have 20 to 40 acres to build a place that people can use as a library recreation, meditation, sanity to get into they can help or just visit have fruit trees, vegetables. Games, and activities to help mentally and spiritually. How do I go about getting into the projects deal?

Well, it's kind of one of those deals. If you make it the people will come I guess that's true. There's a set of circumstances that you call your core beliefs. And your core beliefs might include things that are not a part of other people's core beliefs. They don't do they may not want to have a meditation centers or things of this nature. They may just rather have better replicators to prepare their dinners. Who knows? We need to be flexible as we move into these things. Because if we if all of the humanitarians set up a clinic if all humanitarians build homes for the homeless, we would have homes all over the place and be fighting over finding a homeless person to get into him. There we need to understand that once the problems associated with a lack of money have been solved, that we're moving on into a different society. A different way of interacting with one another. Your pet projects, their pet projects that you want to have. Is there anything wrong with uh, no, there is not. And I'm not saying there isn't anything wrong with them. I'm just simply saying I understand that project will be completed and then we'll move on and well, I'm going to do it all over the world. What about the people over there? They're doing all of their stuff over there and coming over here to do their stuff as well. It's going to be interesting to see how this takes place.
