Hello humanitarians. This is Ron Giles. I'm here with Tracy. She's got some question marks on her forehead again. So it looks like we're going to do another to answer period. It is November the fourth 2021. And so with those introductions let's go ahead and answer some questions.

Okay, I'm seeing a once until you in Zim know on eBay, but it is a commemorative replica and no gold value same size etc. Will this be acceptable to use the appointment?

Yes, it is. All of the gold bonds whatever color they are gold, silver, and especially the the originals from printed from the Reserve Bank of Zimbabwe. They will all be available for you to redeem at the appointment. And here's the big gift. If you are humanitarian. If you're not a humanitarian and better less one with the Alliance agent, then you will not be able to redeem them or any other Zim for that matter. So all of these Zim large Jim bonds are available to be redeemed, because they want us all to have a lot of money. And like we've said before in our thing, so yes, it is available for for your appointment. Next question.

I have already started in humanitarian activity. I sold my house and have been using the money to help others. I find the system to be complicated. If I am not up to speed with the paperwork will this exclude me to get more funding I desperately need to carry on my work.

Well, it sounds like you have a humanitarian heart and that's the most important thing. You'll be valid as a humanitarian. You've got your Sim take that in there. There are times when we don't really feel like we're up to speed. The Alliance understands that as we go into our appointment. Very few humanitarians have had much opportunity to have the funds necessary to do their humanitarian work. You're going to get that now. And you're also going to get a member or a person or an entity I don't think could be an angel resurrected being centered master something like this, who will be there at your appointment, and that person will be your new counselor and will hold your hand to do everything they can do. You have to ask, they'll help you to do the things that you need to do to be a very high level functioning humanitarian in these kinds of projects. So don't worry about a lot of stuff. Just be sure that you've got some thoughts and ideas about your projects and go and write as much down as you can. And then go in there with the confidence that these people love you. They want you to serve. They want you to be a part of what they're doing. Humanitarian hearts are not are hard to find it time so they want every single one of those kinds of people involved. Next question.

How do I get an appointment to get set up to receive the funds

this is a very basic question and indicates to me that there's a lot of information that you're not aware of that is available for you. Just briefly, the appointment will have you will get the chance to make your appointment because the alliance will contact you. From there. I'll let you go and research and do the things you need to do for yourself to come up to speed. Next question.

Why don't you state the URL of your website? Yeah, that's 2020 Instead of just saying go to the website

we're talking to people now who have already registered on the website and are available to are wanting to be trained to become a gym benefactor. I'm assuming that everybody knows what the website is. As for you signed up, that might be a little bit picky. My perception when I'm responding to somebody, this is probably from somebody who I have responded to. The reason I do that is because I have a difficult time. Tybee and I don't like to spend more time on that then is necessary. So that's the way it ends up. X question

I'm trying to set up Sorry, can a new beneficiary start with just one trust and add more later until he reaches six?

This is this is an interesting question. Why do you have to have six? And when are you going to start them? You gotta get your beneficiary account. Yeah, you're gonna get your beneficiary account and you start doing the trust accounts whenever you want to. They're available you just set it up and obviously do it legally. To do so you have to have an account either a bank account in transition or the quantum actual system. Take that but the transitional but you over the quantum financial system will be available when we have the money to do this. So your accounts will be in the quantum financial system, set up an account for the trust account. And then you'll be able to draw the money down for that you don't have to do it. Even you don't have to do them all at once. You never have to you don't have to ever give them your choice. Next question.

I am trying to set up a structure for my humanitarian work what I start out as a nonprofit. I'm trying to grasp the concept of how government will be involved in our group. If you are paying people and giving away money. I can see states wanting to know where the money is coming from. They can't find info on NESARA and state involvement. What are your thoughts on this?

Just sorry, compliant government means all of the state, county and city governments as well. They're all going to be on the same sheet of music. Why? Because there's no taxing of the people. Except for sales tax. Governments have been running off of taxing people all these years. That is all going to and by the way, a state in the city and all that. If it says state that is a corporation for the county as a corporation. They are all going away. We're not going to be governed by any corporations ever again. So all of that structure is going to go away. What are we going to have left? We might have organizations rather than corporations. I don't know how it is going to be. Well, it's not going to be the same as this now, but we set ourselves up doing things the way they are now for the transition. You set up a trust that's your best way. LLC. They may be good. It all depends on how well versed you are in these kinds of things. Sake some counsel from other people, but the most important thing is to realize that again, when you go to your appointment, you'll have a counselor there who will help you to make some of these types of decisions. But you have somebody to discuss. Next question.

Why could you not use on ESS employment contracts the normal 90 day trial period as an uncontracted period to wait and see if the employee has the necessary skill set.

He ESS is where we when we start talking about that we're talking about any at all depends on where you are. If you're out on a farm that's a different situation than going to a car manufacturer and there's workers that are already there. So when you say Do they have the skill levels, or skill set, there are common human resources. They are human resources in the larger corporations. They have theirs their job is to train people their job is to hire and train with people that they need for the work. But I say hire and train we are going to take over the the paying of those wages to the people, but we have nothing to do with who they hire if they go through the grievance processes to prove termination. That's a different story. We'll go address that those two things will happen when we get there and we find out what the contracts are and so forth from the the attorneys that are going to get or the lawyers who are going to get involved. So you're it's an interesting question, and maybe this is a little bit beforehand. But these kinds of questions. We're projecting into the future. We're shooting down ghosts, it's pretty hard to see which ones are real and which ones are just go away when we get there. So let these things go for now. And understand that it's going to be set in place at appropriate time that it needs to be set in place.

For humanitarian practice, will we need to provide a full budget this is difficult we're not on the property as of yet.

There's no way for you to really understand what your budget is. And your humanitarian packet, if you can project into the future, how much it's going to cost for you to do your project and every country in the world. You know, I I did count with a crystal ball. I don't know how you can too. And the Alliance does not expect you to have a budget. No, there's no budget expected. You don't have to justify what you're asking for. Again, as I've said before, they're not financing or funding projects. They're funding humanitarians who will do the projects. humanitarians will get the funds and it doesn't change humanitarians. How much money is zero, so just an opportunity in your phones. So we'll go from there. But next question.

On the situation and multiple benefactors for beneficiaries, it seems simple to me if a person is a beneficiary and has an ID, it follows him wherever he goes. If another benefactors director wants to put that person on a contract, the contract reverts back to the original benefactor for payment, and the Benefactor should agree part of a benefactors contract. So no further disagreements could arise. Otherwise, it seems this is rewarding a person signing up others not the party needing to be paid. The whole line of earlier beneficiaries who enroll to get to the person would be affected bonuses, additional payouts, is this what you had in mind? That makes a good point actually.

It does. The question then would be what account is available for the quantum or for the RSS computer to draw money from? Now? If they're just on a beneficiary account with their six trusts, then that's a certain amount of money and they they may have grown and gone out use a bonus program and get more money. But we're not talking about a significant amount of money at all there. However, if they add a large contract to it, then that could be but even at that it's not meaningful, and I'm thinking that let's just go with the original beneficiary ID number for all of the contract employment contracts as well. Because I think that there's very seldom are we going to have a situation where where that takes place. Most often you're going to get a contract in your local area, and everything will be fine. So we've got this, we've got the flag up the pole on that one. It's not going to be a major problem is when that needs to be addressed. So we'll address it appropriately as they move forward. But I appreciate your question and I appreciate your thinking this through Thank you. Good job. Next question.

Further to my earlier question about the beneficiary's ID number following them in the 90 day trial period, I think, tell me if I get this wrong, please that uh, if a beneficiary is hired, then the Benefactor associated with his ID should also commit to funding slash continuing his insurance. Thereby the beneficiary and family are never without insurance, even if they're hired by another beneficiary for work. Would this stop any disputes keep them covered and the chain of beneficiaries who originally listed the person into the program flowing uninterrupted?

It it's a good question and it's similar to the one before but there's a nuance there. Health insurance loved one society, my my, the way that I look at this as loved one society will will provide a blanket insurance program for whoever kind of science contracts that loved one society is associated with. It won't come out of the benefactors or Yeah, it won't come out of that. The original benefactor for that person. It will come from love wants to say so that doesn't matter where they go. They'll always get the insurance. And you know, we're moving into the point where all of the remedies for the problems associated with health will go through the med bed situation. So it's not it and there's no payment for that. So there's no liability as far as providing or saying free insurance or free health care. Because that's,

that will be part of what's going on in the future. So let's not worry too much about that that loved one side will take care of the bills for all those as we call it in insurance. But it's not going to be an insurance I don't believe in insurance. But the concept is good. Next question.

Ron, is your website the same as your app with the house on it? I have no idea what that means.

Maybe somebody has done something that I'm not aware.

Hmm, maybe that person Oh,

house maybe it's that person to send something and if we've got a problem and then before

you know, I'll email them and see if I can figure that out. Okay, I'm really wondering what you think the holdup is. I have three projects planned out and ready to share but I'm also was just evicted living in my truck for the past two weeks with my two dogs. I know so many have it much worse than I and I have no place to complain. And I guess I'm just getting worn out and tired. I realized this is a military operation and I have faith. All is being done to make this happen. Just didn't know if you could shed any light on when this will happen.

Light on when? No, that would just That's right. How long is it going to take to finish the war? There are so many moving elements about the war. That you can't pin it down to where this happens and then that's gonna happen and then that went over there. It's kind of like they're having little skirmishes all over. And when all of the skirmishes are over, and it safe. That's the important thing. To realize, when it's safe for us to have the money. When we personally are safe from the kinds of people who would destroy us. That's personal. There also needs to be security of the money that we receive. So it doesn't get into their own hands. And alliance is pretty well taken care of that. But it has to be under their umbrella of protection. And maybe that hasn't happened yet to the extent that it needs to. These are all things that play into when the time when they pull the trigger on the on the RV and start releasing the funds to us. It has to the money has to be safe, we have to be safe. And the political environment and so forth has to be stabilized so that there's not a war going on in the streets. For it when we get our money. So those are kind of the concerns are the things that I take into consideration. Do I have a feeling for when it takes place will take place? No. Because I'm not familiar with all the things that need to be done. I just have a I don't have a list. So and nobody has that list. Probably not even in the insides of things. Because each person has their responsibility and they're doing it and doing and getting the information back to a central command and then you go to all of this information that you have to call eight and so on and so forth. This is a this is a big thing. We're not talking just about this, this world, or this, this world. We're talking about the offworlders who have to be defeated who come who came here and everything in the beginning that caused the problems. Those people have to be dealt with as well are those entities whatever you want to call them. They have to be neutralized to the point where we are moving into the golden age of mankind, not just for this earth, but for the entirety of all of God's creation. This is what's taking place. It's monumental. So we just have to let the powers that be do their powerful things to bless us with the things that are coming with the Golden Age. Next question.

When we approached people to register them as beneficiaries, we explained that we represent a nonprofit humanitarian organization that is dedicated to the betterment of humanitary Manatee and the planet Some may I ask the question, if you are a non profit then who is profiting from the \$10 registration fee? How do we answer that?

Well, that is so insignificant, that it's almost ridiculous. It's almost a ridiculous question. The \$10 is only it's not a fee because there's things that have to be paid for. Now as a benefactor, you need to understand the psychology of this. If you give something free, they think that there's always a catch to it. And if you give it to him free for a long period of time, it's like they're on the doll and you destroyed their ability to feel like they're independent. From that. The \$10 fee says to them, you paid the \$10 Now you're entitled to this money. It is insignificant about the moment it \$10 for \$144 a day. That's not the point. The point is is that you did what you needed to do to get the \$144 a day and that's to pay the \$10 in your mind. Open that's true for everybody seems to be true, because that's what's been given to us to charge that that a person feels like I did what I needed to do and I'm getting these funds, so their mind, I'm entitled to them. Yes, you are. So let's not be hung up on this \$10 If somebody asked that, then just say how was the matter to you? You're getting the money. Don't go inside this and start picking it apart. And people will try and do that and they'll have their questions. You don't have to ask these kinds of questions, period. If you don't like it, don't do it. The guy over there, it's not getting tender. It's not getting \$144 a day. Why? Because as per the \$10, he pays the \$10 we'll get down to \$44 a day. It's that simple. Next question was

I've listened to all your q&a. I remember early on reading your website, you talked about projects on the other side of the hill. I have to admit I had to think very hard in my community. I know exactly who will be my directors. Have you any guidance traveling to other communities or countries? How you would get good quality directors?

No, I don't know how to do that. I'm in the same boat. You are banned and you just do a little bit of time that you'll find the right people. here here's the key to all of this please understand, ask can you share with see that is universal law. If you ask now, in my simple belief system, I go back maybe even 100 years or two generations the people who will be doing this work are being prepared for us, not by us but for us, by the Alliance by the Divine Consciousness to participate in this particular period. of time. You ask and you will find those people because they're looking for you. And you will be able to come face to face with each other if that's if they're supposed to be working with you. This is this we're going to leave this in the hands of God because it's his plan. And he's going to help us address right people I've been told the right people will come out of the woodwork and you will be astounded how easy it is. That's my belief. That's where I'm approaching it. So next question,

is it possible to have all money going out to help in a community by buying up land to stop construction destruction help the fire department the police department, the equipment and on ranch farm hiring, building maintenance, free celestial chambers and wands replicator services purchase all supplies, equipment and furnishings needed furnishings needed and still not run out of money?

If you ask for a one to one \$1 present, you might run out of money. But if you ask for the \$500,000 with a 100 Tino that's 1.25 quintillion. Yeah, your mind has wrapped around 1.25 quintillion data, you wouldn't even approach that question. We're talking about some money that we've never had experience with. We have not had experience with a trillion. A trillion is 1000 billion. trillion. 1000 trillion is a quadrillion. 1000 quadrillion is a quintillion. Did you get to get 1.25 of those every quarter if you ask for the \$500,000. Now I asked you Is that enough? Are you going to do all of these things? The world economy is somewhere around \$120 trillion a year. And you're getting 1.25 quintillion and you're wondering if you're going to run out of money with doing all of the stuff that needs to be done. No. We're not going to run out of money because we're going to ask sufficient for our needs. And we'll get

the jump. The things that were in that question, are the things that we're going to be doing. In a community, not only one community but hundreds and 1000s of communities. We're going to be building the roads. We're going to be building the bridges. We're going to be doing the helping the fire department and the police with the equipment and things of this nature. That the government is not going to taxes to buy those things. We has humanitarians. Those who have the money will have very little to do with government. Because they're going to be small and they're not going to be taxing people anymore. They're not going to be able to do the things that they have done before. That's that's the Cobalts ways of governing people and we're not going to do them anymore. So we're going into something new. And yes, we're the ones that are in charge of those things to pay for them and, and to help people and we've got the money to do that. So we do. Yeah, I appreciate the question. That's what we're going to be doing anyway. We're not going to be running out of money. Unless you don't plan ahead. Next question.

As we expand and help outreach to state national global and galactically however that will be, well, the CAC expand on that scale with us as the number of employees increase

Sure, why not? Yes. Oh, you want to spend the money that you have? That's good thing to do. Next question.

Will you be creating a PDF for the Benefactor account to go along with the other PDFs?

Probably not sure what the Benefactor count is okay. That's that's a simple thing. I don't know if that we need to be PDF. It's the benefactors have account. They can establish counts for whatever they want. And fund them were however they want to do it. That's your benefactor account. I don't know that that needs a PDF. But we'll include it if it's necessary. Question.

Do you think we will ever build a new planet or place hidden behind Antarctica, which has always been my feeling?

Well, it said it's a feeling and I don't I don't know whether that's going to happen or whether it won't. I don't understand when you say behind and Arnica. You'd have to do it underneath it because there's no front and back of Antarctica. I'm

not sure. The ice wall or something.

I don't know. Well, it's those are things that I have no idea about. But just say it that way. I don't know.

And okay, so regarding the q&a that we did on 1029, part two, at 53 minutes in the discussion about a beneficiary have an RSS in California employment contract and Florida real estate contract elsewhere. Tracy is talking about these contracts as separate accounts. This was just a discussion we were having for ideas. Anyway, but we're the beneficiary only has one best account but can have many contracts with the various programs under different CAC directors. benefactors. The common point for the beneficiaries, the beneficiaries kFS ID number slash account. The contracts define the separation between the different revenue sources, or benefactors and how the beneficiaries kFS account receives funds from those sources. I'm not sure what their question was. That sounds more like a comment to me. What do you think Ron?

Well, his comment and we discussed that earlier, where there's a beneficiary account for an individual who moves to another location that gets a contract. Who's Who's gonna pay for that? I think it's the

original, original better benefactor. Why? Because it's an accounting situation. It's just too hard to control. There's no reason to you know, you'd have to have a whole thing of debits and credits and then and worry about money. When there's you know, it's like let's divvying up the ocean and you get so much and I get so much you can't do that. There's too much so I think it's just appropriate for the original benefactor to to be finance you know, paying for the things that are going on, or is that not part of humanitarian activities? Is that part not not part of it? That is part of the community. So let's pay for that's what we do. So who's whose account and benefactors I don't think is going to be a relevant factor in the decisions that we make for that sort of thing. I think it's going to go back on the original benefactor. Just check before we go on. When you get your quarterly payment through the structured payout program, that one quarter payment is worth more than the entire economic system for the for the country, or for the world. Or maybe 10 years. You're gonna have a hard time getting rid of your money. So don't be worried about who's paying for this and who's paying for that. Because if I'm paying if I set up a benefactor in and he goes to another location, she goes to another location that gets a nice paying job. And that's a great benefit for me because that's a way for more of my money to be used. Instead of put it over into the bond account, that's just accumulating there. So I have no problems in paying for everybody who's doing that. So that's the way I'm kind of looking at it. My mind is, is going fall upon thought so I feel like this is the right way to go. So let's keep in mind that 1.25 quintillion and that's for one Tino, one 100. No. Oh, let's not worry about any of that sort of stuff because in worrying about it, you don't understand how much money we've got. Just trying to get a drink. of water as to what Niagara Falls. Next question.

I was wondering if there is a limit to the number of Zim benefactors that will be chosen to do this work? It appears to me there cannot be an unlimited amount

that's up to God. I have no control over that. What won't limit myself once is it one, we can have as many benefactors as we need? Or want to be benefactors, nobody's going to get turned out nobody. Even 10 years after we're in business. If you've got the money to do it, there's no problem for me. That's in charge. Next question.

Well, the applications for Zim benefactors cease once the RV is done. And redemption appointments have taken place.

No. No, because there's no reason to stop creating new benefactors. Name his previous question. Next question.

I feel there could be some true humanitarians who will not be able to avail themselves of this in the future as they did not discover this opportunity early enough. Any comment?

Yeah. Some people are going to get the money. To do the work and other positions. Some humanitarians are going to get the funds and other humanitarians get to use those funds for the things that they want to do. Maybe they may have some projects. I was a director, and somebody who's paying for the things you like, and I'm going to be working towards projects that I think are really valuable. And that's in the community that I'm the director for. I will counsel with my benefactor but I want humanitarians in every position that we have. Because there's a spirit of a humanitarian that I want to provide to all of the stuff that we do. That's just what we're going to be accomplishing. So I think that that's a great thing. I don't believe that person who is a humanitarian will ever lose opportunities to

become a true humanitarian, just because they missed out on funds. I'll be looking for them anyway. Next question.

Will the training videos also be available in German?

Good question. If there's some technology for it, then yeah, we can do that. It's it's almost impractical. For us to the videos in every language system possible. So what we have to do is have to depend on some technology that will. We can do it in English. In German. I don't I don't know how that is. I haven't researched that. But there's technologies to do that. I believe there is already. I just because I don't know about it doesn't mean it isn't there. But I anticipate that every German will get to all of them. Every language will get the information that they need to become good Jim Jim benefactors. Next question.

Well, and we have those Word docs that we just created with everything so that they can just copy and paste it into a translator. Um, yeah, last question for today after I have become a benefactor, and when I talk to people, I plan to say that I represent a global humanitarian aid organization a loved one society would that be appropriate?

Is it important for you to use a name? I'm not sure that love wants to say it needs to be promoted as the organization that did this. We're not seeking recognition. You don't need to say the name of the if you work for a nonprofit, then just say that I work for a nonprofit. Well, who is it? They? I'm under an NDA, so I can't do that. It's a simple thing, but I don't know that. Well, I don't I don't want loved one. Society to be promoting itself as some kind of an organization that save the world or anything like this or even has the money, each of us as your benefactors for the ones and let's just keep a nonprofit or whatever you want to say and I'm under an NDA. I can't tell you anything about the best way to do it that I can see. But that would be more appropriate. Just I work for a nonprofit organization. And they have a lot of money and they'd like to see what they've commissioned us to do. We've got this RSS program and we're doing it and wanted to be part of it. Enjoy I guess that's it for today or any more question marks on your on your forehead?

I don't think so.

We watched them all off. Okay. Well, that sounds really good. Robin appreciate everybody for being a part of who we are. And as we spread forth over the earth we're learning how to do the job dry.
