#### 1. Purpose of Shaving

I understand that my pet is a double-coated breed (e.g., Siberian Husky, Alaskan Malamute, German Shepherd, etc.), and that shaving may be recommended for grooming purposes. I understand that double-coated dogs have a coat structure designed to provide insulation and protection from environmental factors, and shaving may impact this natural protection.

### 2. Acknowledgment of Risks

- **Health Risks:** In some cases, the stress of shaving may exacerbate existing health conditions or cause skin or coat problems that could require veterinary attention.

### 3. Grooming Procedure

I authorize the groomer to proceed with the shaving of my dog, understanding that this will involve cutting or clipping the fur to remove the undercoat. I understand that the groomer will make every effort to ensure my pet's safety and comfort during the grooming session.

### 4. Alternative Grooming Options

I have been made aware of alternative grooming methods that may be less invasive, such as hand-stripping, brushing, or de-shedding treatments. I understand that these methods may help maintain my pet's natural coat while reducing matting, but may not always be effective if the coat is severely matted.

## 5. Release of Liability
