| Food/Produce | \$1,324.71 | Food and produce is a common item. The opossums start getting smoothies made with produce when they are 100 grams. We start them eating solids as they get older and larger. All of our animals get a protien item with each meal, it could be eggs, yogurt, or meat, with fruit and vegtables appropriate for the species. They also receive a staple such as premium cat or dog food. As they get older we start them on species specific items they may find in the wild. For example, our raccoons get a pond and learn how to fish. |
| Formula | \$409.53 | Each of our orphaned wildlife takes species specific formula. We were lucky to get a lot donated but we also bought quite a bit. |
