Seadrift Street Purchase Proposal

May 5, 2021

Honorable Elmer DeForest, Mayor Seadrift City Council Members 501 S. Main Street Seadrift, TX 77983

Dear Mr. Mayor and Council Members:

Seadrift Miramar LLC is proposing a Land Purchase/Offset from the City of Seadrift as previously petitioned and publicly announced for:

a. the north end of 7th street From North of Nelson Street to the WCID Drainage Ditch which comprises 23,490 square feet not to include a 16ft alley, or Powers Avenue.

b. north end of 8th street North of Nelson Street to platted Alley which comprises 8,382 square feet not to include the 16ft alley on the north end of the lot.

Total area involved in Offset is 31,872 sf.

Attached is a recent Comparative Market Analysis by a local Real Estate Broker showing comparable lots that have recently sold in Seadrift. We have calculated an average purchase price from that recent CMA to be \$0.61 cents per square foot which would equal \$19,441 as the total value for the identified lots above.

This Development will require an upgrade of the existing Sewer Lift Station located at 7th St. and Nelson St. and owned/managed by the City of Seadrift. Specifications and Cost estimate are still underway by a local Engineering firm at this time.

Per our recent communications, we have recently discussed with City of Seadrift and is agreeable to offer an Offset or Trade of the Property for-mentioned in exchange for the Lift Station improvements sufficient to support Sewer and Wastewater for the development being planned in the area. The cost to install the Lift Station is estimated to around \$20,000 to \$30,000 for the project. We propose that the City deeds over to Seadrift Miramar LLC the referenced lots in full, free and clear of encumbrances, once the lift station is completed and operational.

Pursuant to the foregoing, we are hereby requesting the City Council of Seadrift to consider this proposal during its next upcoming meeting and hold a vote for approval of this arrangement, which we estimate will bring an improved sewer system to part of the city and additional homes at a benefitting tax base to the City of Seadrift.

We appreciate your fair consideration and vote to approve this proposal, and we remain open to any discussion regarding the foregoing.



The City of Seadrift received two bids for the Hurricane Shutters, HMGP DR 4332-0313 and GLO 20-065-103-C278 on June 3, 2021. The lowest bidder, Barefoot Construction, send in a bid with a price as \$68,500. After the deadline and the contingent award, the City was contacted that the price quoted did not include all the estimated costs and had a quote cost of \$82,200. The contractor also did not provide all required bid documentation. For these two reasons, the bid is considered ineligible. The second bidder, All in One Construction had a quoted price of \$93,757.37. The Shutter Project has a budget of \$43,902 so the City would have to request FEMA and GLO the funds after a budget revision request.
