The City Council met in a Regular Meeting on November 2, 2021, at the City Hall Council Chamber located at 501 S. Main St., Seadrift, TX 77983.

WORK SESSION

Mayor DeForest called the Work Session to order at 6:45 p.m. The City Council met in an Agenda Review Work Session to review the Meeting Agenda.

Work Session closed at 6:58 p.m.

CALL TO ORDER

Mayor DeForest called the meeting to order at 7 p.m.

1. INVOCATION AND PLEDGE OF ALLEGIANCE

John Griffin gave the invocation and Mayor DeForest led the pledge to the flags.

2. CONSENT AGENDA

MOTION: Alderperson Brigham made the motion to approve the consent agenda as presented. Alderperson Reese seconded the motion.

VOTE: Motion carried unanimously 4-0.

3. DEPARTMENT HEAD REPORTS

a. POLICE

Seadrift Police Chief Leonard Bermea gave the Police Report for October 2021: There was 302 calls for service, 45 traffic stops, 48 reports written, and 3 total arrests for the month.

b. MUNICIPAL COURT

Municipal Court Clerk Marilyn Dufner read the Municipal Court Report for October 2021 with 19 new cases, 23 closed cases, 131 current cases, and \$2,613 fines collected for the month.

c. PUBLIC SAFETY

Alderperson Brigham did not have a report.

d. PERMITS

Alderperson Reese seconded the motion.

VOTE: Motion carried unanimously 4-0.

7. WASTEWATER TREATMENT PLANT (WWTP) PROJECT - ENGINEERING CONTRACT

David Sheblak, engineer with John D. Mercer & Associates, was in attendance to answer any questions regarding the engineering contract or updates on the WWTP Project. John Griffin, City Attorney, stated that his office had reviewed the contract and was okay to approve if City Council desired.

MOTION: Alderperson Brigham made the motion to approve the engineering contract with John D. Mercer & Associates for the Wastewater Treatment Plant (WWTP) Project. Alderperson Gaines seconded the motion.

VOTE: Motion carried unanimously 4-0.

Hannah Crone with the Golden Crescent Regional Planning Commission (GCRPC) was in attendance.

MOTION: Alderperson Reese made the motion to extend the City Administrator contract with Golden Crescent Regional Planning Commission (GCRPC) for the Economic Development (EDA) Project until August 31, 2024. Alderperson Hunt seconded the motion. **VOTE:** Motion carried unanimously 4-0.

b. HARBOR ECONOMIC DEVELOPMENT (EDA) GRANT PROJECT – PAYMENT OF INVOICES

MOTION: Alderperson Gaines made the motion to authorize liquidation of Harbor CD 825 and deposit into the Harbor Fund, authorize payment of engineering invoice #16686 from Urban Engineering for \$89,400 and invoice #7723 from GCRPC for \$2,543.43, and amend the Harbor Fund Budget accordingly. Alderperson Reese seconded the motion. **VOTE:** Motion carried unanimously 4-0.

10. WATER TREATMENT PLANT (WTP) USDA BONDS SERIES 1998

AKMO Advisors had an ordinance authorizing refinancing of the Water Plant Certificates of Obligation Series 1998. City Council discussed delaying the refinancing until a future date until things settle down with other grants and C/O's.

MOTION: Alderperson Hunt made the motion to table item #10 – Water Treatment Plant USDA Bond Series 1998 – Ordinance to refinance 1998 C/Os. Alderperson Reese seconded the motion. **VOTE:** Motion carried unanimously 4-0.

11. HARBOR LEASE #110

Randal Cain with CRC Custom Services LLC was in attendance to request entering a long-term lease agreement at 25 years with the current rate for their commercial lease at #110. The request also stated that upon entering into a long-term lease agreement, CRC would rebuild the pier at the end of lease #110 to help the flow of boat traffic. CRC also asked that the pier at the end of lease #110 be included as part of the commercial lease. CRC stated in their request that the rebuilding of the pier would be after the construction of 150ft of wooden breakwater from the EDA Project is complete; to reduce any interference with the EDA Project construction process. CRC also requested that the process of removing forty-one pilings in the EDA Project be removed from the project scope so that the pilings remain. Alderperson Brigham asked Mayor DeForest if the City has ever extended a lease, to which the Mayor answered, to his knowledge, that the City has never done this. The Mayor continued by stating that the City has also never arbitrarily taken someone's lease and the longest living leaseholder has been there since the 1980's. The only time a lease was taken was due to no payment. Alderperson Brigham stated that if the City allows this, more leaseholders will come forward to request long-term leases. City Attorney John Griffin commented that this may tie the hands of the City. He clarified that it binds the City for a lease even though in emergencies or in extensive situations can cause the City to reconvert or change the character of the property. Most Cities do not like having long-term leases of property that belong to the public and the Texas

Municipal League (TML) discourages it. Randal stated that was his concern in that CRC could invest \$100,000 into the lease, but the City could come down and change things. John Griffin stated that the best way to look at it is to look at the City's history with leaseholders in the Harbor. The City has not made any major wholesale changes in the Harbor. Mayor DeForest stated that if a lessee invest money into a lease and the City must take it over, they will receive reimbursement.

MOTION: Alderperson Brigham made the motion to not enter into the 25-year lease agreement with CRC Custom Services LLC at Harbor lease #110. Alderperson Gaines seconded the motion. **VOTE:** Motion carried unanimously 4-0.

 - **a.** Adopt a Resolution authorizing publication of notice of intention to issue certificates of obligation for improvements to the City's harbor. (Not to exceed \$1,000,000)
 - **b.** Create a Special interest-bearing checking account to deposit the Harbor C/O funds.
 - **c.** Assign signatories to the above created account.
- **5. HARBOR CERTIFICATES OF OBLIGATION FUNDING** Review/Discuss and Consider sources of funds to pay the Harbor C/O's in the interim and long term, such as:
 - a. Utilize a portion of the \$0.0747 tax set aside for Streets through the end of the 2021 Fiscal Year amount to be determined then add tax to the 2022-2023 Tax Budget to off-set due to being capital improvement.
 - **b.** Preliminary review of possible harbor lease increases to pay for Certificates of Obligation.
 - **c.** Discuss potential amounts needed to pay for the EDA match plus have funds left over to perform further harbor improvements, depending on what is needed after the EDA grant is completed.
- **6. EXECUTIVE SESSION:** At any time, during the Special Meeting, the City Council may adjourn into an Executive Session, as needed, on any item listed, including the items listed here and which the Texas Government Code section 551 authorizes Executive Sessions to be held: Sections 551.071 (attorney consultation), 551.072 (Real Property), 551.073 (Gifts & Donations), 551.074 (Personnel), 551.076 (Security) and 551.087 (Economic Development).
