The City of Seadrift City Council will meet in a Special Called Meeting
on Thursday January 21, 2021 at 6:30PM

This meeting will be at 501 S. Main Street in Civic Center through the Council Chambers for the purpose of discussing/considering/reviewing and taking any action on the following agenda:

1. **INVOCATION & PLEDGES TO US FLAG AND TEXAS FLAG**
2. **PRESENTATION** – Hear a presentation from Matagorda Fisheries Cooperative. Consider, Discuss, Take any action that may be needed.
3. **NEW WASTE-WATER TREATMENT PLANT (WWTP) Capital Improvement Fee Update:** From Public Hearing Held at 6:15pm on January 5, 2021 and action taken during regular meeting implementing a \$2 fee on waste-water billing to be set aside and reserved to offset preliminary planning/engineering/design fees on new WWTP until such time that pending loan/grant guarantees are received. *NOTE: It was initially thought this would be a separate line item on the utility bill. HOWEVER, there are no longer any lines left to use on the utility bill as the lines of entry are maxed out. Therefore, the only way for this \$2 charge to appear on the utility bill is to add the \$2 fee to the waste-water portion of the bill, which will make it appear that there has been a \$2 increase in the waste-water bills. Alice says that she can separate this \$2 fee from the monthly revenue and place that in the Contingency Fund to be utilized exclusively for the purpose intended.*
CONSIDER/REVIEW/DISCUSS/TAKE ANY ACTION REGARDING THE WAY THIS FEE WILL APPEAR ON UTILITY BILL.
4. **SOLID WASTE** – Consider/Review/Discuss/Take any Action needed to deal with the Solid Waste Truck and Solid Waste Service.
5. **EXECUTIVE SESSION:** At any time, during the Regular Meeting, the City Council may adjourn into an Executive Session, as needed, on any item listed, including the items listed here and which the Texas Government Code section 551 authorizes Executive Sessions to be held: Sections 551.071 (attorney consultation), 551.072 (Real Property), 551.073 (Gifts & Donations), 551.074 (Personnel), 551.076 (Security) and 551.087 (Economic Development).
6. **ADJOURN**
