#### **WORK SESSION**

Mayor DeForest called the Work Session to order at 6:47 p.m. The City Council met in an Agenda Review Work Session to review the Meeting Agenda.

Work Session closed at 6:59 p.m.

#### **CALL TO ORDER**

Mayor DeForest called the meeting to order at 7 p.m.

#### 1. INVOCATION AND PLEDGE OF ALLEGIANCE

Tanya DeForest gave the invocation and Mayor DeForest led the pledge to the flags.

#### 2. CONSENT AGENDA

**MOTION:** Alderperson Gaines made the motion to approve the consent agenda as presented. Alderperson Johnson seconded the motion.

VOTE: Motion carried unanimously 5-0.

#### 3. DEPARTMENT HEAD REPORTS

#### a. POLICE

Seadrift Police Chief Leonard Bermea gave the Police Report for April 2022: 320 calls for service, 42 traffic stops, 38 reports written, and 0 arrests for the month. Chief Bermea stated that the City had a grant scoring of 88.6 and was number one in the region from GCRPC regarding the Patrol Unit Grant #4492801.

#### **b. MUNICIPAL COURT**

Municipal Court Clerk Marilyn Dufner read the Municipal Court Report for April 2022 with 14 new cases, 13 closed cases, 122 current cases, and \$2,405.75 fines collected for the month.

#### c. PUBLIC SAFETY

Alderperson Brigham did not have a report.

#### d. PERMITS

Mayor DeForest read the Permit Report for April 2022 with a total gross property valuation increase of \$408,562.

#### e. CODE ENFORCEMENT

Mayor DeForest read the Code Enforcement Report for April 2022 with no tall/weeds/grass/clean-up letters sent out for the month.

#### f. HARBOR

Alderperson Hunt did not have a report. Mayor Deforest stated that the EDA Grant Project is waiting for the long-term lease to be approved.

### g. PARKS AND RECREATION

Alderperson Gaines did not have a report but stated that repairs were continuing on the Bayfront with the Restroom and the Shoreline Project. Alderperson Gaines asked residents to be aware of vehicles and equipment moving around on Bay Avenue.

#### h. STREETS AND DRAINAGE

Alderperson Brigham did not have a report but stated that the City was looking at a few roads to start rebuilding. Mayor DeForest stated that the City was not sure how much it would be able to accomplish this year due to spending from the previous fiscal year. He continued that the County also is being slow in completing their own work and have not figured out what to do regarding ordering materials yet. The Mayor stated that any street work that gets done will be started later than normal, but a list maybe be presented for review at the next meeting.

#### i. UTILITIES

Alderperson Reese read the Utility report for April 2022 with 1 water tap installed at Swan Point Landing. Alderperson Reese also stated that the TCEQ Agreed Order and SEP Project were completed and submitted on April 20, 2022, and March 7, 2022, respectively.

#### j. SOLID WASTE

Alderperson Johnson did not have a report but asked that residents clean their totes as flies were getting bad.

#### k. GENERAL

Mayor DeForest read the General Fund report for April 2022 with 4 driveway culverts installed and 11 burn permits issued for the month.

### DEPOSITORY CONTRACT AND PLEDGE AGREEMENT

THE STATE OF TEXAS COUNTY OF CALHOUN

- 1. FIRST NATIONAL BANK, PORT LAVACA, TEXAS, a national banking corporation with its principal place of business situated in Port Lavaca, Calhoun County, Texas, (the BANK), hereby PLEDGES, ASSIGNS, TRANSFERS AND DELIVERS the securities described in Exhibit "A" (which description shall include the actual market value thereof) attached hereto and made a part hereof for any and all purposes, to the CITY OF SEADRIFT, TEXAS, a municipal corporation duly incorporated and existing under the laws of the State of Texas (the CITY), upon the terms and conditions and for the purposes hereinafter set forth.
- 2. The conditions of this contract are such that on the 3rd day of May , 2022, the Bank was duly and legally chosen by the City Council of Seadrift, Texas, as depository for all funds of said City for a period beginning on the date of execution of this instrument and until the expiration of said relationship as defined by the bid specifications for selecting said depository.
- 3. If the Bank shall faithfully do and perform all of the duties and obligations devolving upon its law as a depository of the City, and shall upon presentation pay all checks drawn on it against collected funds of such City on demand deposits, by the duly authorized officers of the City, shall faithfully keep and account for all funds deposited with it, and shall pay interest at the time and at the rate hereinbefore stipulated, and shall otherwise comply with the requirements of the law governing depositories in Texas, and shall at the expiration of the term for which it has been chosen turn over to its successor, all funds, property and things of value coming into its hands as depository, then and in that event, this contract is to become null and void, and the securities above mentioned shall be returned to the Bank, otherwise to remain in full force and effect.
- 4. The Bank hereby authorizes the City, upon default of any of the Bank's obligations hereunder and at any time thereafter during the continuance of such default, to sell at public or private sale, with or without notice to the Bank, the pledged securities or any part thereof and to apply the proceeds of sale to the satisfaction of any indebtedness arising by virtue of the violation of any of the conditions of this contract. This right is in addition to the other remedies which the City may have under this contract and without prejudice to its right to maintain any suit in any court for redress for any injuries sustained by the City under this contract. Such securities shall stand as security for funds deposited under the preceding contract until fully accounted for.
- 5. It is contemplated that the amount of funds deposited under this contract shall vary from time to time. Pledges of securities of market value, exclusive of accrued interest, in excess of deposits shall not be required to be maintained. However, the City shall have the right upon notice to require the pledge of additional securities hereunder, not to exceed the amount on deposit with the Bank, and likewise upon notice

the Bank shall have the right to withdraw securities the market value of which is in excess of the amount required.

- The securities pledged under this agreement shall be deposited in trust as more particularly set forth in Exhibit B attached hereto and made a part hereof for any and all purposes. In the event the Bank desires to substitute a security or securities for any security or securities already pledged, due and reasonable notice shall be given to the City. The Bank shall have the right to substitute eligible securities for all or any part of the securities pledged hereunder. When an exchange is desired, the Bank shall make application to the City, and submit a list of securities proposed to be exchanged and specify the securities which it desires to withdraw. If the securities so proposed intended for substitution are of the kind, character, amount and value required by law, and the depository specifications, such substitution shall be permitted. If granted, the substituted securities shall thereafter be subject to all the terms and conditions of this contract as fully as if originally incorporated herein.
- The Bank agree not to discriminate in the performance of this Agreement on the basis of race, color, national origin, sex, age religion, creed, martial status, disabled, or presence of any physical, mental, or sensory handicap. To the extend applicable, The Bank shall comply with all federal, state and local laws regarding non-discrimination, equal employment opportunity, affirmative action and occupational-safety health concerns, shall comply with all applicable rules and regulations thereunder, and shall comply with same as each may be amended from time to time.
- All of the provisions and requirements of the law governing depositories for cities shall be a part of this contract.

#### **RESOLUTION NO. 20220503**

A RESOLUTION OF THE CITY OF SEADRIFT, TEXAS FINDING THAT AEP TEXAS INC.'S APPLICATION TO **AMEND** ITS **DISTRIBUTION COST** RECOVERY **INCREASE** DISTRIBUTION **FACTORS** TO RATES THE SHOULD WITHIN CITY  $\mathbf{BE}$ **DENIED:** AUTHORIZING PARTICIPATION WITH THE CITIES SERVED BY AEP TEXAS; AUTHORIZING HIRING OF LEGAL COUNSEL; FINDING THAT THE REASONABLE RATE CASE EXPENSES SHALL BE REIMBURSED BY THE COMPANY; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; REQUIRING NOTICE OF THIS RESOLUTION TO THE COMPANY AND LEGAL COUNSEL.

WHEREAS, the City of Seadrift, Texas ("City") is an electric utility customer of AEP Texas Inc. ("AEP" or "Company"), and a regulatory authority with an interest in the rates and charges of AEP; and

WHEREAS, the City is a member of the Cities Served by AEP ("Cities"), a membership of similarly situated cities served by AEP that have joined together to efficiently and cost effectively review and respond to electric issues affecting rates charged in AEP's service area; and

WHEREAS, on or about April 6, 2022 AEP filed with the City an Application to Amend its Distribution Cost Recovery Factor ("DCRF"), PUC Docket No. 53451, seeking to increase electric distribution rates by approximately \$27.56 million (an approximately \$1.28 increase to the average residential customer's bill from the rates approved in the Company's most recent DCRF case); and

WHEREAS, all electric utility customers residing in the City will be impacted by this ratemaking proceeding if it is granted; and

WHEREAS, Cities are coordinating its review of AEP's DCRF filing with designated attorneys and consultants to resolve issues in the Company's application; and

WHEREAS, Cities members and attorneys recommend that members deny the DCRF.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEADRIFT, TEXAS:

- **Section 1.** That the City is authorized to participate with Cities in PUC Docket No. 53451.
- **Section 2.** That subject to the right to terminate employment at any time, the City hereby authorizes the hiring of the law firm of Lloyd Gosselink and consultants to negotiate with the Company, make recommendations to the City regarding reasonable rates, and to direct any necessary administrative proceedings or court litigation associated with an appeal of this application filed with the PUC.
- **Section 3.** That the rates proposed by AEP to be recovered through its DCRF charged to customers located within the City limits, are hereby found to be unreasonable and shall be denied.
- **Section 4.** That the Company shall continue to charge its existing rates to customers within the City.
- **Section 5.** That the City's reasonable rate case expenses shall be reimbursed in full by AEP within 30 days of presentation of an invoice to AEP.
- **Section 6.** That it is hereby officially found and determined that the meeting at which this Resolution is passed is open to the public as required by law and the public notice of the time, place, and purpose of said meeting was given as required.
- **Section 7.** That a copy of this Resolution shall be sent to Leila Melhem, American Electric Power Service Corporation, 400 West 15<sup>th</sup> Street, Suite 1520, Austin, Texas 78701 and to Thomas Brocato, General Counsel to the Cities, at Lloyd Gosselink Rochelle & Townsend, 816 Congress Ave., Suite 1900, Austin, Texas 78701.
