Six Key Figures

Arthur James Balfour — Foreign Secretary. Authored the declaration expressing formal support for a 'Jewish national home.' A devout Protestant who held messianic views about the return of Jewish people to Palestine as biblical fulfillment.

David Lloyd George — Prime Minister. Primary political architect. Believed a friendly Jewish settlement near the Suez Canal would secure a pro-British ally essential to imperial communications with India.

Herbert Samuel — Cabinet member and Zionist. Helped draft the declaration; became the first High Commissioner of Palestine.

Chaim Weizmann — Not a government official. An energetic Zionist spokesman who maintained personal relationships with Churchill, Lloyd George, and Balfour. The model of the external operator cultivating inner-circle access without holding office.

Lord Walter Rothschild — Primary financial intermediary. The declaration was addressed to him — not to the Board of Deputies of British Jews, the official representative body — because that body was

largely skeptical of political Zionism. The government intentionally bypassed the authentic community representative to work through a strategically aligned financial figure.

Edwin Montagu — Secretary of State for India. The only Jewish Cabinet member to oppose the declaration. His warnings are the most prophetic critique in this entire historical record.

Edwin Montagu's Prophetic Opposition

Montagu labeled the policy as "*inherently antisemitic*" — arguing that establishing a Jewish 'national home' would cast Jews everywhere as 'foreigners' in their own countries, providing antisemites the tool to demand expulsion and generating perpetual divided-loyalty charges against Jewish citizens worldwide. His prophecy was confirmed in full.

SECTION III: THE EPSTEIN NETWORK — FULL ANATOMY OF THE LEVERAGE INFRASTRUCTURE

The January 2026 declassification of approximately 3.5 million pages — released under the Epstein Files Transparency Act — constitutes the most significant public documentation of a private leverage infrastructure in American history. What follows is the documented record, held to the Devarim 19:15 evidentiary standard.

Scale: Trump References in the Epstein Files

A *New York Times* review found over **38,000 references** to Donald Trump, Melania Trump, and Mar-a-Lago across more than **5,300 separate documents**. Most references are benign — news articles, financial disclosures, correspondence. Specific files have drawn scrutiny:

- **Flight logs:** Trump appears in Epstein's private flight logs at least 8 times between 1993 and 1997.
- **FBI 302 summaries (2026 release):**Declassified interview notes from 2019 detail a woman's allegation that Epstein introduced her to Trump when she was a minor. This allegation is unverified. It is in the declassified record.
- **The 'Everyone Knew' call:**A summary of a 2019 FBI interview with a former Palm Beach police chief states Trump called him in 2006 saying: 'Thank goodness you're stopping him [Epstein], everyone has known he's been doing this.'
- **Congressional review:**Rep. Jamie Raskin (D-MD) stated Trump's name appears more than one million times in unredacted files. Rep. Thomas Massie (R-KY) joined bipartisan criticism of redacting prominent men's names while leaving victims' details exposed.

Official stance: The White House has described allegations as 'unfounded and false.' The DOJ found no credible evidence warranting criminal charges against the President. The covenant witness records official denials and the documented record equally.

The Wexner / Mega Group Connection

Leslie Wexner — founder of L Brands and Victoria's Secret — was Epstein's primary financial patron. Wexner gave Epstein power of attorney over his entire financial empire and transferred his Manhattan townhouse for \$0. Wexner is a leading member of the **Mega Group** — approximately 20 of the wealthiest Jewish American donors organized privately in 1991, meeting twice yearly, explicitly concerned with Israel's interests, outside all public accountability.

Ehud Barak — 30+ Documented Visits

Ehud Barak — former Israeli Prime Minister, former head of military intelligence, former Defense Minister — made more than 30 documented visits to Epstein's Manhattan townhouse. Barak was a co-investor in **Carbyne** (formerly Reporty Homeland Security), an Israeli tech startup. He received \$2.3 million from Wexner's foundation. The visits are documented. Their purpose has not been satisfactorily explained by any official source.

The Maxwell-Mossad Connection

Robert Maxwell — Ghislaine Maxwell's father — was a documented intelligence asset given a state funeral in Israel attended by the heads of Israeli intelligence services. The 2020 FBI memorandum from a Confidential Human Source described Epstein as a "**co-opted Mossad agent**" — trained to gather compromising information on powerful individuals. The FBI notes this is 'a claim under review.' Former Mossad director Yossi Cohen called it 'baseless.' The covenant witness records both.

The Paolo Zampolli Network — New April 2026 Documented Evidence

Paolo Zampolli — Italian modeling agent, founder of ID Models — introduced Donald and Melania Trump at the Kit Kat Club in September 1998. The 2026 Epstein file releases document:

- **Modeling-Epstein overlap:**Zampolli and Epstein reportedly partnered in a failed 2004 bid to acquire Elite Model Management. Epstein was a patron of Zampolli's agency, frequently present during casting auditions.
- **TerraMar Project:**Zampolli was named as one of four partners in Ghislaine Maxwell's TerraMar Project charity in 2013.
- **Wexner connection:**Zampolli has stated his relationship with Epstein was 'purely professional' because Epstein acted as a financial intermediary for Victoria's Secret and Les Wexner — Zampolli's biggest client.
- **Amanda Ungaro — the deportation scandal:**Zampolli's ex-partner, Brazilian model Amanda Ungaro, claims she was brought to the U.S. at age 17 on Epstein's private plane via French agent Jean-Luc Brunel, before being recruited by Zampolli. In March 2026, Zampolli reportedly used political clout to ask a senior ICE official to detain and deport Ungaro during a custody battle over their son. Following the reported deportation, Ungaro threatened to 'tear down the system,' alleging she has evidence of how the Trump-Zampolli-Epstein network operated.
- **Trump appointment — March 2025:**Despite this documented proximity, President Trump appointed Zampolli as U.S. Special Representative for Global Partnerships in March 2025. Critics describe this as ensuring his loyalty during ongoing Epstein investigations.

The 'Sweetheart Deal' — Prosecutorial Protection

Federal judge Kenneth Marra ruled that the 2008 non-prosecution agreement negotiated by then-U.S. Attorney Alex Acosta violated the Crime Victims' Rights Act by keeping victims in the dark. Acosta told Trump transition officials he had been told to back off because Epstein 'belonged to intelligence.' The republic question is: what system of power was capable of preventing effective prosecution of

documented crimes against minors for more than a decade, involving a private citizen with no elected office and no official role?

SECTION IV: THE FINANCIAL ARCHITECTURE — BILLIONAIRES, AIPAC, ESPIONAGE

Miriam Adelson — The Largest Individual Pro-Israel Benefactor

Miriam Adelson, widow of Sheldon Adelson, is the most significant individual pro-Israel financial patron of the Trump administration:

- **\$106 million:** Third-largest donor to Trump's 2024 presidential campaign.
- **\$250 million pledge:** In December 2025, at a Hanukkah reception at the White House, Trump publicly stated Adelson had offered \$250 million toward a potential third term.
- **West Bank annexation:** Reports from 2024 and 2025 allege Adelson's funding was tied to specific outcomes — most notably U.S. recognition of Israeli annexation of the West Bank. Her spokespeople have denied specific quid pro quo claims.
- **Marco Rubio appointment:** Adelson reportedly pushed for Rubio as Secretary of State in 2025. AIPAC officials have since boasted that Rubio provides them with 'access' to internal government discussions.

The constitutional question: When a single foreign-aligned donor contributes \$106 million to a presidential campaign, pledges \$250 million toward a future campaign, and is reported to have pushed for the appointment of a specific Cabinet official who then provides the donor's organization access to internal government deliberations — the constitutional republic's separation of private wealth from public governance has been functionally dissolved.

AIPAC 'No Conditions' Red Line — 2026

Internal reports confirm AIPAC has shifted to enforcing a specific "No Conditions" policy — any U.S. official who supports conditioning military aid to Israel on humanitarian compliance is targeted for electoral defeat regardless of party or seniority.

- **The Malinowski warning:** \$1.5 million against Malinowski in January 2026 explicitly because he supported conditioning aid. Described internally as enforcing the red line.
- **Shell PAC funding:** A March 2026 investigation found AIPAC funneled over \$5 million through shell PACs to obscure its involvement in certain high-tension primaries — raising direct FARA and campaign finance disclosure questions.

Brad Parscale / Clock Tower X — Full Contract Detail

According to FARA filings from early 2026, the Israeli Ministry of Foreign Affairs expanded its contract with **Clock Tower X LLC**, led by former Trump campaign manager Brad Parscale, to **\$9 million** (\$1.5 million monthly). Key contract terms documented in the FARA filing:

- **Target:** Generation Z through TikTok, Instagram, and YouTube.
- **KPIs:** Over 100 ads per month; 50 million impressions.
- **AI integration:** The contract specifically aims to influence the output of Artificial Intelligence models and distribute pro-Israel content through 'newly created websites' that appear as independent news sources.
- **Havas Media:** A French PR firm serves as intermediary to carry out nationwide messaging, framed as 'combating antisemitism' while boosting pro-Israel policy narratives.

This is a foreign-government-funded operation targeting American citizens with manufactured editorial content. It is not lobbying. It is information environment capture — designed to make a foreign government’s preferred narratives appear to be organic American independent journalism. Under any honest application of the republic’s own First Amendment framework, citizens have the right to know when content is foreign-government funded.

Unit 8200 and the Silicon Valley Intelligence Pipeline

Unit 8200 is the elite Israeli signals intelligence unit — the equivalent of the NSA. Former Unit 8200 veterans occupy key roles at Palo Alto Networks, Check Point, and CyberArk, and have transitioned into positions at Google, Meta, Microsoft, and Amazon Web Services. Related firms founded or led by Unit 8200 alumni are valued at approximately \$160 billion as of 2025.

Investigative reports (2025) allege a 'secret mechanism' built into Project Nimbus — cloud computing contracts between Israel and Google and Amazon — designed to alert the Israeli government whenever foreign law enforcement, including U.S. agencies, accesses their data.

The covenant witness is not asserting that every former Unit 8200 officer in American tech is an active intelligence asset. The witness is asserting that the concentration of foreign military intelligence veterans in the infrastructure that processes, stores, and routes American citizens’ data is a republic-level security question that has not received republic-level scrutiny.

Key documented friction: Trump instructed Netanyahu to stop Lebanon strikes, forcing a ceasefire. Israeli hardline factions found 'premature.' Trump signaled openness to an Iran nuclear deal that has 'blindsided and upset' Netanyahu. Anonymous White House officials expressed frustration in May 2025, sarcastically claiming Netanyahu had visited '700 times.' Trump has invited the leaders of Israel and Lebanon to the White House for direct talks — the first meaningful engagement since 1983, which some Israeli officials view as premature.

The covenant witness holds the tension precisely: individual policy friction between two leaders does not equal structural independence of the republic's legislative, financial, and information systems. A president can resist specific demands while the infrastructure around him remains captured.

- **The Epstein declassification:** 3.5 million pages now in the public record. The leverage infrastructure's existence cannot be recalled.
- **AIPAC FARA exposure:** Bipartisan congressional pressure for AIPAC FARA registration reached new levels in 2026. The exemption has not been revoked. It is no longer invisible.
- **AIPAC's own limits:** The Laura Fine loss in IL-09 despite \$7M+ in outside spending demonstrates that money does not always prevail, even for the most powerful electoral infrastructure in America.

Covenant Analysis
