PREFATORY NOTE

This document is a formal follow-up to the Miqdash Bethel Covenant Institution's previously issued study on Courtney Bonneau. It does not repeat biographical or background material already established in that record. Its sole purpose is to **document and covenant-examine the updated field findings** that Bonneau has produced since the resumption of active combat in Lebanon on March 2, 2026, with specific attention to her ongoing documentation of Geneva Convention violations that indict the State of Israel under international humanitarian law and under the covenant standard of **Yahweh**.

All claims in this document are corroborated by a minimum of two independent authoritative sources in accordance with the *Devarim* (Deuteronomy) 19:15 research standard. Wikipedia has been used for orientation only and is not cited as a primary authority.

PART I — THE WITNESS

COURTNEY BONNEAU'S FIELD POSITION: MARCH 2 – MAY 12, 2026

Courtney Bonneau has remained in South Lebanon continuously since March 2, 2026 — the date Israeli forces launched their full-scale invasion. She is reporting from active conflict zones including **Saida (Sidon)**, **Tyre (Sour)**, **Nabatieh**, **Bint Jbeil**, and **the border area**, often moving under armed drone surveillance. In a documented account from late April 2026, she described driving ten kilometers through southern Lebanon

without seeing a single person, followed the entire distance by an armed drone — an experience she offered as a snapshot of the daily reality for Lebanese civilians who have not fled.

By the time of this writing, Bonneau has survived targeted death threats, Israeli military loudspeaker warnings directed at journalists, and proximity to multiple airstrikes. She has documented these events in real time across her field reports, her Instagram account (@courtneybonneauphotography, 44,000+ followers), and her X account (@cbonneauimages). Her footage and photographs are being reviewed by legal colleagues who have confirmed the record meets the evidentiary threshold for submission to the International Criminal Court.

Her stated summary of conditions as of April 29, 2026, in her own words: "What's happening here is apocalyptic."

PART II — THE GENEVA RECORD

SIX CATEGORIES OF DOCUMENTED VIOLATION

Bonneau's field documentation, corroborated by Amnesty International, the International Bar Association Human Rights Institute (IBAHRI), the World Health Organization (WHO), the UN Office of the High Commissioner for Human Rights (OHCHR), the Committee to Protect Journalists (CPJ), Médecins Sans Frontières (MSF), the Lebanese Centre for Human Rights (CLDH), and the International Federation of Journalists (IFJ), establishes six distinct categories of Geneva Convention violation.

VIOLATION ONE — SYSTEMATIC TARGETING OF JOURNALISTS

The deliberate targeting of journalists carrying press credentials and performing civilian documentary work is a war crime under **Additional Protocol I, Article 79** to the Geneva Conventions. A journalist in a combat zone is a civilian and must not be treated as a combatant.

The Killing of Amal Khalil — April 22, 2026. Al-Akhbar correspondent **Amal Khalil** and her colleague Zeinab Faraj were reporting on Israeli strikes in southern Lebanon when an Israeli drone targeted their vehicle. The two took cover in a nearby building. Khalil notified Lebanese officials and family of their location. The building was then struck, collapsing it. When rescuers attempted to extract her, Israeli forces fired on the emergency workers. Khalil remained trapped under rubble for more than seven hours while the Red Cross was prevented from reaching her. She died. Zeinab Faraj survived but was wounded.

Courtney Bonneau's immediate witness statement: **"This was a blatant murder. This was a targeted assassination. The Israeli army committed multiple flagrant war crimes this afternoon, during this incident."**

Lebanese Prime Minister Nawaf Salam confirmed in a formal government statement that the strikes on the journalists constituted war crimes. The CPJ's Middle East director, Sara Qudah, condemned the conduct as **"a brutal and recurring crime."** The IFJ at its Centenary Congress in May 2026 passed a formal motion calling

on the UN Human Rights Council to establish an independent commission of inquiry into the systematic killing of journalists by Israeli forces in Lebanon.

The documented scale: At least **259 journalists and media workers** have been killed by Israeli forces since October 2023, spanning Gaza and Lebanon. At least **nine journalists** were killed in Lebanon alone between March 2 and mid-April 2026, including three killed in a single drone strike on their vehicle on March 28, 2026.

UN Special Rapporteurs on freedom of expression, extrajudicial killings, and counter-terrorism jointly confirmed in an April 2, 2026 statement that the deliberate targeting of journalists not participating in hostilities amounts to **"a serious violation of international human rights and humanitarian law and a war crime."**

VIOLATION TWO — SYSTEMATIC TARGETING OF MEDICAL WORKERS AND AMBULANCES

The Fourth Geneva Convention (1949), Article 18, prohibits the targeting of civilian hospitals under any circumstances. Additional Protocol I, Articles 12 and 15, extend full protection to all medical personnel, units, and transport. Willful attacks on protected medical entities constitute grave breaches of the Conventions — rising to the level of war crimes under **Rome Statute Article 8(2)(b)(ix)**.

Bonneau's field testimony, April 29, 2026: "Israel is systematically targeting hospitals, medical workers — in fact, last night the Israeli army besieged more ambulance drivers. So they've killed over a hundred medical professionals since March 2nd. That's a hundred. Now it's a hundred and three."

The CLDH’s legal analysis confirms: even if medical facilities had been misused for military purposes — **which Israel has claimed without providing any evidence** — international humanitarian law requires a prior warning, a reasonable time limit for cessation, and confirmation of non-compliance **before any strike is lawful**. Israel produced none of these procedural requirements. Amnesty International noted that the Israeli military is deploying **“the same deadly playbook it used in 2024 in Lebanon”** — a documented pattern, not isolated incidents.

VIOLATION THREE — DOUBLE-TAP STRIKES TARGETING FIRST RESPONDERS

“Double-tap” strikes — a method in which a location is bombed, and then struck again when rescuers arrive — are among the most unambiguously prohibited conduct in international humanitarian law. They constitute deliberate attacks on rescue operations and are classified as war crimes under AP I, Article 15 and Rome Statute Article 8(2)(b)(ix).

The IBAHRI documented **101 incidents involving ambulances and double-tap strikes** targeting first responders between March 2 and mid-April 2026. The killing of Amal Khalil on April 22 described above is the definitive documented case: Israeli forces struck a location, waited for rescuers to respond, then struck again — and then fired on Red Cross workers attempting to reach her. This constitutes not one but three overlapping war crimes within a single incident.

UN Geneva correspondents confirmed at the April 10, 2026 press briefing: **"There are no warnings for the bombardments. This is against any Geneva Convention, any international convention."**

VIOLATION FOUR — CIVILIAN BOMBARDMENT WITHOUT WARNING

Additional Protocol I, Article 57(2)(c) requires all feasible precautions in attack, including effective advance warning of attacks that may affect the civilian population, except where circumstances do not permit. The OHCHR, WHO, and UN Geneva press briefings have all confirmed that Israel has repeatedly struck civilian areas — residential buildings, shelters for displaced persons, health facilities — **without issuing any prior warning.**

Bonneau documented the March 5, 2026 Israeli airstrike on the **Ghazali family** in Mashghara, in which four family members were killed while gathered for Iftar during Ramadan. The IDF claimed the father was a Hezbollah commander — providing no evidence — while making no mention of the children killed alongside him. This pattern — labeling any male casualty a "commander" after the fact — has been confirmed by multiple independent journalists and human rights monitors as a systematic method of retroactive justification.

On April 8, 2026 — the single deadliest day since the invasion began — Israeli forces struck more than **100 targets across 50 locations**, killing more than 300 people according to Lebanon's Ministry of Health, with over 1,100 additional injuries. WHO confirmed Beirut's two major hospitals — Rafik Hariri University Hospital and Al Zahraa Hospital — were filled to capacity, with no reserve capacity for additional mass casualties.

The Israeli evacuation orders issued across southern Lebanon — including orders covering areas between the Litani and Zahrani rivers — have been assessed by the OHCHR as potentially constituting **forced displacement, prohibited under international humanitarian law.**

VIOLATION FIVE — DOMICIDE AND DEMOGRAPHIC DESTRUCTION OF LEBANESE TERRITORY

Bonneau has systematically documented what she describes as the "Gaza model" being applied to southern Lebanon: the complete demolition of entire towns and villages, reducing inhabitable communities to rubble. This characterization has been independently confirmed by the **New York Times** in an April 2026 investigative report with satellite imagery and ground-level photographs showing widespread demolitions flattening at least two dozen towns and villages near the border.

On March 24, 2026, Israeli Defense Minister Katz formally announced that Israel would **demolish Lebanese border villages and occupy southern Lebanon up to the Litani River.** Netanyahu followed with a public statement calling for a permanent security buffer zone. As of this writing, Israel has stationed troops 8–10 kilometers inside Lebanese sovereign territory.

The humanitarian toll:

Bonneau has described this not as military operation but as **ethnic cleansing by architecture** — the systematic removal of a civilian population from their land through the destruction of the homes they would return to, a practice that violates the prohibition against collective punishment under the Fourth Geneva Convention, Article 33, and AP I, Article 85.

VIOLATION SIX — WESTERN MEDIA SUPPRESSION AND COMPLICITY

On May 3, 2026, Bonneau issued a public statement via her X account that has since been widely circulated:

"The level of complicity of the BBC in the ethnic cleansing of southern Lebanon is shocking. I am listening to their Jerusalem correspondent report that the 'IDF are striking Hezbollah targets' while I'm on the ground in the middle of it watching men, women and children being killed on a daily basis. My colleagues are being executed. Paramedics are being systematically murdered. All of this is happening in plain sight and the BBC correspondent here in Lebanon knows it."

This statement followed an earlier April 18 Bonneau observation in which she documented the BBC reporting that the ceasefire was "holding" while **Israel continued to murder civilians and demolish civilian homes in violation of it**. The BBC's framing of IDF strikes as "Hezbollah targets" while on-the-ground witnesses document civilian mass casualties represents the international information suppression that allows the documented atrocities to continue without political consequence.

The covenant community recognizes this suppression as a form of **bearing false witness to protect injustice** — a violation of the prohibition in **Shemot** (Exodus) 23:1–2, which commands: do not spread a false report; do not follow a multitude to do evil. A reporter who knows and conceals is not a journalist — he is a participant.

PART III — CORROBORATING INSTITUTIONAL RECORD

MULTI-SOURCE VERIFICATION UNDER DEVARIM 19:15

The covenant standard of **Devarim** (Deuteronomy) 19:15 — that no matter shall be established by one witness alone but by two or three — has been rigorously applied throughout this document. The following table identifies each confirming institutional voice:

PART IV — THE COVENANT VERDICT

Behold, the princes of Israel in you, every one according to his power, have been bent on shedding blood. Father and mother are treated with contempt in you; the sojourner suffers extortion in your midst; the fatherless and the widow are wronged in you.

(EXODUS)
23:1-2**

You shall not spread a false report. You shall not join hands with a wicked man to be a malicious witness. You shall not fall in with the many to do evil, nor shall you bear witness in a lawsuit, siding with the many, so as to pervert justice.

COVENANT VERDICT — MIQDASH BETHEL COVENANT INSTITUTION

The documented record established by Courtney Bonneau and confirmed by ten independent institutional witnesses constitutes a comprehensive indictment of the State of Israel under international humanitarian law and under the covenant standard of Yahweh as recorded in the Tanakh. The shedding of innocent blood — of journalists, of healers, of children at Iftar, of families in their homes — pollutes the land under Bemidbar 35:33. The systematic suppression of this testimony by Western media organs violates the prohibition of Shemot 23:1-2. The State of Israel cannot invoke the name or the covenant of Yahweh while its hands are full of blood. The covenant community is called to bear accurate witness, to refuse the false report, and to demand accountability — because the earth belongs to Yahweh, and every life taken without justice will be required of those who took it.

PART V — THREE-RELIGION AUDIT

COVENANT REACH: JUDAISM, CHRISTIANITY, AND ISLAM

Miqdash Bethel Covenant Institution reaches Judaism, Christianity, and Islam simultaneously through the covenant of **Yahweh**. On the documented crimes in Lebanon, all three traditions speak with one voice through their foundational texts.

<p>ISLAM</p>	<p>The Qur'an establishes: "Whoever kills a soul — unless for a soul or for corruption in the land — it is as if he had slain all mankind" (Surah Al-Ma'idah 5:32, affirming the Torah principle). In Islamic jurisprudence, the killing of non-combatants, women, children, and those performing humanitarian service — doctors, journalists — is prohibited without exception across all schools of fiqh. The targeting of healing and rescue operations violates the mercy (<i>rahmah</i>) that stands at the center of Islamic covenant ethics. The Lebanese civilian population — Muslim and Christian alike — deserves the protection of every tradition that claims the name of the God of Abraham.</p>

As reported by Courtney Bonneau via her field account on May 12, 2026, citing Lebanon's Ministry of Public Health: since Israel's invasion of Lebanon began on March 2, **3,000 men, women, and children have been killed** and **10,000 wounded**. Of those, **380 have been killed since the ceasefire** was announced on April 17 — a ceasefire that Israel has violated every day since it took effect, through continued airstrikes, drone attacks, and the systematic demolition of Lebanese homes and civilian infrastructure.

The trajectory of the toll confirms what Bonneau has documented on the ground since day one: the killing did not pause for the ceasefire. It continues as this document is written.

THE NABATIEH DOUBLE-TAP: CIVIL DEFENSE WORKERS KILLED WHILE RESCUING THE WOUNDED

Among the most recent documented incidents in Bonneau's May 12 report: **two civil defense workers were killed in Nabatieh** while attempting to rescue injured civilians. Israel employed what is formally termed a **"double-tap" strike** — the same method documented throughout this study in which a location is first struck to produce casualties, and then struck again when rescuers arrive, converting the rescuers themselves into targets.

The Lebanon Health Ministry has described this pattern as **"a continuing pattern of grave violations of International Humanitarian Law."** The IBAHRI has documented 101 such ambulance and double-tap incidents since March 2. The Nabatieh civil defense deaths bring this pattern into its most recent expression: **those who run toward the wounded are being killed alongside them.**

On May 9, 2026, three days before this report, a Syrian father and his 12-year-old daughter were killed by three successive drone strikes in Nabatieh — the same district. The drone struck once. The father and daughter moved away. The drone struck again, killing the father instantly. The daughter moved approximately 100 meters and was struck a third time. She was taken to hospital but did not survive. Bonneau stood over the rubble and said:

"To my Western followers, I really want you to think critically about the definition of terrorism — to whom it gets applied and who does it benefit. Because where I've been sitting for the last 18 months, this mass murder, this mass destruction, this ethnic cleansing of south Lebanon — this looks a lot like terrorism to me."

The covenant community affirms Bonneau's framing. The definition of terrorism — the deliberate targeting of civilians to produce fear, submission, and displacement — fits the documented pattern in Lebanon with precision. The label is withheld by Western governments and Western media because the party doing the targeting is a state ally. **Yahweh** does not sort by alliance. **Bemidbar** (Numbers) 35:33 requires accounting for every innocent life regardless of the political identity of the hand that shed it.

Bonneau's standing witness on the November 2024 to March 2, 2026 "ceasefire": "Every single person they killed was a civilian. Every single one."

That prior ceasefire claimed 331 Lebanese lives — 127 of them independently confirmed civilians — before the current invasion resumed on March 2. The pattern is consistent across both ceasefire periods: Israel kills during ceasefires. It kills under ceasefires. It names the killing after the fact. The naming does not change what **Yahweh** sees. **Tehillim** (Psalms) 94:3–7 speaks directly to this:

"How long shall the wicked, O Yahweh, how long shall the wicked exult? They pour out their arrogant words; all the evildoers boast. They crush Your people, O Yahweh, and afflict Your heritage. They kill the widow and the sojourner, and murder the fatherless; and they say, 'Yahweh does not see; the Elohim of Jacob does not perceive.'"

Yahweh sees. The record stands. 3,000 men, women, and children. Their blood cries out from the ground.

INSTITUTIONAL CLOSING

This covenant witness document is issued in the name of **Yahweh**, the Elohim of Israel, whose covenant is not the property of any state, army, or political ideology. Courtney Bonneau remains in the field. The record she is building — at personal cost and mortal risk — is a record that cannot be undone by denial, by silence, or by false reports. **Yahweh** does not hear the prayers of those whose hands are full of blood (**Yeshayahu 1:15**). The earth is **Yahweh's**, and the fullness thereof. It will not be held in injustice without an answer.
