

## WHAT TO DO IN THE EVENT OF A HOMEOWNERS CLAIM

## AFTER THE FACT ..... AFTER THE INITAL CLAIM HAS OCCRRED

STOP AND REMAIN AS CALM AS POSSIBLE

TAKE A LOOK AT THE SITUATION AND WHAT IS HAPPENING? IS IT A BURGLAR STEALING, IS IT A WINDSTORM OR IS IT A FIRE? BASED ON WHAT IS HAPPENING THEN YOU CAN DECIDE WHAT TO DO.

IF IT IS A BURGLAR, GO TO A SAFE PLACE OF YOUR HOUSE OR IF YOU CAN GET OUT OF YOUR HOUSE, MAKE THE SAFEST DECISION POSSIBLE AND CALL 911 IF AT ALL POSSIBLE

IF IT IS A WINDSTORM, FIND A SAFE PLACE IN YOUR HOUSE SUCH AS THE BASEMENT OR THE INNER MOST ROOM OF YOUR HOUSE IF YOU DO NOT HAVE A BASEMENT

IF IT IS A FIRE MAKE SURE YOU AND YOUR FAMILY MEMBERS OR WHOEVER IS INSIDE , PLUS YOUR PETS, GET OUT OF THE HOUSE AS SOON AS POSSIBLE

ALL OF THESE EVENTS ARE SUPER TRAMATIC, BUT YOU AND YOUR FAMILIES PERSONAL SAFETY IS THE FIRST PRIORITY ITEMS INSIDE THE HOUSE OR THE HOUSE ITSELF CAN BE REPLACE, BUT YOUR LIFE AND YOUR LOVED ONES LIFES CAN NOT. CALL THE POLICE IF THERE WAS A BURGLARY OR CALL THE FIREDPARTMETN IF THERE WAS A FIRE OR IF THERE WAS STRUCTRUAL DAMAGE TO THE HOUSE BECAUSE OF WIND OR SOME OTHER INSTANCE

THEN CALL THE INSURANCE COMPANY AND LET THEM KNOW WHAT HAS TAKEN PLACE

YOU WILL NEED TO KNOW SPECIFICS OF THE EVENT TO LET THEM KNOW WHAT HAPPENED. ALL EXAMPLE : TIME , DATE , CAUSE OF LOSS OR ESTIMATED CAUSE OF LOSS WHAT DAMAGE HAS OCCURRED IF YOU CAN TELL RIGHT AWAY

SOMETIMES YOU WILL NOT BE ABLE TO TELL THEM WHAT WAS STOLEN OR WHAT WAS LOST RIGHT AWAY AND THAT MAY TAKE SOME TIME TO COME UP WITH A LIST OR PHOTOS OF BELONGINGS THAT WERE DAMAGED OR STOLEN

IF THERE WAS PHYSICAL DAMAGE TO THE HOUSE YOU WILL HAVE TO CALL A CONTRACTOR TO GET AN ESTIMATE OR DAMAGE ASSESMENT ON THE HOUSE BASED ON THE SITUATION, THINGS CAN DEVELOP AFTER THE FACT OF THE INITIAL CLAIM BUT TO GET IT CALLED IN AND THE PROCESS STARTED IS KEY TO HELP TO RESOLVE THE DAMAGE AS SOON AS POSSIBLE.

IF THERE ARE HOLES IN THE ROOF FROM A WINDSTORM OR THERE IS HOLES IN THE SIDING FROM TREES HITTING THE HOUSE OR HAIL, TAKE AS MUCH PRECAUTION ON NOT LETTING FURTHER DAMAGE OCCUR AFTER THE FACT SOMETIMES YOU CAN TARP YOUR ROOF IF POSSIBLE OR THE CONTRACTOR YOU CALL CAN COME OUT AND TARP THE ROOF OR DAMGED PORTION OF THE HOUSE SO NO FURTHER DAMAGE OCCURS
