Pledge of Allegiance

Jim Casey reports on Last month: fire department talked about space heater safety. Asked officer about crash data. Talked about car shop on Tremont and pine street that is in the street. Prepared for Earthday May 15

Engine 21 update: Lieutenant Lehman-

- Cincinnati fire department trying new things to service the community more efficiently: Chase cars= officer, firefighter, paramedic team to go on lesser severity dispatch with ambulance instead of engine to decrease number of runs. Runs have increased every year for the past 10-12 years. Peak Demand Ambulences= 10 am -10 pm to cover areas of high volume during the day. Allows us to spread out the runs. Ran pilots in January and currently processing data.
- 2. Fire Safety: If you are in an apartment complex, grilling on the balcony is not allowed unless there is an approved sprinkler system. Don't put your grill to close to an overhang at home.
- 3. Summer Safety: Kids are out of school, running around in the streets- look out for rambunctious kids running and biking. Look out for kids safety swimming. Swim at the proper places, always with friends, and with an adult.

Officer Gottman: News from District 3

- 1. Neighborhood report: slightly more crime- uptick in burglary at the storage facility, homes, auto theft.
- 2. Tremont and Pine tree: one towed, two more appear, working on it
- 3. Illegal dumping- use Cincy 311
- 4. BP has a new owner who is applying for a new liquor license. Run volume at the location is consistent over the years, regardless of when the liquor license has been in act. Jim: Community Council has fought for years to remove liquor license from the BP. We consistently say we do not want a liequor license at that location and no matter what they get it.
