

HAWLEY TOWNSHIP MEETING MINUTES

Location: 405 6th St. Hawley

Date: May 5, 2026

Chairman Rick Weaver opened the meeting at 7:00 pm with the Pledge of Allegiance.

Present: Chairman Rick Weaver, Supervisor Everett Nelson, Supervisor Keith Cederberg, Treasurer Alissa Wang, Clerk Denise Graunke, Scot Manthe and Claudia Murray.

Approval/Additions to the agenda: Nelson moved to approve with the addition of discussing Scot's development, Cederberg second, motion passed unanimously.

Public Comment: Discussion moved to Manthe and his development. There seems to have been a culvert that had possibly removed at one time. He is suggesting once the South side is dry, he could have it flow to the North, and Matt from Buffalo River Watershed seems OK with this suggestion. Also, they'd need to reset the culvert on Paul's side.

As for the Bond, the township will accept liability insurance of \$1.5 million and a line of credit will suffice, and Manthe has provided cash bond.

Nelson moved that, after meeting with the engineer, and their approval, and the township approves with proceeding with the road building. In addition, once the watershed approves, the township approves clearing of the road ditch north of Manthe's proposed road to the driveway to the North. Cederberg second, motion passed unanimously.

Treasurer's Report: Cederberg moved to approve, Nelson second, motion passed unanimously.

OLD BUSINESS

General Business:

1. Joint Annexation Resolution between Township and City: City is wanting to annex additional 80 acres South, which was not previously discussed. City has already annexed Gloryland, and clerk received check for \$7,336 for tax revenue lost.
2. Web site, .gov address - clerk is working on in May
3. Attorney bill for Manthe's Subdivision: We will settle once all engineering costs are completed

Road and Bridges:

1. Larson Hearing Update - This is between just the attorneys at this point.
2. Amendment to Road Gravel Policy, Driveway Access Police - Attorney has to review

Fire and HERT:

1. Review of 1998 Joint Powers Agreement: They are reviewing to have the limit for board approval to go from \$2,500 to \$5,000. The agreement is to be reviewed every 5 years. They will include a line item for legal fees and to have the Board and an attorney review going forward. They will also allow up to 30 members on the fire department.

Landfill: They are doing water testing at the Weaver stock pond and at Ekres. The county pays for this testing. There is a question whether the township received the check for having the landfill (\$7,500). Clerk to check.
