Missouri State Statute 320.302 Volunteer fire protection association may respond to any emergency within its area regardless of whether the property owner or individual is a member of or subscriber to the association. In responding to emergencies of non-members or non-subscribers, the volunteer fire protection association may charge up to the following fees:

1. One hundred dollars for responding to an emergency;
2. Five hundred dollars for each hour or a proportional sum for each quarter hour spent providing emergency services; plus
3. An amount equal to one year's membership or subscription fees.

No property owner or individual shall be liable for fees or charges under this subsection if said property owner or individual notifies the volunteer fire protection association in writing, prior to the occurrence of any emergency, not to respond to an emergency on or involving his/her property.
