FAMILY RESPONSIBILITIES AND AGREEMENT TERMS

By signing this agreement, the family agrees to adhere to the following terms:

- 1. **Annual Basis:** This scholarship agreement is made on a yearly basis. No assumption of automatic renewal or continuation past the current school year is implied. Renewal requires a new application and approval process.
- 2. **Financial Obligations:** The family agrees to pay the remaining 50% tuition balance and all additional fees including but not limited to: registration fees, book fees, activity fees, field trip costs, lunch fees, and any specialized program costs in a timely fashion according to the agreed payment schedule.
- 3. Confidentiality: All conversations and details concerning this scholarship agreement are to remain confidential between the family and RLA administration. This helps protect the privacy of all families and maintains the integrity of our financial aid program.
- 4. Academic and Behavioral Standards: The student must maintain satisfactory academic progress and adhere to all school policies, including the Code of Conduct and recovery support requirements as outlined in the Student Handbook.

- 5. **Recovery Commitment:** Given RLA's specialized mission, the family commits to actively supporting the student's recovery journey, including participation in required Alternative Peer Group (APG) programs and compliance with all recovery-related policies.
- **6. Communication and Cooperation:** The family agrees to maintain open communication with RLA staff and participate in required meetings, conferences, and support activities as needed for student success.

SCHOLARSHIP REVIEW AND MODIFICATION

RLA reserves the right to review, modify, or discontinue this scholarship in the following circumstances:

- 1. **Payment Default:** If the remaining tuition balance or required fees are not paid according to the agreed schedule after appropriate notice and opportunity to cure.
- 2. **Breach of Confidentiality:** If details about this scholarship agreement are shared outside the family and RLA administration without prior written consent.
- 3. Academic or Behavioral Issues: If the student's academic performance falls below satisfactory levels or behavioral issues arise that are detrimental to the school environment, and improvement plans are unsuccessful.
- **4. Recovery Program Non-Compliance:** If the student or family fails to comply with recovery-related requirements essential to RLA's mission and the student's success.
- **5. Enrollment Changes:** In exceptional circumstances where enrollment capacity requires reallocation of scholarship funds, families will be given reasonable notice and assistance in transition planning.

Important Note:

Before any scholarship modification or discontinuation, RLA will provide written notice and, when appropriate, an opportunity to address concerns through a review process. Our goal is always to support student and family success.

FINANCIAL RESPONSIBILITY ACKNOWLEDGMENT

In the event this scholarship agreement is discontinued for cause, the family acknowledges responsibility for any remaining tuition balance according to the original enrollment agreement. RLA will work with families to establish reasonable payment arrangements when possible.
