This is civil in nature. The RP asked for maintance to be done and the landlord arrived to do the work. The lease agreement allows the landlord to enter for maintance requests and the RP advised the landlord that they could enter to do the work on the request form.

The RP is upset that the landlord entered the living room while the RP was lying naked under a blanket. The landlord began to do the work with no contest from the RP. The RP advised that he felt trapped under the blanket and asked the landlord to leave after about 15min. The landlord left after he finished up with some loose/open wires that needed to be fixed.

The RP advised that he was covered by the blanket the entire time and felt embarrassed that this was happening. The RP feels that this was harrassing behavior on the landlords part and possibly false imprisionment.
