CAUTION - CAUTION - CAUTION

This past year while doing road work our crew has witnessed a lot of disregards to posted signs and flaggers. Drivers intentionally drive fast on freshly oiled roads, running over and destroying signs, showing disrespect to workers. What this is causing is a more financial burden to HOVE RMC and all lot owners. Show Aloha. Take a different route; it won't take but a few more seconds. If you're not sure what to do, simply ask. Here are a few reminders...

To stay safe in construction areas, it's crucial to slow down and stick to the posted speed limit. Although it may be tempting to speed up and get through the construction zone quickly, doing so can put you and others at risk. Remember that construction zones are often congested with workers, large vehicles, and equipment, so it's important to take extra precautions. Please watch for road workers!

- Drive Slowly on freshly chipped or oiled roads.
 - Be Aware of Workers on Foot
 - Give Workers Plenty of Space
 - Follow Flaggers' Instructions
 - Use Caution Around Heavy Equipment
 - Stay Clear of Construction Equipment
 - Be Prepared for Equipment to Move
 - Be Prepared for Changes in Road Conditions
 - Stav Calm and Patient

Our paving process...

Chipseal (also chip seal or chip and seal) is a pavement surface treatment that combines one or more layers of road oil with one or more layers of fine aggregate. In the United States, chipseal is typically used on rural roads carrying lower traffic volumes, and the process is often referred to as asphaltic surface treatment. This type of surface has a variety of other names including tar-seal or tar seal, tar and chip, sprayed seal surface dressing, or simply seal.

Chipseal's are constructed by evenly distributing a thin base of hot tar, bitumen or asphalt onto an existing pavement and then embedding finely graded aggregate into it. The aggregate is evenly distributed over the hot seal spray, then rolled into the bitumen using heavy rubber-tired rollers creating a paved surface. A chip-seal-surfaced pavement can optionally be sealed with a top layer, which is referred to as a fog seal or enrichment. Vehicle speed can affect the set-up time with chipseal. Depending on weather conditions, the set speed for chipseal is 10–15 miles per hour for the first 24–48 hours after construction.



The shaka sign, sometimes known as "hang loose", is a gesture with friendly intent often associated with Hawaii and surf culture.

Some say the gesture started with Hamana Kalili of Laie, who lost the three middle fingers of his right hand while working at the Kahuku Sugar Mill. Kalili was then shifted to guarding the sugar train, and his all-clear wave of thumb and pinkie is said to have evolved into the shaka as children imitated the gesture.

Another theory relates the origin of the shaka to the Spanish immigrants, who folded their middle fingers and took their thumbs to their lips as a friendly gesture to represent charges a drief with the patient they get in Houseii.

to represent sharing a drink with the natives they met in Hawaii.

The late Lippy Espinda, a used car salesman and Oahu-based entertainer, has also been named as a possible creator of the shaka. Espinda, who frequently appeared as an extra in Hawaii Five-O as well as The Brady Bunch episodes shot in Hawaii, used the term and the sign during his television ads in the '60s. He is credited with increasing its popularity and that of Hawaiian Pidgin as well. Residents of Hawaii use the shaka to convey the "Aloha Spirit", a concept of friendship, understanding, compassion, and solidarity. Drivers will often use it on the road to communicate and to avert altercations when people are cut off in traffic. The sign has spread around the world since the surfing boom of the 1950s and '60s. It's popular in Brazil, where it's been used by martial arts aficionados. Brazil soccer greats Ronaldinho and Neymar Jr. incorporated it into their goal celebrations. Shakas also come out naturally when locals are somewhere else in the world and want to display connection to their island roots. It makes people feel good when they receive one.

A bill making it the state's official gesture passed the legislature in 2024.

PLEASE HELP CLEAN UP OUR COMMUNITY OF ABANDONED VEHICLES!

Once the vehicle has been tagged, after 5 days from the date on the tag, call 808-961-2226 and provide them with the tag #, date on tag, cross street, make/model and they will pick it up.

If you have junk vehicles on your private property, there is a program to have up to 2 of those removed per fiscal year free of charge.

BALLOT INSTRUCTIONS

It is important that you vote on the issues included herein. This is your opportunity to be counted and help decide the issues. To view a copy of the RMC Bylaws, go to our website www.hoveroad.com. The number in the corner of your mailing label on the newsletter represents the number of lots you own. If this label is incorrect in any way contact us. Do not alter your label. In the next section you have one vote per lot for each item on the Ballot. For example 6 (lots) x 1 = 6 entries. Place your total number of votes on either the YES or NO line. The completed ballot must be returned in the envelope provided. Be sure to place a first-class stamp on the envelope before mailing. Please allow at least TEN DAYS mailing time. On the back of your mailing envelope, there is a line for you to sign your name across the sealing flap for security reasons.

To be counted, your mailed ballot must be received in our office prior to the meeting on Saturday, December 14, 2024. Our office will close at 4:00 pm HST, on Friday. December 13, 2024.

Hand carried ballots or proxy ballots will be accepted at the meeting up until the last call for voting.

2025 BUDGET

The assessment is based on the 2025 budget. The 2025 proposed assessment is \$155.00 per lot. Those members who pay in full on or by February 28, 2025 may take a \$10.00 early payment discount and pay \$145.00.

2025 ROAD PLAN

Road Maintenance has chip sealed 12 miles of the 2024 road plan. With 3 months left in the year we anticipate completion of 15 miles of roadway. The road plan for 2025 is to include 15 miles of roadway. Roads to work on include Princess Kaiulani Blvd., Aloha Blvd., Marlin Blvd., Reef Pkwy., and many of the secondary roads that need attention from excessive wear. In addition to chip sealing, we have the never-ending task of patching potholes, replacing damaged or stolen street signs and stop signs, repainting center lines and fog lines on all of the 157 miles of roadway. There is also the mowing of intersections and the equivalent of 314 miles of easement.
