#### Aloha Members,

#### President, George Campbell

HOVE Road Maintenance Corporation has had a productive year. We used our own crews to do all of our road work this year. We have been able to resurface roads with considerable cost savings compared to what we have paid per mile in the last few years.

That being said, our road crew has completed eight (8) miles of resurfaced road to date. The manufacturer has been able to solve most of the minor problems that we have had with our new tractor and mower and RMC is hoping to be able to sell some of our older surplus equipment. We have been able to stay within the budget that you all approved last year and we thank all of you who pay your road maintenance fees on-time. We are looking forward to another great year and we are planning to resurface more miles in 2019 than we did this year. Mahalo, George.

The 2018 road work is well underway and we have brought down the cost of road resurfacing with the help of great part time crew members. As of this writing, the road work has consisted of five Miles on Trade Wind from top to bottom, two miles on Hukilau from Trade Wind to the top ending at King Kalakaua and one mile on Palm and Hawaii. Work is now ongoing on Hawaii Blvd.

We anticipate working on Aloha next and continue to fill potholes, paint white lines and repair and replace signage. The mowing is never ending.

HOVE Road Right of Ways are not part of Private Property. Please do not encroach on the right of way. This includes no parking on the right of way and building rock walls or fencing thereon.

Please do not grow any vegetation outside of your private property line. Any violation of these rules may be subject to being corrected by H.O.V.E. RMC at the expense of the property owner.

#### 2019 ROAD PLAN.

For the past few years we have left the choice of exactly which Road's we intend to resurface until the February BOD meeting. This has worked out very well for us, as we assess the roads that are in the most need of repair just before the work starts.

The Board of Directors is recommending the resurfacing of 13 miles of road way in 2019. A detailed Plan will be completed at or before the February BOD Meeting.

In addition to road resurfacing, we will continue to mow the right of way, fill potholes and repair and replace signs throughout HO.V.E.

#### 2019 ROAD ASSESSMENT FEE.

The BOD has voted to keep the Road Assessment Fee the same as last year. The fee will remain at \$150.00.

For Members who pay in full before February 28, 2019, the assessment for early payment is \$140 per lot. Paying your assessment early is a plus for you and also RMC. The assessment is based on the 2019 Budget that has been approved by the RMC Board of Directors for your consideration.

# PAYMENT INFORMATION.

A late fee of \$10 will be applied to lot owner bills after March 31, 2019. There is also a 12% per annum interest applied until all payments are made. A lien fee of \$235 is charged if unpaid after two (2) years. Any property is subject to be foreclosed if not paid in full by 1 year after the date of lien. We accept cash (at our office only), checks, money orders, payments by PayPal, or by credit/debit card. If you own multiple properties, you can pay with one check and enclose the return portion of all statements with your payment. You can mail your payment to us using a check or credit/debit card. Please do not send us cash by mail. You can also call our office with your credit/debit card number. One good payment option is to pay your road assessment on our website, www.hoveroad.com.

For members who are unable to pay their assessment in full before March 31, a Monthly Payment Plan is available to avoid additional fees. If the account is paid in full before the end of the year, no fees will be added to the account for delinquency. For more information contact our office.

#### 2018 TREASURER'S REPORT.

H.O.V.E. RMC has stayed within its budget again this year. We have had no major equipment break downs and even though the price of oil has gone up we have been able to contain our road paving costs.

Our assessment compliance is much like last year and we expect it to be in the mid to upper 80% by the end of 2018.

The audit firm of Carr & Goveia is conducting the 2018 audit which should be completed by October.

#### BOARD MEMBER APPLICANTS.

The following two Members have applied for a position on the RMC Board of Directors. Four (4) positions are open for election.

#### Jim Steenburg.

I have lived in Ocean View for thirty years now and have served on the Board from 2011 through 2016. During my term I was elected as VP and then as President. For most of my last five years of my previous term, I held the position as Secretary and I have been elected to that position again this year.

#### ABANDONED VEHICLES

Last May the County stopped removing abandoned cars from all of the private roadways. This included the HOVE road right of ways!

However, a State Measure, HB 2447 was passed by the Legislature earlier this year. This measure gives the County a better method on how it handles abandoned vehicles. It also requires that the Counties take abandoned vehicles into custody within 10 business days.

The Hawaii County Council has recently passed bill 154 which specifically authorizes the Department of Environmental Management to remove abandoned vehicles from private roads. The removal of abandoned vehicles in Ocean View should commence after the paperwork involved is completed. This will probably be in the early part of October.

Remember: It is illegal to abandon a vehicle on public or private property. Therefore, you should not partake or be involved in any of this kind of activity. If you observe any of this activity, please take the time report it to the police.
