JOB SUMMARY: To perform duties in support of the Housing Authority Is Inspection Program; to investigate complaints and enforce all regulations related to Housing Quality Standards (HQS) and local laws and regulations; to confer with residents on compliance with regulations and policies relating to housing, health, and safety; and to perform a variety of technical tasks relative to assigned areas of responsibility, to include Section 8 Program, Voucher, Tenant Based Rental Assistance (TBRA/HOME), Mod Rehab, Mod Rehab SRO, and PBV other Public Housing and rental assistance programs.

<u>MINIMUM QUALIFICATIONS:</u> Equivalent to the completion of the twelfth grade, supplemented by specialized training in HQS codes, public health, environmental regulations, or a related field.

Preferred Experience: Two years of HQS enforcement program experience or inspection related experience

<u>License or Certificate:</u> Possession of, or ability to obtain HQS certification within at least 60 days and a valid Colorado driver ls license.

## **ESSENTIAL JOB FUNCTIONS:**

- 1) Perform a variety of duties in support of the Housing Authoritylls Inspection Program to protect the health, safety, and welfare of the Housing Authoritylls residents.
- 2) Investigate complaints and enforce all policy and regulations related to housing standards, environmental health, and zoning ordinances; confer with residents, landlords, and staff on compliance with regulations relating to housing, health and safety.
- 3) Inspect homes, apartment buildings, and other properties; ensure compliance with applicable housing standards, zoning and environmental health codes, ordinances, policies, and regulations; determine whether property complies; issue notices of violation as required; document all actions and notices; perform follow-up inspections to ensure compliance.
- 4) Meet with and respond to residents and landlords who are in violation of regulations; explain actions required to comply with regulations and perform mediation and intervention to resolve potential conflicts regarding regulations or violations.
- 5) Respond to reports from tenants, landlords, and neighbors alleging HQS violations including high weeds, junk vehicles, litter, and graffiti; interview complainants and witnesses; take photographs of violations and document activities through computer input; perform research to determine ownership of property and the approved conditional uses of property; process certified letters.
- 6) Respond to public inquiries in a courteous manner; provide information within the area of assignment; resolve complaints in an efficient and timely manner.
- 7) Generate daily inspection activity reports; distribute as required. Enter inspection findings into handheld and desktop devices. Schedule inspections and create letters.
- 8) Testify in court and at administrative proceedings, as necessary.
- 9) Perform HQS inspections for contracted PHAlls and all related responsibilities; position requires travel outside of city limits to perform inspections.
- 10) Perform related duties and responsibilities as required.

Filling of this position will be subject to Section 3 requirements as directed by the Department of Housing and Urban Development. Additional information will be required following submission of an initial application from the applicant if chosen for an interview.
