Seller Agreements

1. The purchase price of this puppy/dog will be refunded or the puppy/dog will be taken back if the seller's veterinarian certifies that the dog is genetically unsound for a reason that is the seller's fault. The Seller will reimburse no veterinary or shipping costs.
2. In order for this warranty to be taken advantage of, seller MUST receive a certificate of genetic unsoundness from a veterinarian of the seller's choice.
3. The puppy/dog is healthy at the time of sale and has had immunizations enumerated in the attached health record.
4. If at any time the buyer is unable to keep or care for the puppy/dog, Seller will attempt to assist in rehoming the dog. The buyer's understanding and acceptance of this condition is signified here by his or her initials: _____ on ____ (date)_____.

The seller will endeavor to place any returned puppy/dog as advantageously as possible. If a purchase price is obtained for the puppy/dog, it will be refunded to the original buyer, less any costs of placement. If the puppy/dog is placed free of charge, no money will be returned to the original buyer. No veterinary or other costs of keeping the puppy/dog, or any other costs incurred by the buyer resulting from his/her ownership of the puppy/dog, will be paid by the seller to the original buyer of the puppy/dog under any circumstances.

5. Bluebird Kennels puppies/dogs are bred to be companion dogs, and the seller does not provide any warranty as to the puppy/dog's fitness for any specific purpose, including but not limited to obedience trials, agility, show ring performance, or breeding.
6. The seller agrees to provide advice and information on grooming and training to the best of his/her ability, to help the buyer and the animal to live their best lives.

5. The buyer recognizes that special coat care is required for Aussiedoodles and that this coat care entails extra expenses that can reach over \$100 per grooming appointment.
