_____ I/We agree that the dog will not be off lead except when inside the house or within the safety of a fenced backyard.

_____ I/We agree that the dog will not be abused in any manner. The dog will not be chained, roped or otherwise tethered outside at any time. I/We agree that the dog will not be left outside unattended at any time. The dog will not be trained or used for attack of guarding property and will never be used in any aspect of dog/animal fighting or other illegal practices. The dog will not be the subject of, nor subjected to any biological, chemical, psychological or other experiments, nor shall the pet be subjected to shock collars or other cruel means of training.

_____ I/We agree that the dog will not be subjected to any form of cosmetic surgery or altercation.

_____ I/We understand and agree that Kaylee's Island of Misfit Dog Sanctuary and Rescue. makes no express or implied warranty, representation or promise to the age, health, breed, habits, disposition or safety of the animal. I/We hereby accept the animal as is, assume all risks and responsibilities associated with the ownership of the Animal, including bites, and I hereby fully and completely release, indemnify and hold harmless Kaylee's Island of Misfit Dog Sanctuary and Rescue., its directors, officers, volunteers, servants, and employees from any claim, cause of action or liability of any sort or nature, whether known or unknown, directly or indirectly arising out of or in connection with the adoption, care or ownership, maintenance, temperament or condition of the Animal.

_____ I/We agree in the case I cannot keep the animal, he/she will be returned to . Kaylee's Island of Misfit Dog Sanctuary and Rescue

_____ I/We agree to notify KIMD with any changes of address, phone number, etc.

_____ I/We agree to comply with all state and local laws and ordinances related to keeping of this dog, including licensing and leash laws.

_____ I/We acknowledge falsification of the above can result in my being denied adoption of an animal or, if animal has been adopted to me, the return of that animal to Kaylee's Island of Misfit Dog Sanctuary and Rescue

_____ I/We certify that the above information is true and correct to the best of my knowledge. I agree to notify Kaylee's Island of Misfit Dog Sanctuary and Rescue if I decide at any time that I cannot keep the animal and will not surrender the animal to a shelter or abandon the animal without first making every attempt to notify. I agree that if I rehome the Kaylee's Island of Misfit Dog Sanctuary and Rescue animal, I will contact Kaylee's Island of Misfit Dog Sanctuary and Rescue with the new owner's updated information. I understand that, if I dispose of the animal in a manner not in compliance with this paragraph, it constitutes a material breach of this Agreement and in the event of any. Material breach will be entitled to a payment Kaylee's Island of Misfit Dog Sanctuary and Rescue t by me of Five Thousand no cents (\$5000.00) as liquidated damage and not as a penalty; I also agree to compensate for all expenses incurred by Kaylee's Island of Misfit Dog Sanctuary and Rescue arising out of any material breach, including (not limited to) filing fees, court costs, and attorney fees. I understand. That returning the animal may take 4-6 weeks and that I am responsible for costs associated with boarding.

This contract constitutes the full agreement and understanding of both parties.
