- A maximum of 100,000 shares may be purchased representing 10% ownership.

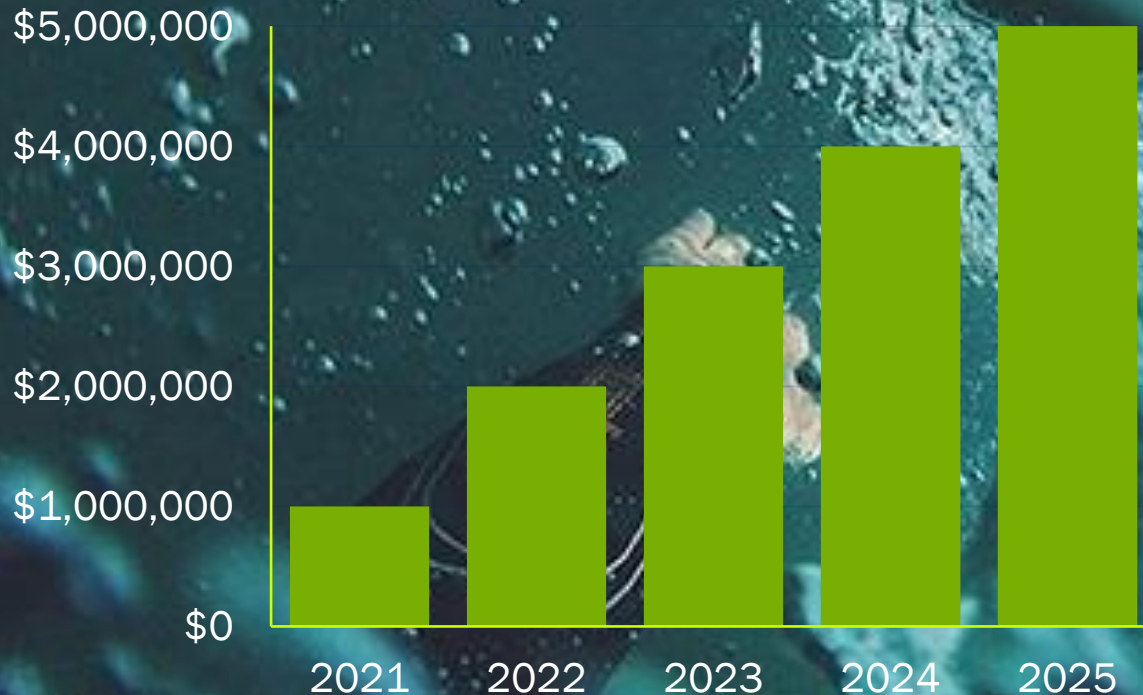
Return
