PUBLIC NOTICE

The Village of New Square will hold a public hearing on July 18, 2023 at 10:00am at Village Hall for the purpose of hearing public comments on the Village of New Square's community development needs, and to discuss the possible submission of one or more Community Development Block Grant (CDBG) applications for the 2023 program year.

The CDBG program is administered by the New York State Office of Community Renewal (OCR), and will make available to eligible local governments approximately \$1,250,000 for the 2023 program year for housing, economic development, public facilities, public infrastructure, and planning activities, with the principal purpose of benefitting low/moderate income persons. The Village of New Square is applying for up to \$1,250,000 in CDBG funds to implement critical storm drainage and flood control improvements. The hearing will provide further information about the CDBG program and will allow for citizen participation in the development of any proposed grant applications and/or to provide technical assistance to develop alternate proposals. Comments on the CDBG program or proposed project(s) will be received at this time. The hearing is being conducted pursuant to Section 570.486, Subpart I of the CFR and in compliance with the requirements of the Housing and Community Development Act of 1974, as amended.

Assistance under the Community Development Block Grant Program must meet one of three national objectives: benefit to low and moderate-income persons, elimination of slums and blight or urgent needs affecting the health and safety of the community. No less than seventy percent (70%) of grant funds must be used for activities benefitting low and moderate-income persons and the benefit area must contain at least fifty-one percent (51%) low- and moderate-income residents.

All interested residents including minority, women, disabled and disadvantaged persons are strongly encouraged to attend this public hearing. The Village Hall is accessible to persons with disabilities. If special accommodations are needed for persons with disabilities, those with hearing impairments, or those in need of translation from English, those individuals should contact the Village Clerk, David Breuer, 37 Reagan Road, New Square, NY 10977 or 845-354-1000, at least one week in advance of the hearing date to allow for necessary arrangements.
