LAKES AREA CANVAS & MARINE WINTER STORAGE TERMS & CONDITIONS

1. No outside contractors or competitive laborer of any type permitted in the yard.
2. LAKES AREA CANVAS & MARINE WILL NOT BE HELD LIABLE FOR DAMAGE OR THEFT OF VESSEL OR PROPERTY INSIDE VESSEL WHILE IN STORAGE. CUSTOMERS WILL BE RESPONSIBLE FOR ANY AND ALL DAMAGES WHILE AT LAKES AREA CANVAS & MARINE
3. Customers only paying for storage are responsible for snow removal, water removal, and covering of their vessel.
4. To minimize the possibility of fire, no electric cords may be left plugged in during winter storage, and no electrical heaters may be used.
5. It shall be the owner's responsibility to remove the bilge drain plug after hauling and reinstall it prior to launching.
6. Winter storage season runs from September 1st -May 15th . The owner agrees that arrangements will be made for the prompt removal of the Vessel at the end of the storage term. Boats left on land without arrangements after May 15th will be billed \$75.00/ Month and may be subject to movement within the yard at the owner's expense. Boats left on land after July 1st without prior arrangements will be considered by Lakes Area Canvas & Marine to be abandoned and may be sold at a public auction or otherwise disposed of by Lakes Area Canvas & Marine in accordance with applicable State and/or Federal laws.
7. All accounts MUST be paid in full prior to the vessel leaving the premises.
8. Lakes Area Canvas & Marine is not responsible for removal of batteries or storage of batteries. (We will disconnect your battery with paid winterization). Lakes Area Canvas & Marine is not responsible for lost or stolen batteries.
9. We require a minimum of two week notice for removal/pickup of the boat in the spring.
