Without going into great detail, by the end of the second day, August 7<sup>th</sup>, after “MUCH” debate and discussion, by vote of the majority of the delegates in attendance that we would remain the Vietnam Veterans of America, with “NO” changes to Our structure. The delegates determined that at Our next Convention in 2027 in the DC area, that another look would be taken as to the future of the VVA. In the meantime, National Leadership, At Large Board of Directors and the Regional Directors would further their discussion on Our Fate.**

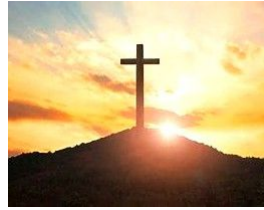

Recently our South Carolina State Council President Sam Brick had to resign from his position due to medical reasons. Sam has been with the South Carolina State Council President since August 2018. He has achieved many accomplishments while being in the military service and as the SC State Council President. While in the military he retired as a Colonel in the Army Reserve on June 2002. He was a Judge Advocate General (JAG) officer and military judge, serving in various capacities including counsel for HQ Area Command in Vietnam and staff judge advocate for CENTCOM Rear Headquarters during the First Persian Gulf War. With over 30 years with the Department of Defense (DoD) in attorney-advisor roles. His legislative roles included Director of Legislative Reference for the DoD and Chief Legislative Counsel for the Army. He was admitted to practice law before the Maryland Bar and various federal courts, including the Supreme Court. Army Reserve Ambassador for South Carolina from August 2014. While being the SC State Council President, he was elected to the Committee for State Council Presidents as chairperson. It is an Honor knowing Sam, he will be missed as our State Council President and all the good he has done for his fellow Vietnam Veterans.

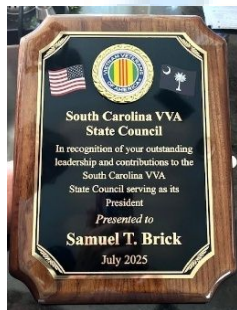

## **National Purple Heart Day August 7<sup>th</sup>**



The Purple Heart (PH) is a United States military decoration awarded in the name of the president to those wounded or killed while serving, on or after 5 April 1917, with the U.S. military. With its forerunner, the Badge of Military Merit, which took the form of a heart made of purple cloth, the Purple Heart is the oldest military award still given to U.S. military members. The National Purple Heart Hall of Honor is located in New Windsor, New York. The original Purple Heart, designated as the Badge of Military Merit, was established by George Washington – then the commander-in-chief of the Continental Army – by order from his Newburgh, New York, headquarters on 7 August 1782. The Badge of Military Merit was only awarded to three Revolutionary War soldiers by Washington himself. Washington authorized his subordinate officers to issue Badges of Merit as appropriate. Although never abolished, the award of the badge was not proposed again officially until after World War I. In 2009 *National Geographic* estimated the number of Purple Hearts given as:<sup>[5]</sup>

World War I: 320,518, World War II: 1,076,245, Korean War: 118,650, Vietnam War: 351,794 Persian Gulf War: 607, Afghanistan War: 12,534 (as of 18 November 2018)<sup>[16]</sup>

Iraq War: 35,411 (as of 18 November 2018)<sup>[16]</sup>, Operation Inherent Resolve: 76 (as of 4 May 2020)<sup>[17][18]</sup>, United Nations Multidimensional Integrated Stabilization Mission in , ail, MINUSMA super camp attack: 2 (as of April 14, 2018)<sup>[1]</sup>

## **Coast Guard Happy 235<sup>th</sup> Birthday**



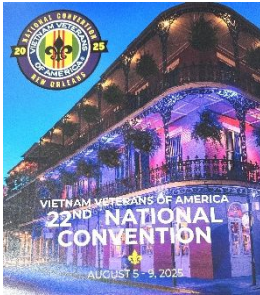
The United States Coast Guard, one of the country's five armed services, is a unique agency of the federal government. We trace our history to 4 August 1790, when the first Congress authorized the construction of ten vessels to enforce tariff and trade laws and to prevent smuggling. Known variously through the nineteenth and early twentieth centuries as the Revenue Marine and the Revenue Cutter Service, we expanded in size and responsibilities as the nation grew. The service received its present name in 1915 under an act of Congress when the Revenue Cutter Service merged with the Life-Saving Service. The nation then had a single maritime service dedicated to saving life at sea and enforcing the nation's maritime laws. The Coast Guard began to maintain the country's aids to maritime navigation, including operating the nation's lighthouses, when President Franklin Roosevelt ordered the transfer of the Lighthouse Service to the Coast Guard in 1939. In 1946 Congress permanently transferred the Bureau of Marine Inspection and Navigation to the Coast Guard, thereby placing merchant marine licensing and merchant vessel safety under our purview. The Coast Guard took over the administration of bridges over navigable waterways in 1967. The Coast Guard is one of the oldest organizations of the federal government and until Congress established the Navy Department in 1798 it served as the nation's only armed force afloat. The Coast Guard protected the nation throughout its long history and served proudly in the majority of the nation's conflicts. The Coast Guard's national defense responsibilities remain one of its most important functions even today. In times of peace it operates as part of the Department of Homeland Security, serving as the nation's front-line agency for enforcing the nation's laws at sea, protecting the marine environment and the nation's vast coastline and ports, and saving life. In times of war, or at the direction of the President, the Coast Guard serves as part of the Navy Department.





# Vietnam Veterans of America National Convention

## August 5<sup>th</sup> – 9<sup>th</sup> 2025



Vietnam Veterans of America - Twenty-Second National Convention was held in New Orleans, Louisiana from August 5th through the 9th, 2025. During this convention the VVA held their elections are as follows: Tom Burk of New Philadelphia Ohio was elected as VVA National President. John Riling III of Michigan was elected VVA National Vice President. Bill Meeks, Jr. of The Woodlands, Texas. elected as VVA National Secretary. Dottie Barickman of Council Bluffs Iowa was elected as VVA National Treasure. There were also 10 At-large Directors elected: Lize Cannon (NC), Gumersindo Gomez (MA), Charlie Hobbs (TN), Ken Holybee (CA), Dennis Howland (UT), Frederick Gasior (NY), Charlie Stapleton (MO), Dan Stenvold (ND), Steve Williams (VA), and Sandie Wilson (MI). Charlie Montgomery was elected as Regional 3 Director.

Just a short scenario what was the key factors going on at this convention. It was to decide our future of the VVA on when this organization was to be dissolve on March 1, 2028, and the name change from VVA to Viernam Veterans of America Legacy Society, until it came to the "*Future Plan: Resolutions*". When they started to read and vote on the "*Proposed Resolutions Relating to the Plan for Dissolution*" it became a nightmare. It appeared that the Board of Directors was trying to pass this resolution which no Region Directors nor the Directors at large approved. This was the rumor what was going around on the floor. In this section under Resolved 1 through 8 they did not get pass #2 because of the wording. This went on for several hours playing with changing the wording. It got to a point the Board of Directors right hand does not know what the left and was doing it became a bit chaotic. Even the Delegates were confused. If they showed the power point presentation first, (*Future Plan: VVA National Chapters & Stats Councils*) a lot of questions may have been answered; but they refused to show this presentation, just an opinion! The **DELEGATES VOTED IT DOWN** because they wanted to remain VVA and not a Society. So, they are back on the drawing board till the 2027 convention on the future of the VVA.

However, there were Constitutional Amendments, and 2025 Convention Resolutions were adopted and some were retied.

Overall it was a good convention. There were 752 delegates attending the convention. Region 3 (South Carolina had 10 delegates attending ) had 139 delegates

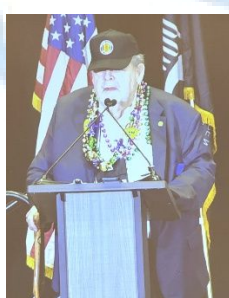

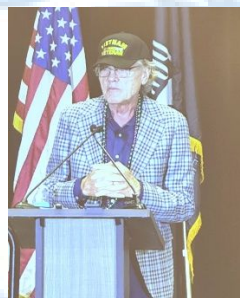

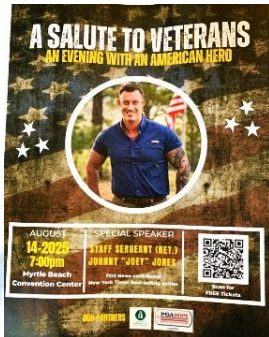

### **Chapter 303**

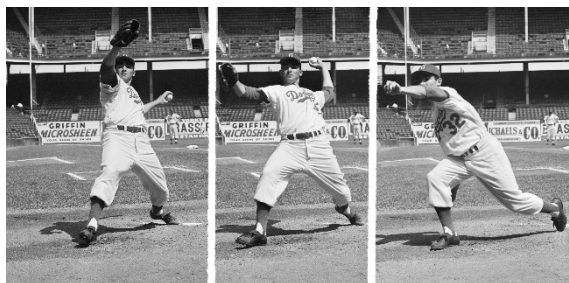

## Why Are Left-Handers Called ‘Southpaws’?



The “American Heritage Dictionary of the English Language” cites the conventional wisdom that the word “southpaw” originated “from the practice in baseball of arranging the diamond with the batter facing east to avoid the afternoon sun. A left-handed pitcher facing west would therefore have his pitching arm toward the south of the diamond.” As the third edition of “The Dickson Baseball Dictionary” points out, however, that origin story is a little too simplistic. The earliest baseball mention of a

“southpaw”—as found by Tom Shieber, senior curator at the National Baseball Hall of Fame—appeared in the New York Atlas in 1858, but in reference to a left-handed first baseman, not a pitcher. Boston Globe baseball writer and former ballplayer Tim Murnane also recalled in a 1908 edition of Arizona’s Bisbee Daily Review that a St. Louis newspaper had called him a “southpaw” in 1875 because he was a left-handed batter. Murnane adopted the term in describing pitchers “simply because they were left-handed, and not because they pitched the ball towards the sunny south on certain grounds.”

As Murnane pointed out, numerous big-league stadiums were not oriented with the pitcher facing west. That was not the case, though, with Chicago’s West Side Park, and it’s theorized that Chicago News sportswriter and humorist Finley Peter Dunne or the Chicago Herald’s Charles Seymour made the geographic connection by calling left-handed hurlers “southpaws” in the 1880s.

John Thorn, Major League Baseball’s official historian, told Wall Street Journal language columnist Ben Zimmer that he believes the term for lefties likely originated with a wholly different sport—boxing. In its coverage of an 1860 bare-knuckle prizefight, the New York Herald reported that left-hander David Woods “planted his ‘south paw’ under [his opponent’s] chin, laying him out as flat as a pancake” in the ninth round. Even earlier, an 1848 political cartoon depicted Whig vice-presidential candidate—and future president—Millard Fillmore lying battered on the ground after being punched by the left hand of Democratic presidential candidate Lewis Cass and lamenting, “Curse the Old hoss wot a south paw he has given me!” The Whig ticket of Zachary Taylor and Fillmore, however, ultimately delivered the knockout punch at the ballot box that fall by defeating Cass for the White House.
