1. INFORMATION WE COLLECT

We collect personal information and other data from users in various ways, including directly from you, automatically through your device, and from third-party sources.

A. Information You Provide to Us

1. Registration Information

When you create an account, register for updates, request a quote, or otherwise engage with our Services, we may collect:

- Name

2. Communications

3. Events

4. User Content

We may permit users to submit or share reviews, comments, testimonials, or other user-generated content. Any such content may be public unless otherwise stated.

5. Payment Information

If you make a purchase or payment through our Services, we or our third-party payment processors may collect:

- Billing name
- Billing address
- Payment card details
- Transaction records

Payment information is processed securely by third-party PCI-compliant vendors; we do not store full payment card numbers.

B. Information Collected Automatically

When you access our Services, we may automatically collect certain data from your device, including:

- IP address
- Browser type and version
- Device identifiers
- Operating system
- Cookie and tracking technology data
- Log information (pages viewed, referring URLs, date/time stamps, clickstream data)

We use cookies, pixels, and similar tools for authentication, analytics, preventing fraud, saving preferences, and enhancing user experience.

C. Information From Third-Party Sources

We may receive personal or demographic information about you from:

- Insurance carriers and underwriting partners
- Marketing partners
- Data verification services
- Public databases

This may include coverage history, eligibility information, quote status, or other relevant insurance data.

2. HOW WE USE PERSONAL INFORMATION

We use collected information to:

- Provide, maintain, and improve our Services
- Process quotes, applications, transactions, and service requests
- Verify identity and prevent fraud
- Respond to inquiries, provide customer support, and manage accounts
- · Communicate administrative messages, policy changes, or marketing information (subject to opt-out rights)
- Customize website content and user experience
- Comply with law, regulation, or contractual obligations
- Protect the rights, property, and security of SureNest and our users

3. HOW WE SHARE INFORMATION

We may share information in the following circumstances:

1. Service Providers & Contractors

With trusted vendors assisting in hosting, analytics, payments, marketing, email delivery, customer service, or compliance support.

2. Insurance Carriers & Underwriting Partners

If you request quotes or insurance products, we share necessary information with licensed carriers and administrators to process those requests.

3. Legal, Compliance, and Safety

We may disclose information if required to:

- Respond to lawful requests by public authorities
- Protect against fraud, security threats, or misuse of our services
- Enforce contracts or defend legal claims

4. Business Transfers

If we engage in a merger, acquisition, restructuring, asset sale, financing, or similar transaction, personal information may be transferred as permitted by law.

5. User-Generated Content

If you submit public content (e.g., reviews), it may be visible to other users.

We do not sell personal information for monetary consideration.

4. COOKIES AND TRACKING TECHNOLOGIES

Users may disable non-essential cookies through browser settings, though some features may not function properly.

When data is no longer needed, it is securely deleted or anonymized.

6. SECURITY

We use administrative, physical, and technical safeguards designed to protect personal information against loss, theft, misuse, unauthorized access, or disclosure.

No security system is perfect, and we cannot guarantee absolute protection.

7. CHILDREN'S PRIVACY

Our Services are not intended for children under 13, and we do not knowingly collect information from minors without verifiable parental consent. If we discover data belonging to a child, we will delete it promptly.
