Pursuant to the provisions of Act 162, Public Acts of 1982, the undersigned corporation executes the following Articles:

ARTICLE II

The purpose or purposes for which the corporation is formed are:

The corporation is organized exclusively for charitable, educational, religious, or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. The new 911 Memorial in Bedford County, Michigan, will be a tribute of remembrance honoring the 2,977 people killed in the terrorist attacks of 9/11/01. At the WTC site, the Pentagon, and in Somerset County, Pennsylvania. In addition, we would like future generations to learn and participate in educating children about our incredible country. A Learning Center will be part of the Bedford Library, Michigan, where generations will interact and contribute to the history of this event. With the historical timeline, Khios will be accessible to all who enter the 911 memorial grounds. Objectives: To raise communities and private funds year-round; in addition, the maintenance of the grounds on the memorial grounds must be done, such as snow removal, landscaping, and the upkeep of the trees and flowers. Raising funds to hire individuals for groundwork will be necessary. Our objective is to have a committee of individuals who will be responsible for the daily maintenance of the 911 Memorial grounds. A team of individuals will be responsible for the monthly fundraising throughout the year. A 911 Memorial Board of officers and directors will oversee the fundraising and any other prudent responsibility as we move forward with the building of the 911 Memorial.
