## **Geitner Homestead Equine Campground Waiver of Liability**

Wis. Stat. 895.481 – NOTICE – A person who engages for compensation in the rental of equines or equine equipment, or in the instruction of riding or driving an equine, or in being a passenger on an equine is not liable for any injury or death of a person involved in equine activities resulting from the inherent risks of such activities, as defined in section 895.481(1)(E) of the Wisconsin Statutes.

I acknowledge that participating in equine activities involves a significant risk of serious personal injury, death, or property damage. As a participant, parent, or guest at Geitner Homestead Equine Campground, I assume full responsibility for the safety of myself, my child, and any children in my care (which may include nieces, nephews, grandchildren, or friends who are not my biological children) while on the property. I understand that Geitner Homestead Equine Campground is not responsible for supervising my children or ensuring their safety. I hereby RELEASE AND DISCHARGE Geitner Homestead Equine Campground from any and all liability, known or unknown, even if it arises from negligence or carelessness by the sponsors. I accept all responsibility for any risks, conditions, and hazards that may occur, whether currently known or unknown. Therefore, in consideration of the services provided by Geitner Homestead Equine Campground, and for other valuable considerations acknowledged herein, I, the Participant/Parent/Guest, willingly execute this release under the terms outlined below:

### **Release and Waiver**

The Participant/Parent/Guest hereby FOREVER releases, discharges, indemnifies, holds harmless, defends, exonerates, and covenants not to sue Geitner Homestead Equine Campground and its owners, employees, staff, agents, successors, and assigns from any and all liabilities, claims, or demands of any kind, whether at law, in equity, or otherwise, arising directly or indirectly from participation. The Participant/Parent/Guest SPECIFICALLY UNDERSTANDS AND AGREES that this Release FOREVER DISCHARGES Geitner Homestead Equine Campground from any liability or claims related to bodily injury, personal injury, illness, death, or property damage resulting from participation, even if caused by the negligence of Geitner Homestead Equine Campground or its personnel, to the fullest extent permitted by applicable law. The Participant/Parent also understands that Geitner Homestead Equine Campground does not assume any responsibility for providing financial assistance or other support, including medical, health, or disability insurance, in the event of injury, illness, or claims.

### **Medical Treatment**

The Volunteer hereby FOREVER releases, discharges, indemnifies, holds harmless, defends, exonerates, and covenants not to sue Geitner Homestead Equine Campground and its owners, employees, staff, agents, successors, and assigns from any and all liability or claims arising from any first aid, treatment, or medical services rendered in connection with the Participant/Parent's activities with sponsoring agencies associated with Geitner Homestead Equine Campground.

### **Assumption of Risk**

The Volunteer SPECIFICALLY UNDERSTANDS AND AGREES that participation involves hazards for the Participant/Parent/Guest. They expressly, specifically, knowingly, intentionally, and voluntarily assume all risks of injury or harm that may result from participation and FOREVER releases, discharges, indemnifies, holds harmless, defends, exonerates, and covenants not to sue Geitner Homestead Equine Campground from all liability for injury, illness, death, or property damage or loss arising from participation.

### **Insurance**

The Participant/Parent/Guest understands that Geitner Homestead Equine Campground does not maintain health, medical, or disability insurance coverage for any Participants/Parents/Guests.

### **Other**

The Volunteer agrees that this Release is intended to be broad and inclusive as permitted by the laws of the State of Wisconsin and other applicable laws. This Release shall be governed by and interpreted according to the internal laws of Wisconsin. Jurisdiction and venue for any actions regarding this Release shall be exclusively in a competent tribunal in Door County, Wisconsin. If any clause or provision of this Release is found invalid by a competent tribunal, the remaining provisions shall continue to be fully enforceable.

I recognize that I am permanently waiving substantial rights, including my right to sue. I assert that my participation is voluntary, and I knowingly assume all associated risks.
