In many instances the team has had to go back as far as 2021 to correct incorrect data entries and put data in their proper category. In other news, you all know by now that package pick up has moved to lot 94B. We have a volunteer team making calls and handing out packages from 2 to 4 Monday thru Saturday. New office hours will begin next Monday January 30th. The office will be open from 8:30 AM to 4:00 PM and will be closed for lunch from Noon to 12:30 PM. We are still considering another hours change once our staffing is in place. We'll keep you advised.

Another change is on propane day. You don't have to rush to the office to pay your propane bill as it will be added to your statement. You can pay your propane, electric, and maintenance charges during one office visit or better yet we're working on the system so you can pay on line with a credit card when you get your emailed invoice (pledge). Still a few bugs to work out and Don Olney is working diligently to make it happen. Electric will still be read at the same time of the month, but the office needs more time to efficiently enter the data into each member's statement. Electric bills will be available 5 days after the meters are read. So, if we read your meter on the 20th your bill will be available for payment on the 25th. During January there were two bills due to the Valley Electric rate increase of 17%. December's portion was at the old lower rate and January's at the new rate.

There's a lot more happening than what's been listed here so be sure to thank our volunteers for all the hard work they are putting in on helping the park. Suggestions of how to improve our park are always welcome.

BYLAWS AND STANDING PARK RULES

Sue Vice 39B

Heads up! You should be receiving a ballot in the mail in the next few weeks. This ballot includes:

1) a proposed minor change to Bylaws Article VII, Section 3.A.2.a, needed for consistency with the approved change to Bylaws Article III Section 2.B.1.a.2, where "will be hand delivered" was changed to "may be hand delivered",

2) several changes to Bylaws Article II, Section 11 to enable the provision of proxy voting as discussed in last month's Bylaws Corner article, as well as some minor amendments which came to light while working on Section 11 for the proxy topic,

3) an amendment to Bylaws Article II, Section 2.B.1.a.2 to remove a sentence which appears to have been included at some point by mistake,

4) an amendment to Bylaws Article III, Section 4.E.11, requested by the Board of Directors, to raise the amount which has to be reported and approved by the Board from \$75 to \$150, and

5) an amendment to Bylaws Article II, Section 1.D to enable a new spouse of a member to be added to the Pair-A-Dice membership.

Please consider these proposals carefully and return your ballot. Every vote is important, particularly for proposed changes to the Bylaws, since the threshold for such changes to be approved by the membership is a majority of all memberships eligible to vote.

Remember, blank ballots and ballots not returned are effectively NO votes.

DID YOU KNOW?

Zoom Meetings are being recorded and are available for watching/listening to on our website. These meetings include the Board Workshops, the Open Board Meetings, the Silver Seekers General Meetings, and the Town Hall Meetings.

To access these recordings, go to the Pair-A-Dice website, click on Members, and sign in. Then click on Zoom Meetings.

There is a list of the available meeting recordings. The format is YY-MM-DD (year/month/date) along with the type of meeting. Double click on the one you are interested in.

There are 3 files (or sets of files). Those beginning with Video are the video and audio of the meeting. Those beginning with Audio are the audio only of the meeting. Those beginning with Chat are the Zoom chat from the meeting. If there is more than one of any given kind it means that the recording was interrupted and restarted during the meeting. They are in numerical order within the file types.

Town Hall Meeting January 10

On Parade

The only major topic was about the timing of our annual meeting. There was a discussion about changing the date from November to February or April to allow time for the books to be completed and a more accurate budget to be compiled. Several other co-ops meet in February but there was a concern over the Xscapers events in February since many of our new members are Xscapers. Many attendees felt April had more members in the park. This would need a Bylaws change. Members will be surveyed for their opinions in the coming months.

Open Board Meeting January 15

Topics brought up included:

Dick Martin proposed that the park purchase an AED (Automated External Defibrillator).

Sharon Guthrie is organizing a New Member Orientation Team.

Julie and Don Klein will be representing the park at the Spring Escapade in Tucson.

An updated Boon Docking policy was given to the Board—voting will be next month

- A request was made that Lot Appraisal and Improvement Committees to be combined. Motion was made and approved by the Board.
- Safety and Security Director will be checking all lots for proper compliance to Bylaws and Standing Park Rules. The board will also look at a lot numbering system that is visible from front and back of the shed.
- The Board of Directors has formulated a Code of Ethics and all BOD members have signed. (It is shown on page 6 of this newsletter.) We will be formulating a Code of Ethics for members and employees in the near future.
- The Board is looking at our credit card usage in the park. The bank charges us 2.5% for each use. The question is do we waive this fee as cost of doing business or add on 2.5% to every credit card usage. The Board of Directors will be monitoring our usage to make a determination.

Don Olney presented questions to be asked when software is purchased for the park.

A request from Lynne Eggleston was made to sell the glass cabinet the park no longer needs and that the proceeds will go to the park. Motion was made and accepted to sell the cabinet.

Charlene Darling presented in a letter the need for an address on the concrete wall at the park entrance, the need for a sign telling visitors where to park and check in and a more visible Office sign.

A reminder that any expenditures for any committee, have to be approved prior to purchase. Bob Tessier also stated that committees should formulate their budget needs before the 2024 budget is in progress.

A Few Reminders

If you use the front showers, verify the doors lock when you leave. We have occasionally had outsiders trying to use our facilities.

Check your water box for insulation due to freezing temperatures. If more insulation needed, contact maintenance.

Please clean up after yourself in the clubhouse. Put chairs back. Clean tables off. Throw trash away. Clean up spills.

Remember to sign out when you are leaving the park to travel for more than 4 days.

If you use the clubhouse computer, make sure you log out. Otherwise other members will see your account.

Propane Delivery Update

All members receiving propane from Shoshone at their site, need to call Shoshone directly when you need propane or ask to be put on auto fill. The office is discontinuing maintaining a list of members needing this service. Shoshone tends to fill the 2nd and 4th Wednesday of the month.

Updated Billing Procedure

Recently, the Pair-A-Dice office started emailing invoices or statements for Co-op bills, such as electric, quarterly maintenance, and propane fees.

Maintenance bills seem to still have a problem with paying through the statement. Staff is working on it. Please be patient as they resolve the issues. In the meantime bills can be paid in the office by cash, check or charge card.

Bills come through as ESCAPEES OF CO-OP NEVADA, INC. and say pledge due to our status as a non profit.

If you are not receiving bills, it could be because of your email provider. If you are going to change your E-MAIL in Quick Books for billing, let Don Olney know. He will be making the changes. He needs NAME, LOT# and E-MAIL ADDRESS ---- The Office is working hard on fixing other items and does not need to be involved with this simple fix.

The current board is working on a Code Of Ethics for the park and for employees. We have discovered several of the other SKP Co Ops already have this in place. Below is the Code Of Ethics that has been established for Board members and has been signed by all current board members.

Directors Oath of Office

I agree to abide by the Governing Documents of the Co-op and this Code of Ethics and Conduct. I will always show fair and impartial judgement toward all Co-op Members while performing my duties as a Director.

Code of Ethics and Conduct

No Board Member shall derive benefit or create the appearance of deriving benefit from his or her position as a member of the Board.

Information available to Board Members and not every member of the Co-op shall not be used or appear to be used to the Board Member's advantage.

No Board Member may vote on a motion in which there exists a conflict of interest. Each motion must be considered on its own merits for the membership as a whole, considering the long range results of that motion. If the motion before the board presents a conflict of interest for enough directors that a quorum is no longer possible, this issue should be put before the entire membership at the next membership meeting.

Directors may possess, or become aware of, confidential information in the course of their duties and responsibilities. Maintaining the confidentiality of such information is necessary and critical for the proper administration of the business of the Co-op. Improper handling or disclosure of the Co-op's confidential information will be considered unethical behavior.

Board Members shall treat all members of the Co-op, employees of the Co-op and other Board Members with dignity and respect. Board Members shall not engage in violent or abusive behavior, or fail to control his/her temper with other members of the Co-op, employees of the Co-op or other Board Members. They shall not use profane language or engage in repeated behavior that is unsolicited and unwanted and which may be perceived as harassment of a member of the Co-op, employee of the Co-op or other Board Members.

Board Members shall not solicit special treatment from the Board of Directors or any employee of the Co-op on any personal matter between the Board Member and the Co-op.

Direct management and supervision of Co-op employees is strictly limited to the President of the Board, or his/her designee. Other Board members shall not engage in any behavior that might be construed as disciplinary in nature. Board members may request the assistance of employees in obtaining any information, documents, or assistance necessary for the Board Member to complete his/her responsibilities. However, such requests shall be made politely and with respect for the employee's other duties and responsibilities.

Egregious or continuing violations of this Code of Ethics and Conduct may subject the Board Member to removal as an Officer, and/or removal from the Board of Directors in accordance with the provisions of the By Laws of the Coop.



Through the Lens Meet Annie DeSanti



Annie grew up in a seaside suburb of New Zealand's capital city, Wellington. Per capita, Kiwis are big travelers and in that spirit, in her 20's, Annie and husband took off to Britain and Europe arriving in London at the beginning of January 1979 where she got a job making costume jewelry until the summer, at which time the couple crossed the Channel to travel in their Austin Maxi car and a tent to tour Central and Southern Europe.

They eventually returned to New Zealand to begin the more serious side of life raising a daughter and starting up a commercial hydroponics growing business. This eventually lead to swapping the growing side to the supplying and manufacturing of hydroponic equipment and nutrients when commercial hydroponics was in its fledgling stages in that country. Some years later when her daughter was venturing out on her own, the business well established and the marriage had ended, she met and married Rob, moved to the USA where they both began their 'life on the road'. They worked in many parts of the country, settled for a few years in Northern California before deciding to resume their work camping life. Happy to leave Lake George, New York, we headed to a rustic campground in Brewster, Cape Cod. The weather was cooperating and there were no signs of black flies or blood sucking bugs. We set up camp in late afternoon and were looking forward to a cold beer or a relaxing glass of wine. As I popped the top of my favorite cold beverage, watching the sun set behind the trees, the first squadron of June Bugs attacked! They bounced off my head, the camper door, the station wagon. They dove headfirst into anything stationary, tumbling to the ground on their backs, twisting and turning as their orange eyes glowed in the dark. Once air-born, their wings fluttered noisily as they continued their kamikaze attacks, eventually driving us into our tin box for the night. The attacks continued steadily, subsiding just before 10:00 P.M.

The rest of the week went by without incident. Until we headed home and ran short of money on a Sunday afternoon. In the 1970's online banking, or online anything, had not been discovered yet. The first experimental mobile phone was still three years away from being tested, eleven years away from the \$3,900 Motorola Dyna Tax model that would be offered to the public. The GPS system for personal use was still not perfected by the military, and the only ATM was at the Chemical Bank in Rockville Center, New York City. Trying to find a pay phone out in the country; well; they were non existent. Apparently, we had enjoyed ourselves and forgot to check our wallets. However, we did have a full tank of gas, and a good road Atlas Map. Unfortunately, by the time I checked to find our location, we were heading for a toll bridge that charged five dollars and we only had three dollars between us. Call it false pride, or stupidity, I had no intention of begging a toll attendant to let us cross. The detour took us ninety miles out of our way home. (to be continued)

1849 The Forty Niners and Tough Times

The times were tough in the Gold Rush of California, with expectations high. Visions of wealth rolled through all the miners and right out of their pockets. To hunt gold at some point you had to have nourishment, tools, clothes, and particulars.

Some small amount of research found this. One box of sardines \$16 One pound of hard bread \$2 One pound of butter \$6 One half pound cheese \$3 Two bottles of ale \$16 Total \$43

The price of gold per ounce from 1833 to 1849 averaged \$18.93. And you thought prices for food were high today in 2023. An ounce of gold found can take hours or days to accumulate. These are not the tough times yet.
