




PROJECT LOCATION, DESCRIPTION AND SCHEDULE





Project Location

- Approximately 60 miles west of downtown Phoenix, Arizona
- Unincorporated Maricopa County on private land
- Bounded by Interstate 10 on the north and Centennial Wash on the south




Project Description

- On approximately 11,500 acres of predominately agricultural land
- Phased approach with construction beginning in 2023-2024 and ending by 2027
- Up to 2,000-megawatt photovoltaic solar array utilizing single-axis tracking that includes battery storage
- Up to 10 miles of transmission line to interconnect with the APS Delaney Substation to the east OR interconnecting at the Harquahala Power Plant (adjacent to the solar array)

 Major Comprehensive Plan Amendment (*Current effort*), Zone Overlay with Specific Plan of Development (*Future effort*), and Certificate of Environmental Compatibility (*Future effort*)




