

## Recertification Activities and Evidence for IWBMC-CE Certificants

Hands-on Learning	Field-requirement	Personal Development
<p>CEUs must be earned via hands-on learning that includes observation to ensure IWBMC fidelity and proficiency. Hands-on learning must include observed implementation of the IWBMC Evaluator job tasks on a selected person, including implementing interventions, data tracking, <u>AND</u> performing a complete IWBMC evaluation.</p> <p>a) Competency in the IWBMC Provider job tasks must be demonstrated by observations of direct implementation of various IWBMC interventions, and corresponding data tracking must be represented.</p> <p>b) Competency in the Evaluator job tasks is met through observations of the certificant completing the full IWBMC evaluation process, including assessment, composition of accompanying evaluation findings, and development of an individualized client program.</p> <p>c) All evaluation documents must include a redaction of the client’s name and personal information to ensure confidentiality.</p> <p>d) 2.5 hours of observed implementation equates to .25 CEU hours, and the observed implementation hours do not have to be consecutive.</p> <p>e) Individuals who consent to observe candidate evaluations must sign the Supervisor Criteria Form, indicating that they hold an active IWBMC credential as an Evaluator and have been currently practicing implementation of the IWBMC for a minimum of two years.</p> <p>f) The signed Supervisor Criteria Form must be signed by each observer who participated in certificant observations, and the Forms must be submitted as part of the evidence for the hands-on learning requirement.</p> <p>g) Observation forms must include the date and time, the setting or location, and the length of time for each observation.</p> <p>h) Observation forms must include the date and time, the setting or location, and the length of time for each observation</p>	<p>CEUs must be earned from engaging in field-related training and/or independent reading. The following are options for this requirement:</p> <p>a) Successful completion of approved remote or live-interface training and/or successful completion of approved reading materials and assignments that will be submitted to the NCBC Recertification Committee.</p> <p>b) Certificants may provide program-specific certificates and/or instructor assurance (in writing) demonstrating participation and completion of the training or seminar (must include the course name, date of attendance, continuing education hours earned, and verification that the certificant attended the entire course).</p> <p>c) Independent approved reading activities require a 300 to 500-word essay summarizing key concepts from selected reading material.</p>	<p>CEUs must be earned by participating in personal development activities.
