

Hopes Landing Architectural Control Committee Request for Structure Construction or Modification

In order to protect each individual homeowners' property values and to insure the appropriateness and harmony of the structures in the community, the Deed Restrictions require that any building or structure erected or altered on any lot in Hopes Landing be approved by the Board of Directors. Drawings or sketches, and specifications shall be submitted in sufficient detail for the Board to determine that the proposed construction meets all of the requirements as herein stated such as: location, size, exterior appearance, colors and materials of the proposed construction.

This request is reviewed by the Architectural Control Committee to ensure compliance with deed restrictions. Once the request has been reviewed and approved by the ACC, the request will be forwarded to the Board of Directors for final approval. In the event of a deadlock on approval or disapproval of the proposed plan, the plan shall be returned to the owner for modification. The ACC reserves the right to review the construction periodically to insure compliance with the plans that were submitted and approved.

I further understand that any heavy loads of concrete, soil, or other building materials that exceed the weight limits for the county roads must contact Titus County Precinct 2 Commissioner, Mike Fields, for special permits. Also, any driveways entering onto a county road must be properly constructed and installed to meet county standards. Please contact Titus County Precinct 2 Commissioner, for more details and approval.

I have read, understand, and will comply with the requirements outlined in the Deed Restrictions.

Before proceeding with construction, please contact the ACC when the building materials are on-site to confirm that the materials are in compliance with this submittal. The ACC reserves the right to visit the project periodically during construction to insure compliance.
