COLLABORATION & PARTNER RELATIONSHIP MANAGEMENT

- As a consultant, I have led leaders to understand and navigate the Canadian charities landscape and support them from idea through to charitable status and successful operation. Examples include the construction of International Advancement/Development plans for Jerusalem University College, INSPIRE Africa (Rwanda), a Congolese plastic surgery practice, <u>Brilliance Global Mission</u> (serving rural Uganda), and the construction of International Advancement/Development plans for Jerusalem University College.
- As Executive Director CRCNA, empower charities within the CRCNA umbrella toward organizational
 change specific to the Canadian setting. Areas include fundraising, business development, achieving a
 shared mission, corporate skill procedures, priority setting, culture, human resources, and conflictresolution management. Results demonstrate 7 straight years of fiscal gains in donors and dollars.
- As both Senior Pastor and consultant, I have coached boards to establish organizational best practices in the areas of operating policies, key financial and fundraising practices, governance procedures and programmatic development all to enhance ministry efforts.
- As Director for an ocean science firm, participated in a small team of leadership through a 1/2 billion dollar development strategy for real estate acquisition, building and staff development in alignment with corporate strategic goals
- Oversee and participate in developing cross-Canada fund-raising initiatives with key partners through to completion. Praise God, million-dollar goals were met. And, social awareness and public response oriented toward the government exceeded!
- Maintain and grow strategic partnerships in both the church and secular environments to foster
 collective 'win-win' situations. For example, chaired a group of 4 key partners to develop a digital app to
 serve churches in their missional and community practices. [currently rated a 4.3 stars with more than
 10K downloads]

STRATEGIC and FAITH-FILLED PROJECT/PROCESS OVERSIGHT

- As Pastor in Bellevue, WA, pray, plan, and proceed with the church and the AA community down a strategic leadership path to become 'The Eastside's' [Seattle, WA] largest AA and 12-step programs provider, including a 'bridge ministry' into the life of the church.
- Develop and direct entrepreneurial strategies for growth including the establishment of new business//
 operations. Examples include an international climate-change organization, several Canadian Christian
 charities, a fulsome communications app business for local churches (<u>The Bridge App</u>), and even my
 own Charities consulting practice as well as my <u>hobby</u> (woodturning) as '<u>New Leaf Turning</u>'.
- As Executive Director, develop a team and engage stakeholders to design a long-term Ministry Plan with key measurables for the first time on the Canadian side of the CRCNA denomination.
- Co-lead Strategic Planning processes within a multi-partner ecumenical effort for the <u>Nehemiah Centre</u> in Nicaragua. Intentionally participate in the distributed missional efforts along the Rio Coco amongst the Miskito people.
- As Executive Director, oversee and partner with key staff for a culturally appropriate strategic planning and goal-setting process for Urban <u>Indigenous Ministry Centres</u> across Canada.
- Project oversight in the charity sector. Deliver a variety of outcomes for clients in local churches, regional bodies, national denominations, and international audiences. (e.g. fund-raising initiatives, local church building projects, missional strategy plans, international mission endeavours, and workplace culture improvement). Organizations have included the Canadian Foodgrains Bank, <u>World Renew</u>, <u>ReFrame</u> <u>Ministries</u>, churches, etc.
- Project management (conception to completion) in the engineering/environmental space. Projects
 included working with regional municipalities, manufacturing facilities, major airports, private
 homeowners, government agencies, office environments, heavy industry, automotive manufacturing,
 etc.
- Pastor two congregations through a process to embrace a comprehensive community-oriented ministry plan and develop appropriate staffing. Both times the result was at least a 30% growth in membership. One church was in the USA, the other became Canada's 2nd largest CRC church

- My formative years of work and volunteerism began in my teens with roles serving children through the YMCA, Kitchener Parks and Rec department and summer camps! Such a joy!
- A key area of concentration for me in education and work has been relationships with Indigenous, BIPOC and differently-abled people groups. I have continued education in this area and consulted regularly with others about this form of inclusion
- Fostered and took part in local and international mentoring relationships that would develop skills and character in other's lives.
- As a leader, ensured key stakeholders always felt connected. I did my utmost to be intentional in a myriad of ways: e.g. from personally signing donor letters and hand-writing cards through to a significant event or preaching at a stakeholder's church.
- Pastored two churches through all the pains, sorrows, and joys of being a community of faith even while developing team ministry in key areas in order to facilitate growth
- Fostered learning and implementation of inclusion with de-valued people groups in reaching strategic objectives
