## **Refund & Cancellation Policy:**

We understand we are currently living in somewhat uncertain times and want to ensure our cancellation and refund policies are fair to attendees and sponsors. Please review the policies below prior to registering.

**SPONSORS** may cancel their participation in writing at any time by emailing <u>KYLendersConference@eventfullyyourz.com</u> and will have the following options:

- A. Substitute attendees for any of your included sponsor attendees up until October 5, 2022
- B. Cancel entirely without substitution and cease all promotion -
  - A. If cancelled by August 31st, 2022, a 50% refund is issued (provided at least 50% payment has been made)
  - B. If cancelled on or after September 1<sup>st</sup>, a refund or credit cannot be provided, and full payment is due within 10 days of the conference start date\*\*

If the in-person conference is cancelled by the organizers for any reason including but not limited to COVID-19 restrictions AND a virtual option is <u>not</u> provided, attendees and sponsors will receive a FULL credit to use toward a future Eventfully Yourz-managed conference.
